SYNOPSIS AS INTRODUCED:

5 ILCS 595/10

from Ch. 1, par. 7110

Amends the Great Lakes Naval Base Jurisdiction Act. Provides that the City of North Chicago is prohibited from discriminating in the provision of law enforcement services against the children of personnel serving in the United States Navy, or any other children, attending any public school located on lands within the United States Naval Training Base at Great Lakes. Authorizes the City of North Chicago to exercise its police powers and to provide law enforcement services to public schools located on lands within the United States Naval Training Base at Great Lakes. Effective immediately.

A BILL FOR

1 AN ACT concerning government.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Great Lakes Naval Base Jurisdiction Act is
5 amended by changing Section 10 as follows:

6 (5 ILCS 595/10) (from Ch. 1, par. 7110)

7 Sec. 10. Cession of jurisdiction to the United States.

8 (a) The United States owns or controls certain lands under
9 the jurisdiction of the Department of the Navy used as the
10 United States Naval Training Base at Great Lakes in Lake
11 County, Illinois, and concurrent legislative jurisdiction over
12 those lands has not been ceded to the United States by the
13 State of Illinois. The ceding of concurrent legislative
14 jurisdiction to the United States will facilitate the orderly
15 administration of law and justice by the State and by the
16 United States in the Great Lakes Base area.

17 (b) The State of Illinois cedes to the United States
18 concurrent legislative jurisdiction over all the lands and
19 parcels of land owned or controlled or that may from time to
20 time later be owned or controlled by the United States under
21 the jurisdiction of the Department of the Navy and used as the
22 United States Naval Training Base at Great Lakes, Lake County,
23 Illinois.

1 (c) Cession shall take effect only upon the filing of an
2 acceptance by the United States. Federal jurisdiction shall end
3 whenever the United States shall cease to own, lease, or use
4 for national purposes the lands or improvements on those lands.

5 (d) Nothing in this Section shall be construed to deprive
6 the State of Illinois of any of its jurisdiction over the
7 described lands, and that jurisdiction shall be concurrent with
8 that of the United States.

9 (e) Notwithstanding any provision of law to the contrary,
10 the City of North Chicago is prohibited from discriminating in
11 the provision of law enforcement services against the children
12 of personnel serving in the United States Navy, or any other
13 children, attending any public school located on lands within
14 the United States Naval Training Base at Great Lakes. The City
15 of North Chicago is authorized to exercise its police powers
16 and to provide law enforcement services to public schools
17 located on lands within the United States Naval Training Base
18 at Great Lakes.
