Boston High School, he joined the United States Army and served during the Korean War as a paratrooper; after completing 23 years of service, he was honorably discharged, having received the Korean Service Medal with a Bronze Star, the United Nations Service Medal, and the National Defense Service Medal; and

2 allow his wife the freedom to complete her undergraduate
3 studies and obtain her Master's degree; he worked at Chicago's
4 London House, where he met Robert Vaughn, who quickly became
5 his best friend and ultimately godfather to his daughter; their
6 friendship lasted over 50 years; Early on, Robert encouraged
7 Ben to follow his occupational path and he completed the Meat
8 Cutting and Merchandising Program at Washburne Trade School and
9 worked for A&P Foods; he then worked for Zenith Vending,
10 servicing vending machines, and Technicolor Filmmakers; and

11 WHEREAS, In 1970, he began working for his final employer,
12 United Airlines; the travel bug bit him and his family and they
13 routinely visited such tropical spots as Hawaii, California,
14 the Bahamas, Florida, and the Cayman Islands, and they even
15 went on an Alaskan cruise; in 1996, they traveled to Ghana with
16 a group led by the late Dr. Margaret Burroughs; and

17 WHEREAS, He was an avid golfer and loved to watch it on
18 television; after his wife's passing, he joined the church of
19 his daughter and son-in-law, Trinity United Church of Christ;
20 he was an active member of the Greeter's Ministry and the
