2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Criminal Code of 1961 is amended by changing
Sections 17-2 and 32-5 as follows:

Sec. 17-2. False personation; use of title; solicitation;
certain entities.

9 (a) A person commits a false personation when he or she falsely represents himself or herself to be a member or 10 representative of any veterans' or public safety personnel 11 12 representative of organization or а any charitable 13 organization, or when any person exhibits or uses in any manner 14 any decal, badge or insignia of any charitable, public safety personnel, or veterans' organization when not authorized to do 15 16 so by the charitable, public safety personnel, or veterans' 17 organization. "Public safety personnel organization" has the meaning ascribed to that term in Section 1 of the Solicitation 18 19 for Charity Act.

20 (a-5) A person commits a false personation when he or she 21 falsely represents himself or herself to be a veteran in 22 seeking employment or public office. In this subsection, 23 "veteran" means a person who has served in the Armed Services SB0064 Enrolled - 2 - LRB097 02748 RLC 42770 b

1 or Reserve Forces of the United States.

2 (a-6) A person commits a false personation when he or she 3 falsely represents himself or herself to be a recipient of, or wears on his or her person, any of the following medals if that 4 5 medal was not awarded to that person by the United States government, irrespective of 6 branch of service: the 7 Congressional Medal of Honor, the Distinguished Service Cross, 8 the Navy Cross, the Air Force Cross, the Silver Star, the 9 Bronze Star, or the Purple Heart.

10 It is a defense to a prosecution under this subsection 11 (a-6) that the medal is used, or is intended to be used, 12 exclusively:

(1) for a dramatic presentation, such as a theatrical,
film, or television production, or a historical
re-enactment; or

16 (2) for a costume worn, or intended to be worn, by a17 person under 18 years of age.

18 <u>(a-7) A person commits a false personation when he or she</u>
19 knowingly and falsely represents himself or herself to be:

20 (1) another actual person and does an act in such
21 assumed character with intent to intimidate, threaten,
22 injure, defraud, or to obtain a benefit from another; or
23 (2) a representative of an actual person or
24 organization and does an act in such false capacity with
25 intent to obtain a benefit or to injure or defraud another.
26 (b) No person shall use the words "Chicago Police,"

1 "Chicago Police Department," "Chicago Patrolman," "Chicago 2 Sergeant," "Chicago Lieutenant," "Chicago Peace Officer" or 3 any other words to the same effect in the title of any 4 organization, magazine, or other publication without the 5 express approval of the Chicago Police Board.

6 (b-5) No person shall use the words "Cook County Sheriff's 7 Police" or "Cook County Sheriff" or any other words to the same 8 effect in the title of any organization, magazine, or other 9 publication without the express approval of the office of the 10 Cook County Sheriff's Merit Board. The references to names and 11 titles in this Section may not be construed as authorizing use 12 of the names and titles of other organizations or public safety 13 personnel organizations otherwise prohibited by this Section or the Solicitation for Charity Act. 14

15 (b-10) No person may use, in the title of any organization, 16 magazine, or other publication, the words "officer", "peace 17 officer", "police", "law enforcement", "trooper", "sheriff", "deputy", "deputy sheriff", or "state police" in combination 18 with the name of any state, state agency, public university, or 19 20 unit of local government without the express written 21 authorization of that state, state agency, or unit of local 22 government.

(c-1) No person may claim or represent that he or she is
acting on behalf of any police department, chief of a police
department, fire department, chief of a fire department,

sheriff's department, or sheriff when soliciting financial 1 2 contributions or selling or delivering or offering to sell or 3 deliver any merchandise, goods, services, memberships, or advertisements unless the chief of the police department, fire 4 department, and the corporate or municipal authority thereof, 5 or the sheriff has first entered into a written agreement with 6 7 the person or with an organization with which the person is 8 affiliated and the agreement permits the activity.

9 (c-2) No person, when soliciting financial contributions 10 or selling or delivering or offering to sell or deliver any 11 merchandise, goods, services, memberships, or advertisements 12 may claim or represent that he or she is representing or acting on behalf of any nongovernmental organization by any name which 13 "officer", "peace officer", 14 includes "police", "law "deputy 15 enforcement", "trooper", "sheriff", "deputy", 16 sheriff", "State police", or any other word or words which 17 would reasonably be understood to imply that the organization is composed of law enforcement personnel unless the person is 18 19 actually representing or acting on behalf of the 20 nongovernmental organization, and the nongovernmental 21 organization is controlled by and governed by a membership of 22 and represents a group or association of active duty peace 23 officers, retired peace officers, or injured peace officers and before commencing the solicitation or the sale or the offers to 24 25 any merchandise, goods, services, memberships, sell or 26 advertisements, a written contract between the soliciting or SB0064 Enrolled - 5 - LRB097 02748 RLC 42770 b

1 selling person and the nongovernmental organization has been 2 entered into.

(c-3) No person may solicit financial contributions or sell 3 or deliver or offer to sell or deliver any merchandise, goods, 4 5 services, memberships, or advertisements on behalf of a police, 6 sheriff, or other law enforcement department unless that person is actually representing or acting on behalf of the department 7 8 or governmental organization and has entered into a written 9 contract with the police chief, or head of the law enforcement 10 department, and the corporate or municipal authority thereof, 11 or the sheriff, which specifies and states clearly and fully 12 the purposes for which the proceeds of the solicitation, 13 contribution, or sale will be used.

(c-4) No person, when soliciting financial contributions 14 15 or selling or delivering or offering to sell or deliver any 16 merchandise, goods, services, memberships, or advertisements, 17 may claim or represent that he or she is representing or acting on behalf of any nongovernmental organization by any name which 18 includes the term "fireman", "fire fighter", "paramedic", or 19 20 any other word or words which would reasonably be understood to imply that the organization is composed of fire fighter or 21 22 paramedic personnel unless the person is actually representing 23 or acting on behalf of the nongovernmental organization, and the nongovernmental organization is controlled by and governed 24 by a membership of and represents a group or association of 25 active duty, retired, or injured fire fighters (for the 26

purposes of this Section, "fire fighter" has the meaning 1 2 ascribed to that term in Section 2 of the Illinois Fire Protection Training Act) or active duty, retired, or injured 3 emergency medical technicians - ambulance, emergency medical 4 5 technicians - intermediate, emergency medical technicians paramedic, ambulance drivers, or other medical assistance or 6 first aid personnel, and before commencing the solicitation or 7 the sale or delivery or the offers to sell or deliver any 8 9 merchandise, goods, services, memberships, or advertisements, 10 a written contract between the soliciting or selling person and 11 the nongovernmental organization has been entered into.

12 (c-5) No person may solicit financial contributions or sell 13 or deliver or offer to sell or deliver any merchandise, goods, services, memberships, or advertisements on behalf of 14 а 15 department or departments of fire fighters unless that person 16 is actually representing or acting on behalf of the department 17 or departments and has entered into a written contract with the department chief and corporate or municipal authority thereof 18 which specifies and states clearly and fully the purposes for 19 which the proceeds of the solicitation, contribution, or sale 20 will be used. 21

(c-6) No person may claim or represent that he or she is an airman, airline employee, airport employee, or contractor at an airport in order to obtain the uniform, identification card, license, or other identification paraphernalia of an airman, airline employee, airport employee, or contractor at an

airport. 1

2	(d) Sentence. False personation, unapproved use of a name
3	or title, or solicitation in violation of subsection (a), (b),
4	(b-5), or (b-10) of this Section is a Class C misdemeanor.
5	False personation in violation of subsections (a-5), $(a-7)$, and
6	(c-6) is a Class A misdemeanor. False personation in violation
7	of subsection (a-6) of this Section is a petty offense for
8	which the offender shall be fined at least \$100 and not
9	exceeding \$200. Engaging in any activity in violation of
10	subsection (c-1), (c-2), (c-3), (c-4), or (c-5) of this Section
11	is a Class 4 felony.
12	(e) A violation of this Section may be accomplished in
13	person or by any means of communication, including but not
14	limited to the use of an Internet website or any form of
15	electronic communication.

20	(a) A person who falsely represents himself or herself to
21	be an attorney authorized to practice law for purposes of
22	compensation or consideration commits a Class 4 felony. This
23	subsection (a) does not apply to a person who unintentionally
24	fails to pay attorney registration fees established by Supreme
25	Court Rule.

1	(b) A person who falsely represents himself or herself to
2	be a public officer or a public employee or an official or
3	employee of the federal government commits a Class A
4	misdemeanor. If the false representation is made in furtherance
5	of the commission of a felony, the penalty for a violation of
6	this subsection (b) is a Class 4 felony.
7	(b-5) The trier of fact may infer that a person falsely
8	represents himself or herself to be a public officer or a

9 public employee or an official or employee of the federal 10 government if the person:

11 (1) wears or displays without authority any uniform, 12 badge, insignia, or facsimile thereof by which a public 13 officer or public employee or official or employee of the 14 federal government is lawfully distinguished; or

15 <u>(2) falsely expresses by word or action that he or she</u> 16 <u>is a public officer or public employee or official or</u> 17 <u>employee of the federal government and is acting with</u> 18 <u>approval or authority of a public agency or department.</u>

(c) A person who falsely represents himself or herself to be a public officer or a public employee commits a Class 4 felony if that false representation was for the purpose of effectuating identity theft as defined in Section 16G-15 of this Code.
