of offshore wind energy projects in Illinois waters of Lake Michigan, the Department shall examine the topics identified in subsection (b) of this Section and report its findings and recommendations to the Governor and General Assembly by June 30, 2012. During preparation of the report, the Department is not expected to fund or perform original scientific studies.

7 (b) In preparing a report, the Department shall evaluate8 all of the following:

9 (1) Appropriate criteria for the Department to use to 10 review applications for offshore wind development of Lake 11 Michigan lakebed leases.

(2) Criteria for identifying areas that are favorable,

wildlife, protected habitats, navigation, commercial
fisheries, and recreational uses of Lake Michigan.

20 (4) Options for how the State shall be compensated for21 Lake Michigan lakebed leasing.

Repeal of Act. This Act shall be repealed on July 1, 2012.
