1	AMENDMENT TO SENATE BILL 2288
2	AMENDMENT NO Amend Senate Bill 2288 by replacing
3	everything after the enacting clause with the following:
4 5	"Section 5. The Environmental Protection Act is amended by changing Sections 9.4 and 22.16b as follows:
6	(415 ILCS 5/9.4) (from Ch. 111 1/2, par. 1009.4)
7	Sec. 9.4. Municipal waste incineration emission standards.
8	(a) The General Assembly finds:
9	(1) That air pollution from municipal waste
10	incineration may constitute a threat to public health,
11	welfare and the environment. The amounts and kinds of
12	pollutants depend on the nature of the waste stream,
13	operating conditions of the incinerator, and the
14	effectiveness of emission controls. Under normal operating
15	conditions, municipal waste incinerators produce
16	pollutants such as organic compounds, metallic compounds

and acid gases which may be a threat to public health,
 welfare and the environment.

3 (2) That a combustion and flue-gas control system,
4 which is properly designed, operated and maintained, can
5 substantially reduce the emissions of organic materials,
6 metallic compounds and acid gases from municipal waste
7 incineration.

8 (b) It is the purpose of this Section to insure that 9 emissions from new municipal waste incineration facilities 10 which burn a total of 25 tons or more of municipal waste per 11 day are adequately controlled.

12 Such facilities shall be subject to emissions limits and 13 operating standards based upon the application of Best 14 Available Control Technology, as determined by the Agency, for 15 emissions of the following categories of pollutants:

16 (1) particulate matter, sulfur dioxide and nitrogen 17 oxides;

18 (2) acid gases;

(3) heavy metals; and

(4) organic materials.

(c) The Agency shall issue permits, pursuant to Section 39, to new municipal waste incineration facilities only if the Agency finds that such facilities are designed, constructed and operated so as to comply with the requirements prescribed by this Section.

of this Section the Agency may issue permits for the construction of new municipal waste incineration facilities. The Agency determination of Best Available Control Technology shall be based upon consideration of the specific pollutants named in subsection (d), and emissions of particulate matter, sulfur dioxide and nitrogen oxides.

Nothing in this Section shall limit the applicability of 7 any other Sections of this Act, or of other standards or 8 9 regulations adopted by the Board, to municipal waste 10 incineration facilities. In issuing such permits, the Agency 11 may prescribe those conditions necessary to assure continuing compliance with the emission limits and operating standards 12 13 determined pursuant to subsection (b); such conditions may 14 include the monitoring and reporting of emissions.

(d) Within one year after July 1, 1986, the Board shall adopt regulations pursuant to Title VII of this Act, which define the terms in items (2), (3) and (4) of subsection (b) of this Section which are to be used by the Agency in making its determination pursuant to this Section. The provisions of Section 27(b) of this Act shall not apply to this rulemaking.

Such regulations shall be written so that the categories of pollutants include, but need not be limited to, the following specific pollutants:

(1) hydrogen chloride in the definition of acid gases;
(2) arsenic, cadmium, mercury, chromium, nickel and
lead in the definition of heavy metals; and

(3) polychlorinated dibenzo-p-dioxins, polychlorinated
 dibenzofurans and polynuclear aromatic hydrocarbons in the
 definition of organic materials.

4 (e) For the purposes of this Section, the term "Best 5 Available Control Technology" means an emission limitation (including a visible emission standard) based on the maximum 6 degree of pollutant reduction which the Agency, 7 on а 8 case-by-case basis, taking into account energy, environmental 9 and economic impacts, determines is achievable through the 10 application of production processes or available methods, 11 systems and techniques, including fuel cleaning or treatment or combustion techniques. 12 innovative fuel Ιf the Agency 13 determines that technological or economic limitations on the application of measurement methodology to a particular class of 14 15 sources would make the imposition of an emission standard not 16 feasible, it may instead prescribe a design, equipment, work practice or operational standard, or combination thereof, to 17 require the application of best available control technology. 18 19 Such standard shall, to the degree possible, set forth the 20 emission reduction achievable by implementation of such 21 design, equipment, work practice or operation and shall provide 22 for compliance by means which achieve equivalent results.

(f) "Municipal waste incineration" means the burning of municipal waste or fuel derived therefrom in a combustion apparatus designed to burn municipal waste that may produce electricity or steam as a by-product. A "new municipal waste 09700SB2288sam002 -5- LRB097 10391 JDS 54249 a

incinerator" is an incinerator initially permitted for development or construction after January 1, 1986. <u>"Municipal</u> <u>waste incineration" does not include the burning of any fuel</u> <u>excluded from the definition of "solid waste" pursuant to 40</u> CFR 241.3.

6 (g) The provisions of this Section shall not apply to 7 industrial incineration facilities that burn waste generated 8 at the same site.

10 (415 ILCS 5/22.16b) (from Ch. 111 1/2, par. 1022.16b)

Sec. 22.16b. (a) Beginning January 1, 1991, the Agency 11 12 shall assess and collect a fee from the owner or operator of each new municipal waste incinerator. The fee shall be 13 14 calculated by applying the rates established from time to time 15 for the disposal of solid waste at sanitary landfills under subdivision (b)(1) of Section 22.15 to the total amount of 16 17 municipal waste accepted for incineration at the new municipal waste incinerator. The exemptions provided by this Act to the 18 19 fees imposed under subsection (b) of Section 22.15 shall not 20 apply to the fee imposed by this Section.

The owner or operator of any new municipal waste incinerator permitted after January 1, 1990, but before July 1, 1990 by the Agency for the development or operation of a new municipal waste incinerator shall be exempt from this fee, but shall include the following conditions: 1 (1) The owner or operator shall provide information 2 programs to those communities serviced by the owner or 3 operator concerning recycling and separation of waste not 4 suitable for incineration.

5 (2) The owner or operator shall provide information 6 programs to those communities serviced by the owner or 7 operator concerning the Agency's household hazardous waste 8 collection program and participation in that program.

9 For the purposes of this Section, "new municipal waste 10 incinerator" means a municipal waste incinerator initially 11 permitted for development or construction on or after January 12 1, 1990, but shall exclude any facility that uses a fuel 13 <u>excluded from the definition of "solid waste" pursuant to 40</u> 14 CFR 241.3.

Amounts collected under this subsection shall be deposited into the Municipal Waste Incinerator Tax Fund, which is hereby established as an interest-bearing special fund in the State Treasury. Monies in the Fund may be used, subject to appropriation:

(1) by the Department of Commerce and Economic
Opportunity to fund its public information programs on
recycling in those communities served by new municipal
waste incinerators; and

(2) by the Agency to fund its household hazardous waste
 collection activities in those communities served by new
 municipal waste incinerators.

(b) Any permit issued by the Agency for the development or
 operation of a new municipal waste incinerator shall include
 the following conditions:

4 (1)The incinerator must be designed to provide 5 continuous monitoring while in operation, with direct transmission of the resultant data to the Agency, until the 6 Agency determines the best available control technology 7 8 for monitoring the data. The Agency shall establish the 9 test methods, procedures and averaging periods, as 10 certified by the USEPA for solid waste incinerator units, and the form and frequency of reports containing results of 11 the monitoring. Compliance and enforcement shall be based 12 13 on such reports. Copies of the results of such monitoring 14 shall be maintained on file at the facility concerned for 15 one year, and copies shall be made available for inspection 16 and copying by interested members of the public during 17 business hours.

18 (2) The facility shall comply with the emission limits19 adopted by the Agency under subsection (c).

20 (3) The operator of the facility shall take reasonable 21 measures to ensure that waste accepted for incineration 22 complies with all legal requirements for incineration. The 23 incinerator operator shall establish contractual 24 notification requirements or other and inspection 25 procedures sufficient to assure compliance with this 26 subsection (b) (3) which may include, but not be limited to,

routine inspections of waste, lists of acceptable and unacceptable waste provided to haulers and notification to the Agency when the facility operator rejects and sends loads away. The notification shall contain at least the name of the hauler and the site from where the load was hauled.

7 (4) The operator may not accept for incineration any 8 waste generated or collected in a municipality that has not 9 implemented a recycling plan or is party to an implemented 10 county plan, consistent with State goals and objectives. Such plans shall include provisions for collecting, 11 recycling or diverting from landfills and municipal 12 13 incinerators landscape waste, household hazardous waste 14 and batteries. Such provisions may be performed at the site 15 of the new municipal incinerator.

16 The Agency, after careful scrutiny of a permit application for the construction, development or operation of a new 17 municipal waste incinerator, shall deny the permit if (i) the 18 19 Agency finds in the permit application noncompliance with the 20 laws and rules of the State or (ii) the application indicates that the mandated air emissions standards will not be reached 21 22 within six months of the proposed municipal waste incinerator beginning operation. 23

(c) The Agency shall adopt specific limitations on the
 emission of mercury, chromium, cadmium and lead, and good
 combustion practices, including temperature controls from

1 municipal waste incinerators pursuant to Section 9.4 of the 2 Act.

3 (d) The Agency shall establish household hazardous waste 4 collection centers in appropriate places in this State. The 5 Agency may operate and maintain the centers itself or may 6 contract with other parties for that purpose. The Agency shall 7 ensure that the wastes collected are properly disposed of. The collection centers may charge fees for their services, not to 8 9 exceed the costs incurred. Such collection centers shall not 10 (i) be regulated as hazardous waste facilities under RCRA nor 11 (ii) be subject to local siting approval under Section 39.2 if the local governing authority agrees to waive local siting 12 13 approval procedures.
