## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1 4 5 Section 1 The following named amounts, or so much 6 thereof as may be necessary, respectively, for the objects 7 and purposes hereinafter named, are appropriated to the Board of the Trustees of Southern Illinois University to meet 8 9 ordinary and contingent expenses for the fiscal year ending 10 June 30, 2012: Payable from the Education Assistance Fund: 11 12 For Personal Services, including payment 13 to the university for personal services 14 costs incurred during the fiscal year and salaries accrued but unpaid to academic 15 16 personnel for personal services rendered 17 during the academic year 2011-2012 ......195,604,200 For State Contributions to Social 18 19 20 21

- Section 5. The sum of \$20,000, or so much thereof as may be necessary, is appropriated from the State College and University Trust Fund to the Board of Trustees of Southern Illinois University for scholarship grant awards, in accordance with Public Act 91-0083.
- Section 10. The sum of \$1,250,000, or so much thereof as
  may be necessary, is appropriated from the General
  Professions Dedicated Fund to the Board of Trustees of
  Southern Illinois University for all costs associated with
  the development, support or administration of pharmacy
  practice education or training programs at the Edwardsville
  campus.
- Section 15. The sum of \$1,200,000, or so much thereof as
  may be necessary, is appropriated from the Education
  Assistance Fund to the Board of Trustees of Southern Illinois

- 3 Section 99. Effective date. This Act takes effect July 1,
