- 2 Section 5. In addition to amounts previously
- 3 appropriated for this purpose, the sum of \$821,900, or so much
- 4 thereof as may be necessary, is appropriated from the General
- 5 Revenue Fund to the Department of Human Services for grants for
- 6 After School Youth Support Programs.
- 7 Section 10. In addition to amounts previously
- 8 appropriated for this purpose, the sum of \$400,800, or so much
- 9 thereof as may be necessary, is appropriated from the General
- 10 Revenue Fund to the Department of Human Services for grants and
- 11 administrative expenses related to the Healthy Families
- 12 Program.
- 13 Section 15. In addition to amounts previously
- 14 appropriated for this purpose, the sum of \$274,900, or so much
- 15 thereof as may be necessary, is appropriated from the General
- 16 Revenue Fund to the Department of Human Services for Parents
- 17 Too Soon Program.
- 18 Section 20. In addition to amounts previously
- 19 appropriated for this purpose, the sum of \$1,620,200, or so
- 20 much thereof as may be necessary, is appropriated from the
- 21 General Revenue Fund to the Department of Human Services for

- 1 Early Intervention.
- 2 Section 25. In addition to amounts previously
- 3 appropriated for this purpose, the sum of \$1,050,000, or so
- 4 much thereof as may be necessary, is appropriated from the
- 5 General Revenue Fund to the Department of Human Services for
- 6 Homeless Prevention.
- 7 Section 30. In addition to amounts previously
- 8 appropriated for this purpose, the sum of \$55,800, or so much
- 9 thereof as may be necessary, is appropriated from the General
- 10 Revenue Fund to the Board of Higher Education for a grant to
- 11 the Board of Trustees of the University Center of Lake County
- 12 for the ordinary and contingent expenses of the Center.
- 13 Section 35. In addition to amounts previously
- 14 appropriated for this purpose, the sum of \$1,000,000, or so
- 15 much thereof as may be necessary, is appropriated from the
- 16 General Revenue Fund to the Board of Higher Education for the
- 17 Grow Your Own Teachers Program.
- 18 Section 40. In addition to amounts previously
- 19 appropriated for this purpose, the sum of \$1,000,000, or so
- 20 much thereof as may be necessary, is appropriated from the
- 21 General Revenue Fund to the State Board of Education for

- 2 Section 45. In addition to amounts previously
- 3 appropriated for this purpose, the sum of \$668,000, or so much
- 4 thereof as may be necessary, is appropriated from the General
- 5 Revenue Fund to the Department of Corrections for a grant to
- 6 the Sentencing Policy Advisory Council.

National Board Certified Teachers.

- 7 Section 50. In addition to amounts previously
- 8 appropriated for this purpose, the sum of \$1,470,000, or so
- 9 much thereof as may be necessary, is appropriated from the
- 10 General Revenue Fund to the Illinois Violence Prevention
- 11 Authority for the purpose of awarding grants, contracts,
- 12 administrative expenses and all related costs for violence
- 13 prevention programs.
- 14 Section 55. In addition to amounts previously
- 15 appropriated for this purpose, the sum of \$580,000, or so much
- 16 thereof as may be necessary, is appropriated from the General
- 17 Revenue Fund to the Department of Commerce and Economic
- 18 Opportunity for Agudath Israel of Illinois for grants for
- 19 school transportation.
- 20 Section 60. In addition to amounts previously
- 21 appropriated for this purpose, the sum of \$250,000, or so much

- 1 thereof as may be necessary, is appropriated from the General
- 2 Revenue Fund to the Department of Commerce and Economic
- 3 Opportunity for the purpose of grants, contracts, and
- 4 administrative expenses associated with DCEO community
- 5 programs, including prior year costs.
- 6 Section 65. In addition to amounts previously
- 7 appropriated for this purpose, the sum of \$1,732,200, or so
- 8 much thereof as may be necessary, is appropriated from the
- 9 General Revenue Fund to the Department on Aging for expenses
- 10 associated with Home Delivered Meals (formula and non-formula).
- 11 Section 70. In addition to amounts previously
- 12 appropriated for this purpose, the sum of \$18,252,100, or so
- 13 much thereof as may be necessary, is appropriated from the
- 14 General Revenue Fund to the Department on Aging for grants and
- 15 for administrative expenses associated with the purchase of
- 16 services covered by the Community Care Program, including prior
- 17 year costs.".
