SYNOPSIS AS INTRODUCED:

20 ILCS 655/4

from Ch. 67 1/2, par. 604

Amends the Illinois Enterprise Zone Act. Provides that an area that is located within the jurisdiction of 5 or more municipalities and located in a county in which a military base is located on the effective date of the amendatory Act is qualified to be designated as an enterprise zone if the total area comprises a minimum of one-half square mile and not more than 16 square miles (instead of 12 square miles) in total area, exclusive of lakes and waterways, and meets all other criteria for eligibility. Effective immediately.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Illinois Enterprise Zone Act is amended by 5 changing Section 4 as follows:

6 (20 ILCS 655/4) (from Ch. 67 1/2, par. 604)

Sec. 4. Qualifications for Enterprise Zones. (1) An area is
qualified to become an enterprise zone which:

9 (a) is a contiguous area, provided that a zone area may 10 exclude wholly surrounded territory within its boundaries;

(b) comprises a minimum of one-half square mile and not 11 more than 12 square miles, or 15 square miles if the zone is 12 located within the jurisdiction of 4 or more counties or 13 14 municipalities, in total area, exclusive of lakes and waterways; however, in such cases where the enterprise zone is 15 16 a joint effort of three or more units of government, or two or 17 more units of government if situated in a township which is divided by a municipality of 1,000,000 or more inhabitants, and 18 19 where the certification has been in effect at least one year, 20 the total area shall comprise a minimum of one-half square mile 21 and not more than thirteen square miles in total area exclusive 22 of lakes and waterways; however, if the enterprise zone is located within the jurisdiction of 5 or more municipalities and 23

1 located in a county in which a military base is located on the 2 effective date of this amendatory Act of the 97th General 3 Assembly, the total area shall comprise a minimum of one-half 4 square mile and not more than 16 square miles in total area, 5 exclusive of lakes and waterways;

(c) is a depressed area;

7 (d) satisfies any additional criteria established by 8 regulation of the Department consistent with the purposes of 9 this Act; and

(e) is (1) entirely within a municipality or (2) entirely within the unincorporated areas of a county, except where reasonable need is established for such zone to cover portions of more than one municipality or county or (3) both comprises (i) all or part of a municipality and (ii) an unincorporated area of a county.

16 (2) Any criteria established by the Department or by law 17 which utilize the rate of unemployment for a particular area 18 shall provide that all persons who are not presently employed 19 and have exhausted all unemployment benefits shall be 20 considered unemployed, whether or not such persons are actively 21 seeking employment.
