A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much  
6 thereof as may be necessary, respectively, are appropriated  
7 from the General Revenue Fund to the Department of Human  
8 Rights for the objects and purposes hereinafter enumerated:

20 Section 5. The sum of \$155,000, or so much thereof as

1 may be necessary, is appropriated from the General Revenue  
 2 Fund to the Department of Human Rights for the purpose of  
 3 funding expenses associated with the Commission on  
 4 Discrimination and Hate Crimes as provided in Public Act 95-  
 5 0425.

6 Section 10. The sum of \$350,000, or so much thereof as  
 7 may be necessary, is appropriated from the Department of  
 8 Human Rights Training and Development Fund to the Department  
 9 of Human Rights for the purpose of funding expenses  
 10 associated with administration.

11 Section 15. The following named amounts, or so much  
 12 thereof as may be necessary, respectively, are appropriated  
 13 to the Department of Human Rights for the objects and  
 14 purposes hereinafter enumerated:

 20 and expenses associated with Elementary and Higher Education  
 21 processing.

22 Section 25. The following named amounts, or so much  
 23 thereof as may be necessary, respectively, are appropriated

1 from the General Revenue Fund to the Department of Human  
2 Rights for the objects and purposes hereinafter enumerated:

14 Human Rights Special Fund to the Department of Human Rights  
15 for the purpose of funding expenses associated with the  
16 Department of Human Rights.

17 Section 99. Effective date. This Act takes effect July  
18 1, 2012.
