1 AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1 Section 1. The following amounts, or so much thereof as 5 6 may be necessary, respectively, are appropriated for the 7 objects and purposes named, to meet the ordinary 8 expenses of the Illinois Violence Prevention contingent 9 Authority: 10 Payable from the Violence Prevention Fund: 11 12 For State Contributions to State 13 14 For State Contribution to 15 Social Security40,500 16 17 18 19 20 21 22

- 5 Section 5. The sum of \$1,200,000, or so much thereof as may be necessary, is appropriated from 6 the Violence Prevention Fund to the Illinois Violence Prevention Authority 7 8 for the purpose of awarding grants under the provisions of 9 the Violence Prevention Act of 1995.
- 10 Section 10. The sum of \$1,441,400, or so much thereof as 11 may be necessary, is appropriated from the General Revenue 12 Fund to the Illinois Violence Prevention Authority for the awarding grants, contracts, administrative 13 purpose of 14 expenses and all related costs for violence prevention 15 programs.
- Section 15. The amount of \$544,500, or so much thereof 16 17 as may be necessary, is appropriated from the General Revenue 18 Fund to the Illinois Violence Prevention Authority for the 19 Illinois Family Violence Coordinating Council Program.
- 20 Section 20. The amount of \$273,000, or so much thereof as may be necessary, is appropriated from the General Revenue 21

- 1 Fund to the Illinois Violence Prevention Authority for all
- 2 costs associated with Bullying Prevention.
- 3 Section 25. The amount of \$30,485,000, or so much
- 4 thereof as may be necessary, is appropriated from the General
- 5 Revenue Fund to the Illinois Violence Prevention Authority
- 6 for all costs associated with the Neighborhood Recovery
- 7 Initiative.
- 8 Section 30. The amount of \$3,640,000, or so much thereof
- 9 as may be necessary, is appropriated from the General Revenue
- 10 Fund to the Illinois Violence Prevention Authority for all
- 11 costs associated with Safety Net Works.
- 12 Section 99. Effective date. This Act takes effect July 1,
- 13 2012.
