AN ACT concerning local government.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Counties Code is amended by changing Section
5-1028 as follows:

6 (55 ILCS 5/5-1028) (from Ch. 34, par. 5-1028)

7 Sec. 5-1028. Tax for emergency ambulance service; 8 referendum. In any county which is not a home rule county, a 9 county board may levy and collect, annually, a tax of not to exceed .25% of the value, as equalized or assessed by the 10 Department of Revenue, of all the taxable property in the 11 county not included within the territory of a fire protection 12 district which levies a tax for ambulance service, for the 13 14 payment of expenses not paid for from general funds which are incurred in providing emergency ambulance service under the 15 16 provisions of Section 5-1053. Such tax shall not be included 17 within any statutory limitation of rate or amount for other county purposes, but shall be excluded therefrom and be in 18 addition thereto and in excess thereof. 19

This tax shall not be levied in any county until the question of its adoption is submitted to the electors of the county not residing within the territory of a fire protection district which levies a tax for ambulance service and approved HB0438 Engrossed - 2 - LRB098 03256 OMW 33271 b

by a majority of those voting on the question. Upon the 1 2 adoption of a resolution by the county board providing for the submission of the question of the adoption to the electors of 3 the county the board shall certify the resolution and the 4 5 proposition to the proper election officials who shall submit 6 the proposition at an election in accordance with the general 7 election law. If a majority of the votes cast on the question 8 is in favor of the levy of such tax, it may thereafter be 9 levied in such county for each succeeding year.

10 Notwithstanding any other provision of this Section, the 11 county board of a county that has more than 8,400 but less than 12 9,000 inhabitants, according to the 2010 federal decennial census, may also use funds collected under this Section to 13 14 provide 9-1-1 service, but only if the question of using those funds for that purpose has been submitted to the electors of 15 16 the county not residing within the territory of the fire 17 protection district that levies the tax for ambulance service and if that question is approved by a majority of those 18 19 electors voting on the question. Upon the adoption of a 20 resolution by the county board providing for the submission of that question to those electors, the board shall certify the 21 22 resolution and the proposition to the proper election 23 officials, who shall submit the proposition at an election in 24 accordance with the Election Code.
