1 AMENDMENT TO HOUSE BILL 3053 2 AMENDMENT NO. . Amend House Bill 3053 by replacing everything after the enacting clause with the following: 3 "Section 5. The School Code is amended by changing Section 4 27-6 as follows: 5 6 (105 ILCS 5/27-6) (from Ch. 122, par. 27-6) 7 Sec. 27-6. Courses in physical education required; special 8 activities. (a) Pupils enrolled in the public schools and State 9 10 universities engaged in preparing teachers shall be required to engage daily during the school day, except on block scheduled 11 12 days for those public schools engaged in block scheduling, in 13 courses of physical education for such periods as are compatible with the optimum growth and developmental needs of 14

individuals at the various age levels except when appropriate

excuses are submitted to the school by a pupil's parent or

1 guardian or by a person licensed under the Medical Practice Act

of 1987 and except as provided in subsection (b) of this

Special activities in physical education shall be provided for pupils whose physical or emotional condition, as determined by a person licensed under the Medical Practice Act of 1987, prevents their participation in the courses provided for normal children.

(b) A school board is authorized to excuse pupils enrolled in grades 11 and 12 from engaging in physical education courses if those pupils request to be excused for any of the following reasons: (1) for ongoing participation in an interscholastic athletic program; (2) to enroll in academic classes which are required for admission to an institution of higher learning, provided that failure to take such classes will result in the pupil being denied admission to the institution of his or her choice; or (3) to enroll in academic classes which are required for graduation from high school, provided that failure to take such classes will result in the pupil being unable to graduate. A school board may also excuse pupils in grades 9 through 12 enrolled in a marching band program for credit from engaging in physical education courses if those pupils request to be excused for ongoing participation in such marching band program. In addition, a pupil in any of grades 3 through 12 who is eliqible for special education may be excused if the pupil's parent or guardian agrees that the pupil must utilize the time

1 set aside for physical education to receive special education 2 support and services or, if there is no agreement, the 3 individualized education program team for the pupil determines 4 that the pupil must utilize the time set aside for physical 5 education to receive special education support and services, 6 which agreement or determination must be made a part of the individualized education program. However, a pupil requiring 7 8 adapted physical education must receive that service 9 accordance with the individualized education program developed 10 for the pupil. If requested, a school board is authorized to 11 excuse a pupil from engaging in a physical education course if 12 the pupil has an individualized education program under Article 13 14 of this Code, is participating in an adaptive athletic 14 program outside of the school setting, and documents such 15 participation as determined by the school board. A school board 16 may also excuse pupils in grades 9 through 12 enrolled in a Reserve Officer's Training Corps (ROTC) program sponsored by 17 the school district from engaging in physical education 18 19 courses. School boards which choose to exercise this authority 20 shall establish a policy to excuse pupils on an individual basis. 21
