

1 AN ACT concerning land.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. Upon the payment of the sum of \$2,300 to the  
5 State of Illinois, and subject to the conditions set forth in  
6 Section 900 of this Act, the Secretary of the Department of  
7 Transportation is authorized to convey by quitclaim deed all  
8 right, title, and interest in and to the following described  
9 land in McLean County, Illinois to Todd R. Eades:

10 Parcel No. 5X41203

11 A parcel of land being a part of the Northwest Quarter of  
12 Section 28, Township 25 North, Range 2 East of the Third  
13 Principal Meridian, McLean County, Illinois and being a  
14 part of the right of way acquired by Condemnation Case No.  
15 88ED17 filed June 27, 1988 in the McLean County Circuit  
16 Clerks Office, said parcel being more particularly  
17 described as follows:

18 Beginning at the intersection of the north line of the  
19 Northwest Quarter of said Section 28 and the monumented  
20 east line of the Old Hudson Cemetery said point being the  
21 northwest corner of the 50 feet wide entrance right of way

1           acquired by the aforementioned condemnation case, said  
2           point also being 1645.83 feet easterly of the monumented  
3           northwest corner of said Section 28; thence South 86  
4           degrees 42 minutes 41 seconds East (bearings based on

12          degrees 06 minutes 37 seconds West 50.12 feet along the  
13          south line of said 50 feet entrance right of way to the  
14          southwest corner thereof and east line of said cemetery;  
15          thence North 01 degree 10 minutes 17 seconds West 127.11  
16          feet along the east line of said cemetery and west line of  
17          said 50 feet entrance right of way to the Point of  
18          Beginning, containing 0.146 of an acre, more or less.

19           Section 10. Upon the payment of the sum of \$2,000 to the  
20          State of Illinois, and subject to the conditions set forth in  
21          Section 900 of this Act, the Secretary of the Department of  
22          Transportation is authorized to convey by quitclaim deed all  
23          right, title, and interest in and to the following described  
24          land in Madison County, Illinois to Darren Vollmer:

1 Parcel No. 800XD23

2 That part of the East Half of the Northwest Quarter of  
3 Section 26, Township 5 North, Range 9 West of the Third  
4 Principal Meridian, Madison County, Illinois, described as  
5 follows:

6 Commencing at a stone marking the Southwest corner of said  
7 East Half; thence North 01 degrees 06 minutes 03 seconds  
8 West, along the west line of said Half, 1,556.10 feet to  
9 the southwesterly corner of a tract of land described in

17 northeasterly corner of said tract; thence South 01 degrees  
18 06 minutes 03 seconds East, along the west line of said  
19 tract, 20.02 feet; thence along the southerly line of said  
20 tract, 145.00 feet along a curve to the right, having a  
21 radius of 24,505.40 feet, the chord of said curve bears  
22 North 57 degrees 47 minutes 12 seconds West, a chord  
23 distance of 145.00 feet to the Point of Beginning.

1 Said Parcel 800XD23 contains 0.0512 acres or 2,232 square  
2 feet, more or less.

3 Parcel 800XD23 is subject to any and all utility easements,  
4 and the rights existing to any and all facilities for said  
5 easements on the real estate herein above described.

6 Section 15. Upon the payment of the sum of \$3,100 to the  
7 State of Illinois, and subject to the conditions set forth in  
8 Section 900 of this Act, the Secretary of the Department of  
9 Transportation is authorized to convey by quitclaim deed all  
10 right, title, and interest in and to the following described  
11 land in Madison County, Illinois to SS Peter and Paul Catholic  
12 Church:

14 That part of Lot 4, Four (4) and Five (5) in Block Fifteen  
15 (15) in E.W. Collins Addition to Town, now City of  
16 Collinsville, located in part of the Northeast Quarter of  
17 Section 33, the Northwest Quarter of Section 34 and the  
18 Southwest Quarter of Section 27, Township 3 North, Range 8  
19 West of the Third Principal Meridian, according to the plat  
20 thereof recorded in the Recorder's Office of Madison  
21 County, Illinois in Plat Book 2, Page 1 and subsequently

1 transcribed to Plat Book 10, Page 5 and Plat Book 15, Page

2 Section 20. Upon the payment of the sum of \$31,800 to the  
3 State of Illinois, and subject to the conditions set forth in  
4 Section 900 of this Act, the People of the State of Illinois  
5 hereby release the following described land located in Logan  
6 County, Illinois from all dedication and easement rights, and  
7 interest acquired for highway purposes:

9 A part of the South Half of Section 20, Township 21 North,  
10 Range 1 West of the Third Principal Meridian, Logan County,

3           82.88 feet; thence North 44 degrees 49 minutes 43 seconds  
4           West, 87.53 feet; thence southwesterly on a curve to the  
5           right having a radius of 4870.00 feet and an arc length of  
6           184.76 feet with a chord bearing South 67 degrees 49  
7           minutes 44 seconds West, 184.75 feet; thence South 68  
8           degrees 54 minutes 57 seconds West, 552.38 feet; thence  
9           southwesterly on a curve to the right having a radius of  
10          8096.34 feet and an arc length of 429.27 feet with a chord  
11          bearing South 67 degrees 23 minutes 49 seconds West, 429.22  
12          feet to the westerly property line extended northerly of  
13          Schmidt Implements; thence North 04 degrees 28 minutes 44  
14          seconds East, 85.31 feet; thence northeasterly on a curve  
15          to the left having a radius of 8171.34 feet and an arc  
16          length of 392.41 feet with a chord bearing North 67 degrees  
17          32 minutes 24 seconds East, 392.37 feet; thence North 68  
18          degrees 54 minutes 57 seconds East, 552.38 feet; thence  
19          northeasterly on a curve to the left having a radius of  
20          4795.00 feet and an arc length of 792.79 feet with a chord  
21          bearing North 64 degrees 10 minutes 45 seconds East, 791.88  
22          feet; thence South 30 degrees 33 minutes 21 seconds East,  
23          75.00 feet to the west line of the aforesaid Block 2;  
24          thence along the west line of said Block 2, South 01 degree  
25          37 minutes 03 seconds East, 59.28 feet to the Point of  
26          Beginning, containing 3.603 acre, more or less.

1           Section 25. Upon the payment of the sum of \$2,900 to the  
2 State of Illinois, and subject to the conditions set forth in  
3 Section 900 of this Act, the People of the State of Illinois  
4 hereby release and/or restore any rights or easements of  
5 access, crossing, light, air and view from, to and over the  
6 following described line, subject to permit requirements of the  
7 State of Illinois, Department of Transportation:

8           Parcel No. 800XD28

9           A line in the Southeast Quarter of the Southwest Quarter of  
10 Section 36, Township 6 North, Range 2 West of the 3rd  
11 Principal Meridian in Bond County, Illinois, described as  
12 follows:

13           Commencing at the southwest corner of said Southeast  
14 Quarter of the Southwest Quarter; thence on an assumed  
15 bearing of North 00 degrees 56 minutes 43 seconds West on  
16 the west line of said Southeast Quarter of the Southwest  
17 Quarter, 362.73 feet to the south right of way line of FAP  
18 Route 12 (US Route 40) according to the Dedication of Right  
19 of Way for Public Purposes to the State of Illinois  
20 recorded on April 15, 1941 in Easement Record No.4 at Page  
21 88, and the Point of Beginning of the Release of Access  
22 Control.



1 From said Point of Beginning; thence North 89 degrees 31  
2 minutes 03 seconds East on said south right of way line,  
3 314.17 feet to the Point of Terminus of the Release of

5 west of the most westerly corner of a tract of land as  
6 described by a Warranty Deed recorded in Deed Record 144,  
7 Page 337 in Bond County and in the State of Illinois.

8 Said Parcel 800XD28 consists of a line that is 314.17  
9 linear feet.

10 Section 30. Upon the payment of the sum of \$52,667 to the  
11 State of Illinois, and subject to the conditions set forth in  
12 Section 900 of this Act, the People of the State of Illinois  
13 hereby release the following described land located in McLean  
14 County, Illinois from all dedication and easement rights, and  
15 interest acquired for highway purposes:

16 Parcel No. 5X00402

17 A part of F.A. Route 5, Section 16R right-of-way situated  
18 in the Southwest Quarter of Section 17, Township 23 North,  
19 Range 2 East of the Third Principal Meridian, McLean  
20 County, Illinois, more particularly described as follows:

1 Commencing at the northeast corner of Lot 2 in Townley and  
2 O'Neal's Subdivision of parts of Lots 41, 42 and 43 in the  
3 Subdivision of Section 17, thence South 36 degrees 32  
4 minutes 03 seconds West, 265.15 feet along the  
5 northwesterly line of said Lot 2 to a found iron pin;  
6 thence South 41 degrees 57 minutes 53 seconds West, 178.45  
7 feet along said northwesterly line to a found iron pin on

20 the intersection with the westerly right-of-way line of  
21 Greenwood Avenue; thence North 52 degrees 24 minutes 59  
22 seconds West, 80.00 feet; thence South 36 degrees 33  
23 minutes 17 seconds West, 403.59 feet; thence South 20  
24 degrees 07 minutes 58 seconds East, 70.21 feet to the Point  
25 of Beginning, containing 0.676 acre, or 29,461 square feet,

1 more or less.

7 State of Illinois, and subject to the conditions set forth in  
8 Section 900 of this Act, the People of the State of Illinois  
9 hereby release the following described land located in Logan  
10 County, Illinois from all dedication and easement rights, and  
11 interest acquired for highway purposes:

12 Parcel No. 675X365

13 A part of the Southeast Quarter of Section 26, Township 20  
14 North, Range 3 West of the Third Principal Meridian, Logan  
15 County, Illinois, described as follows:

16 Commencing at the northeast corner of the Southeast Quarter  
17 of said Section 26; thence South 89 degrees 52 minutes 33  
18 seconds West, 144.16 feet; thence South 00 degrees 07  
19 minutes 22 seconds East, 75.00 feet to Illinois Route 10  
20 Station 136+29.51 at 75.00 feet right, being the Point of

11 Section 40. Upon the payment of the sum of \$2,483.33 to the  
12 State of Illinois, and subject to the conditions set forth in  
13 Section 900 of this Act, the People of the State of Illinois  
14 hereby release the following described land located in Cook  
15 County, Illinois from all dedication and easement rights, and  
16 interest acquired for highway purposes:

17 Parcel No. 0ZZ1018:

18 That part of Margaret Street located in the Northwest  
19 Quarter of Section 34, Township 36 North, Range 14 East of  
20 the Third Principal Meridian, in Cook County, Illinois;  
21 described as follows:

1 northerly line of Margaret Street that is 66.00 feet  
2 easterly of the southeast corner of Block 13 in Thornton,

17 building as depicted on said Document Number 24982782, a  
18 distance of 59.55 feet, measured (59.62 feet, recorded) to  
19 an angle point in said southerly face and to the Point of  
20 Beginning; Thence North 75 degrees 40 minutes 36 seconds  
21 East along said southerly face 2.86 feet to said easterly  
22 extension of the northerly right of way line of Margaret  
23 Street; thence North 89 degrees 26 minutes 28 seconds East  
24 along said easterly extension 59.95 feet to the westerly  
25 face of an existing 0.67 foot wide concrete retaining wall  
26 as depicted on said Document Number 24982782; thence South

1           16 degrees 50 minutes 26 seconds East along said westerly  
2           face 9.64 feet; thence North 73 degrees 09 minutes 34  
3           seconds East along the southerly face of said wall 0.67  
4           feet; thence North 16 degrees 50 minutes 26 seconds West  
5           along the easterly face of said wall 9.44 feet to said  
6           easterly extension of the northerly right of way line of  
7           Margaret Street; thence North 89 degrees 26 minutes 28  
8           seconds East along said easterly extension 60.79 feet to  
9           the former northwesterly face of a one story brick building  
10          as depicted on said Document Number 24982782; thence South  
11          47 degrees 48 minutes 10 seconds West along said former  
12          northwesterly face 7.86 feet; thence South 42 degrees 11  
13          minutes 28 seconds East along the former southwesterly face  
14          of said building 25.55 feet to the former most southerly  
15          corner of said building; thence North 80 degrees 38 minutes  
16          56 seconds West 137.36 feet to the Point of Beginning.

17          Said parcel containing 0.033 Acres, more or less.

18          Section 900. The Secretary of Transportation shall obtain a  
19          certified copy of the portion of this Act containing the title,  
20          enacting clause, the effective date, the appropriate Section  
21          containing the land description of the property to be  
22          transferred or otherwise affected under this Act within 69 days  
23          after its effective date and, upon receipt of payment required  
24          by the Section shall record the certified document in the

1 Recorder's Office in the county in which the land is located.

2 Section 950. "An Act concerning local government",  
3 approved September 11, 2007, Public Act 95-604, is amended by  
4 changing Section 5 as follows:

5 (P.A. 95-604, Sec. 5)

6 Sec. 5. The Director of Central Management Services is  
7 authorized to convey by Quit Claim Deed for \$1 to the City of  
8 Chicago the following described real property: surplus  
9 property located within the area bordered by Oak Park Avenue,  
10 West Irving Park Road, North Narragansett Avenue, West Montrose  
11 Avenue, and Forest Preserve Drive, Chicago, Illinois;  
12 provided, however, that should the property fail to be used for  
13 a charitable, educational, or any public purpose within the  
14 first 10 years after the effective date of this amendatory Act  
15 of the 95th General Assembly or fail to be used at any time ~~by~~  
16 ~~the Grantee~~ for charitable, educational, or public purposes,  
17 then title shall revert to the State of Illinois.

19 Section 999. Effective date. This Act takes effect upon  
20 becoming law.
