SYNOPSIS AS INTRODUCED:

20 ILCS 405/405-335 20 ILCS 405/405-335

Amends the Department of Central Management Services Law of the Civil Administrative Code of Illinois. Provides that the Illinois Transparency and Accountability Portal shall provide direct access to a database of all current State grants, sorted by grantee name, awarding agency, grant value, and the purpose for which the grant is awarded. Effective July 1, 2014.

AN ACT concerning State government.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Department of Central Management Services
Law of the Civil Administrative Code of Illinois is amended by
changing Section 405-335 as follows:

8 Sec. 405-335. Illinois Transparency and Accountability 9 Portal (ITAP).

(a) The Department, within 12 months after the effective 10 date of this amendatory Act of the 96th General Assembly, shall 11 establish and maintain a website, known as the Illinois 12 13 Transparency and Accountability Portal (ITAP), with а 14 full-time webmaster tasked with compiling and updating the ITAP database with information received from all State agencies as 15 16 defined in this Section. Subject to appropriation, the 17 full-time webmaster must also compile and update the ITAP with information received from all counties, 18 database 19 townships, library districts, and municipalities.

(b) For purposes of this Section:

1 Authorities under the Governor.

2 "Contracts" means payment obligations with vendors on file 3 with the Office of the Comptroller to purchase goods and 4 services exceeding \$10,000 in value (or, in the case of 5 professional or artistic services, exceeding \$5,000 in value).

6 "Appropriation" means line-item detail of spending 7 approved by the General Assembly and Governor, categorized by 8 object of expenditure.

9 "Individual consultants" means temporary workers eligible10 to receive State benefits paid on a State payroll.

11 "Recipients" means State agencies receiving12 appropriations.

13 (c) The ITAP shall provide direct access to each of the 14 following:

(1) A database of all current State employees and
individual consultants, except sworn law enforcement
officers, sorted separately by:

18 (i) Name.

19 (ii) Employing State agency.

20 (iii) Employing State division.

21 (iv) Employment position title.

22 (v) Current pay rate and year-to-date pay.

(2) A database of all current State expenditures,
 sorted separately by agency, category, recipient, and
 Representative District.

reportable pursuant to the Corporate Accountability for Tax Expenditures Act, sorted separately by tax credit category, taxpayer, and Representative District.

(4) A database of all revocations and suspensions of 4 5 State occupation and use tax certificates of registration and all revocations and suspensions of State professional 6 7 licenses, sorted separately by name, geographic location, 8 and certificate of registration number or license number, 9 applicable. Professional license revocations as and 10 suspensions shall be posted only if resulting from a 11 failure to pay taxes, license fees, or child support.

(5) A database of all current State contracts, sorted
separately by contractor name, awarding officer or agency,
contract value, and goods or services provided.

(ii) Employment position title. 18 19 (iii) Current pay rate and year-to-date pay. 20 (9) A searchable database of all library district employees hired on or after August 9, 2013 (the effective 21 22 date of Public Act 98-246) this amendatory Act of the 98th 23 General Assembly, sorted separately by each of the following at the time of employment: 24 25 (i) Employing unit of local government. 26 (ii) Employment position title.

(iii) Current pay rate and year-to-date pay.
 (9) A database of all current State grants, sorted
 separately by grantee name, awarding agency, grant value,
 and the purpose for which the grant is awarded.

5 (d) The ITAP shall include all information required to be 6 published by subsection (c) of this Section that is available 7 to the Department in a format the Department can compile and 8 publish on the ITAP. The Department shall update the ITAP as 9 additional information becomes available in a format that can 10 be compiled and published on the ITAP by the Department.

(e) Each State agency, county, township, library district, and municipality shall cooperate with the Department in furnishing the information necessary for the implementation of this Section within a timeframe specified by the Department.

(f) Each county, township, library district, or municipality submitting information to be displayed on the Illinois Transparency and Accountability Portal (ITAP) is responsible for the accuracy of the information provided.

(g) The Department, within 6 months after January 1, 2014 19 (the effective date of Public Act 98-283) this amendatory Act 20 21 of the 98th General Assembly, shall distribute a spreadsheet or 22 otherwise make data entry available to each State agency to facilitate the collection of data on the State's annual 23 characteristics, workforce 24 workforce compensation, and 25 employee mobility. The Department shall determine the data to 26 be collected by each State agency. Each State agency shall

1 cooperate with the Department in furnishing the data necessary 2 for the implementation of this subsection within the timeframe 3 specified by the Department. The Department shall publish the 4 data received from each State agency on the ITAP or another 5 open data site annually.
