1 AMENDMENT TO HOUSE BILL 6027

2 AMENDMENT NO. _____. Amend House Bill 6027, AS AMENDED,
3 by deleting everything after the enacting clause, and
4 inserting the following:

5 "ARTICLE 1

6 Section 5. The following named amounts, or so much
7 thereof as may be necessary, respectively, for the objects
8 and purposes hereinafter named, are appropriated to the Board
9 of the Trustees of Southern Illinois University to meet
10 ordinary and contingent expenses for the fiscal year ending
11 June 30, 2015:

12 Payable from the Education Assistance Fund:

13 For Personal Services, including payment
14 to the university for personal services

1	costs incurred during the fiscal year	
2	and salaries accrued but unpaid to academic	
3	personnel for personal services rendered	
4	during the academic year 2014-2015	185,909,000
5	For State Contributions to Social	
6	Security, for Medicare	2,309,400

15 Section 10. The sum of \$1,200,000, or so much thereof as
 16 may be necessary, is appropriated from the Education
 17 Assistance Fund to the Board of Trustees of Southern Illinois
 18 University for all costs associated with the SimmonsCooper
 19 Cancer Center.

20 Section 15. The sum of \$70,000, or so much thereof as
 21 may be necessary, is appropriated from the General Revenue
 22 Fund to the Southern Illinois University School of Journalism
 23 for any costs associated with the Daily Egyptian newspaper.

1 Section 20. The sum of \$27,000, or so much thereof as
2 may be necessary, is appropriated from the State College and
3 University Trust Fund to the Board of Trustees of Southern
4 Illinois University for scholarship grant awards, in
5 accordance with Public Act 91-0083.

6 Section 25. The sum of \$1,250,000, or so much thereof as
7 may be necessary, is appropriated from the General
8 Professions Dedicated Fund to the Board of Trustees of
9 Southern Illinois University for costs associated with the
10 development, support or administration of pharmacy practice
11 education or training programs at the Edwardsville campus.

12 Section 30. The sum of \$311,000, or so much thereof as
13 may be necessary, is appropriated from the Fire Prevention
14 Fund to the Board of Trustees of Southern Illinois University
15 for costs associated with fire protection services at the
16 Southern Illinois University Edwardsville campus.

17 ARTICLE 99

18 Section 99. Effective date. This Act takes effect July
19 1, 2014.”.
