- 7 Missouri Columbia, Missouri State University, West Virginia
- 8 University, and the University of Nebraska Lincoln; and
- 9 WHEREAS, SIC's archery team was organized in the Spring of
- 10 2012 and started competing on the national tournament circuit
- in the fall of that year; in 2 years, it has accumulated 5
- 12 national championships; of the 45 USCAA All-Americans named in
- 2013, 8 were from Southeastern Illinois College: Aaron Head,
- 14 Trevor Nelson, Jordan Walker, Hannah Dudley, Eric Janssen,
- 15 Tyler Butts, Allen Kuhnert, and Josh Bailey of Carrier Mills;
