1 AMENDMENT TO SENATE BILL 930

2 AMENDMENT NO. _____. Amend Senate Bill 930 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Illinois Vehicle Code is amended by
5 changing Section 11-601 as follows:

6 (625 ILCS 5/11-601) (from Ch. 95 1/2, par. 11-601)

7 Sec. 11-601. General speed restrictions.

8 (a) No vehicle may be driven upon any highway of this State
9 at a speed which is greater than is reasonable and proper with
10 regard to traffic conditions and the use of the highway, or
11 endangers the safety of any person or property. The fact that
12 the speed of a vehicle does not exceed the applicable maximum
13 speed limit does not relieve the driver from the duty to
14 decrease speed when approaching and crossing an intersection,
15 approaching and going around a curve, when approaching a hill
16 crest, when traveling upon any narrow or winding roadway, or

1 when special hazard exists with respect to pedestrians or other
2 traffic or by reason of weather or highway conditions. Speed
3 must be decreased as may be necessary to avoid colliding with
4 any person or vehicle on or entering the highway in compliance
5 with legal requirements and the duty of all persons to use due
6 care.

7 (b) No person may drive a vehicle upon any highway of this
8 State at a speed which is greater than the applicable statutory
9 maximum speed limit established by paragraphs (c), (d), (e),
10 (f) or (g) of this Section, by Section 11-605 or by a
11 regulation or ordinance made under this Chapter.

12 (c) Unless some other speed restriction is established
13 under this Chapter, the maximum speed limit in an urban
14 district for all vehicles is:

- 15 1. 30 miles per hour; and
- 16 2. 15 miles per hour in an alley.

17 (d) Unless some other speed restriction is established
18 under this Chapter, the maximum speed limit outside an urban
19 district for any vehicle is (1) 65 miles per hour (i) for all
20 highways under the jurisdiction of the Illinois State Toll
21 Highway Authority, unless some other speed limit is designated,
22 and (ii) for all or part of highways that are designated by the
23 Department, have at least 4 lanes of traffic, and have a
24 separation between the roadways moving in opposite directions
25 and (2) 55 miles per hour for all other highways, roads, and
26 streets.

1 (d-1) Unless some other speed restriction is established
2 under this Chapter, the maximum speed limit outside an urban
3 district for any vehicle is (1) 70 miles per hour on any
4 interstate highway as defined by Section 1-133.1 of this Code;
5 (2) 65 miles per hour for all or part of highways that are
6 designated by the Department, have at least 4 lanes of traffic,
7 and have a separation between the roadways moving in opposite
8 directions; and (3) 55 miles per hour for all other highways,
9 roads, and streets. The counties of Cook, DuPage, Kane, Lake,
10 Madison, McHenry, St. Clair, and Will may adopt ordinances
11 setting a maximum speed limit on highways, roads, and streets
12 that is lower than the limits established by this Section.

13 (e) In the counties of Cook, DuPage, Kane, Lake, McHenry,
14 and Will, unless some lesser speed restriction is established
15 under this Chapter, the maximum speed limit outside an urban
16 district for a second division vehicle designed or used for the
17 carrying of a gross weight of 8,001 pounds or more (including
18 the weight of the vehicle and maximum load) on any interstate
19 highway as defined by Section 1-133.1 of this Code is 60 ~~is 55~~
20 miles per hour.

21 (e-1) (Blank).

22 (f) Unless some other speed restriction is established
23 under this Chapter, the maximum speed limit outside an urban
24 district for a bus is:

- 25 1. 65 miles per hour upon any highway which has at
26 least 4 lanes of traffic and of which the roadways for

1 traffic moving in opposite directions are separated by a
2 strip of ground which is not surfaced or suitable for
3 vehicular traffic, except that the maximum speed limit for
4 a bus on all highways, roads, or streets not under the
5 jurisdiction of the Department or the Illinois State Toll
6 Highway Authority is 55 miles per hour;

7 1.5. 70 miles per hour upon any interstate highway as
8 defined by Section 1-133.1 of this Code outside the
9 counties of Cook, DuPage, Kane, Lake, McHenry, and Will;
10 and

11 2. 55 miles per hour on any other highway.
