#### SYNOPSIS AS INTRODUCED:

235 ILCS 5/6-15

from Ch. 43, par. 130

Amends the Liquor Control Act of 1934. Provides that alcoholic liquors may be served or sold in buildings under the control of the Board of Trustees of Chicago State University for events that the Board may determine are public events and not student-related activities. Provides that the Board of Trustees shall issue a written policy within 6 months after the effective date of the amendatory Act concerning the types of events that would be eligible for an exemption. Provides that the Board of Trustees may issue revised, updated, new, or amended policies as it deems necessary and appropriate. Specifies factors that the Board shall, in addition to other factors it considers relevant and important, consider in forming its written policy. Effective immediately.

1 AN ACT concerning liquor.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Liquor Control Act of 1934 is amended by  
5 changing Section 6-15 as follows:

6 (235 ILCS 5/6-15) (from Ch. 43, par. 130)

7 Sec. 6-15. No alcoholic liquors shall be sold or delivered  
8 in any building belonging to or under the control of the State  
9 or any political subdivision thereof except as provided in this  
10 Act. The corporate authorities of any city, village,  
11 incorporated town, township, or county may provide by  
12 ordinance, however, that alcoholic liquor may be sold or  
13 delivered in any specifically designated building belonging to  
14 or under the control of the municipality, township, or county,  
15 or in any building located on land under the control of the  
16 municipality, township, or county; provided that such township  
17 or county complies with all applicable local ordinances in any  
18 incorporated area of the township or county. Alcoholic liquor  
19 may be delivered to and sold under the authority of a special  
20 use permit on any property owned by a conservation district  
21 organized under the Conservation District Act, provided that  
22 (i) the alcoholic liquor is sold only at an event authorized by  
23 the governing board of the conservation district, (ii) the

1 issuance of the special use permit is authorized by the local  
2 liquor control commissioner of the territory in which the  
3 property is located, and (iii) the special use permit  
4 authorizes the sale of alcoholic liquor for one day or less.  
5 Alcoholic liquors may be delivered to and sold at any airport  
6 belonging to or under the control of a municipality of more  
7 than 25,000 inhabitants, or in any building or on any golf  
8 course owned by a park district organized under the Park  
9 District Code, subject to the approval of the governing board  
10 of the district, or in any building or on any golf course owned  
11 by a forest preserve district organized under the Downstate  
12 Forest Preserve District Act, subject to the approval of the  
13 governing board of the district, or on the grounds within 500  
14 feet of any building owned by a forest preserve district  
15 organized under the Downstate Forest Preserve District Act  
16 during times when food is dispensed for consumption within 500  
17 feet of the building from which the food is dispensed, subject  
18 to the approval of the governing board of the district, or in a  
19 building owned by a Local Mass Transit District organized under  
20 the Local Mass Transit District Act, subject to the approval of  
21 the governing Board of the District, or in Bicentennial Park,  
22 or on the premises of the City of Mendota Lake Park located  
23 adjacent to Route 51 in Mendota, Illinois, or on the premises  
24 of Camden Park in Milan, Illinois, or in the community center  
25 owned by the City of Loves Park that is located at 1000 River  
26 Park Drive in Loves Park, Illinois, or, in connection with the

1 operation of an established food serving facility during times  
2 when food is dispensed for consumption on the premises, and at  
3 the following aquarium and museums located in public parks: Art  
4 Institute of Chicago, Chicago Academy of Sciences, Chicago  
5 Historical Society, Field Museum of Natural History, Museum of  
6 Science and Industry, DuSable Museum of African American  
7 History, John G. Shedd Aquarium and Adler Planetarium, or at  
8 Lakeview Museum of Arts and Sciences in Peoria, or in  
9 connection with the operation of the facilities of the Chicago  
10 Zoological Society or the Chicago Horticultural Society on land  
11 owned by the Forest Preserve District of Cook County, or on any  
12 land used for a golf course or for recreational purposes owned  
13 by the Forest Preserve District of Cook County, subject to the  
14 control of the Forest Preserve District Board of Commissioners  
15 and applicable local law, provided that dram shop liability  
16 insurance is provided at maximum coverage limits so as to hold  
17 the District harmless from all financial loss, damage, and  
18 harm, or in any building located on land owned by the Chicago  
19 Park District if approved by the Park District Commissioners,  
20 or on any land used for a golf course or for recreational  
21 purposes and owned by the Illinois International Port District  
22 if approved by the District's governing board, or at any  
23 airport, golf course, faculty center, or facility in which  
24 conference and convention type activities take place belonging  
25 to or under control of any State university or public community  
26 college district, provided that with respect to a facility for

1 conference and convention type activities alcoholic liquors  
2 shall be limited to the use of the convention or conference  
3 participants or participants in cultural, political or  
4 educational activities held in such facilities, and provided  
5 further that the faculty or staff of the State university or a  
6 public community college district, or members of an  
7 organization of students, alumni, faculty or staff of the State  
8 university or a public community college district are active  
9 participants in the conference or convention, or in Memorial  
10 Stadium on the campus of the University of Illinois at  
11 Urbana-Champaign during games in which the Chicago Bears  
12 professional football team is playing in that stadium during  
13 the renovation of Soldier Field, not more than one and a half  
14 hours before the start of the game and not after the end of the  
15 third quarter of the game, or in the Pavilion Facility on the  
16 campus of the University of Illinois at Chicago during games in  
17 which the Chicago Storm professional soccer team is playing in  
18 that facility, not more than one and a half hours before the  
19 start of the game and not after the end of the third quarter of  
20 the game, or in the Pavilion Facility on the campus of the  
21 University of Illinois at Chicago during games in which the  
22 WNBA professional women's basketball team is playing in that  
23 facility, not more than one and a half hours before the start  
24 of the game and not after the 10-minute mark of the second half  
25 of the game, or by a catering establishment which has rented  
26 facilities from a board of trustees of a public community

1 college district, or in a restaurant that is operated by a  
2 commercial tenant in the North Campus Parking Deck building  
3 that (1) is located at 1201 West University Avenue, Urbana,  
4 Illinois and (2) is owned by the Board of Trustees of the  
5 University of Illinois, or, if approved by the District board,  
6 on land owned by the Metropolitan Sanitary District of Greater  
7 Chicago and leased to others for a term of at least 20 years.  
8 Nothing in this Section precludes the sale or delivery of  
9 alcoholic liquor in the form of original packaged goods in  
10 premises located at 500 S. Racine in Chicago belonging to the  
11 University of Illinois and used primarily as a grocery store by  
12 a commercial tenant during the term of a lease that predates  
13 the University's acquisition of the premises; but the  
14 University shall have no power or authority to renew, transfer,  
15 or extend the lease with terms allowing the sale of alcoholic  
16 liquor; and the sale of alcoholic liquor shall be subject to  
17 all local laws and regulations. After the acquisition by  
18 Winnebago County of the property located at 404 Elm Street in  
19 Rockford, a commercial tenant who sold alcoholic liquor at  
20 retail on a portion of the property under a valid license at  
21 the time of the acquisition may continue to do so for so long  
22 as the tenant and the County may agree under existing or future  
23 leases, subject to all local laws and regulations regarding the  
24 sale of alcoholic liquor. Alcoholic liquors may be delivered to  
25 and sold at Memorial Hall, located at 211 North Main Street,  
26 Rockford, under conditions approved by Winnebago County and

1 subject to all local laws and regulations regarding the sale of  
2 alcoholic liquor. Each facility shall provide dram shop  
3 liability in maximum insurance coverage limits so as to save  
4 harmless the State, municipality, State university, airport,  
5 golf course, faculty center, facility in which conference and  
6 convention type activities take place, park district, Forest  
7 Preserve District, public community college district,  
8 aquarium, museum, or sanitary district from all financial loss,  
9 damage or harm. Alcoholic liquors may be sold at retail in  
10 buildings of golf courses owned by municipalities or Illinois  
11 State University in connection with the operation of an  
12 established food serving facility during times when food is  
13 dispensed for consumption upon the premises. Alcoholic liquors  
14 may be delivered to and sold at retail in any building owned by  
15 a fire protection district organized under the Fire Protection  
16 District Act, provided that such delivery and sale is approved  
17 by the board of trustees of the district, and provided further  
18 that such delivery and sale is limited to fundraising events  
19 and to a maximum of 6 events per year.

20 Alcoholic liquors may be served or sold in buildings under  
21 the control of the Board of Trustees of the University of  
22 Illinois for events that the Board may determine are public  
23 events and not related student activities. The Board of  
24 Trustees shall issue a written policy within 6 months of the  
25 effective date of this amendatory Act of the 95th General  
26 Assembly concerning the types of events that would be eligible

1 for an exemption. Thereafter, the Board of Trustees may issue  
2 revised, updated, new, or amended policies as it deems  
3 necessary and appropriate. In preparing its written policy, the  
4 Board of Trustees shall, among other factors it considers  
5 relevant and important, give consideration to the following:  
6 (i) whether the event is a student activity or student related  
7 activity; (ii) whether the physical setting of the event is  
8 conducive to control of liquor sales and distribution; (iii)  
9 the ability of the event operator to ensure that the sale or  
10 serving of alcoholic liquors and the demeanor of the  
11 participants are in accordance with State law and University  
12 policies; (iv) regarding the anticipated attendees at the  
13 event, the relative proportion of individuals under the age of  
14 21 to individuals age 21 or older; (v) the ability of the venue  
15 operator to prevent the sale or distribution of alcoholic  
16 liquors to individuals under the age of 21; (vi) whether the  
17 event prohibits participants from removing alcoholic beverages  
18 from the venue; and (vii) whether the event prohibits  
19 participants from providing their own alcoholic liquors to the  
20 venue. In addition, any policy submitted by the Board of  
21 Trustees to the Illinois Liquor Control Commission must require  
22 that any event at which alcoholic liquors are served or sold in  
23 buildings under the control of the Board of Trustees shall  
24 require the prior written approval of the Office of the  
25 Chancellor for the University campus where the event is  
26 located. The Board of Trustees shall submit its policy, and any



1 subsequently revised, updated, new, or amended policies, to the  
2 Illinois Liquor Control Commission, and any University event,  
3 or location for an event, exempted under such policies shall  
4 apply for a license under the applicable Sections of this Act.

5 Alcoholic liquors may be served or sold in buildings under  
6 the control of the Board of Trustees of Northern Illinois  
7 University for events that the Board may determine are public  
8 events and not student-related activities. The Board of  
9 Trustees shall issue a written policy within 6 months after  
10 June 28, 2011 (the effective date of Public Act 97-45)  
11 concerning the types of events that would be eligible for an  
12 exemption. Thereafter, the Board of Trustees may issue revised,  
13 updated, new, or amended policies as it deems necessary and  
14 appropriate. In preparing its written policy, the Board of  
15 Trustees shall, in addition to other factors it considers  
16 relevant and important, give consideration to the following:  
17 (i) whether the event is a student activity or student-related  
18 activity; (ii) whether the physical setting of the event is  
19 conducive to control of liquor sales and distribution; (iii)  
20 the ability of the event operator to ensure that the sale or  
21 serving of alcoholic liquors and the demeanor of the  
22 participants are in accordance with State law and University  
23 policies; (iv) the anticipated attendees at the event and the  
24 relative proportion of individuals under the age of 21 to  
25 individuals age 21 or older; (v) the ability of the venue  
26 operator to prevent the sale or distribution of alcoholic

1 liquors to individuals under the age of 21; (vi) whether the  
2 event prohibits participants from removing alcoholic beverages  
3 from the venue; and (vii) whether the event prohibits  
4 participants from providing their own alcoholic liquors to the  
5 venue.

6 Alcoholic liquors may be served or sold in buildings under  
7 the control of the Board of Trustees of Chicago State  
8 University for events that the Board may determine are public  
9 events and not student-related activities. The Board of  
10 Trustees shall issue a written policy within 6 months after the  
11 effective date of this amendatory Act of the 98th General  
12 Assembly concerning the types of events that would be eligible  
13 for an exemption. Thereafter, the Board of Trustees may issue  
14 revised, updated, new, or amended policies as it deems  
15 necessary and appropriate. In preparing its written policy, the  
16 Board of Trustees shall, in addition to other factors it  
17 considers relevant and important, give consideration to the  
18 following: (i) whether the event is a student activity or  
19 student-related activity; (ii) whether the physical setting of  
20 the event is conducive to control of liquor sales and  
21 distribution; (iii) the ability of the event operator to ensure  
22 that the sale or serving of alcoholic liquors and the demeanor  
23 of the participants are in accordance with State law and  
24 University policies; (iv) the anticipated attendees at the  
25 event and the relative proportion of individuals under the age  
26 of 21 to individuals age 21 or older; (v) the ability of the

1 venue operator to prevent the sale or distribution of alcoholic  
2 liquors to individuals under the age of 21; (vi) whether the  
3 event prohibits participants from removing alcoholic beverages  
4 from the venue; and (vii) whether the event prohibits  
5 participants from providing their own alcoholic liquors to the  
6 venue.

7       Alcoholic liquor may be delivered to and sold at retail in  
8 the Dorchester Senior Business Center owned by the Village of  
9 Dolton if the alcoholic liquor is sold or dispensed only in  
10 connection with organized functions for which the planned  
11 attendance is 20 or more persons, and if the person or facility  
12 selling or dispensing the alcoholic liquor has provided dram  
13 shop liability insurance in maximum limits so as to hold  
14 harmless the Village of Dolton and the State from all financial  
15 loss, damage and harm.

16       Alcoholic liquors may be delivered to and sold at retail in  
17 any building used as an Illinois State Armory provided:

18           (i) the Adjutant General's written consent to the  
19 issuance of a license to sell alcoholic liquor in such  
20 building is filed with the Commission;

21           (ii) the alcoholic liquor is sold or dispensed only in  
22 connection with organized functions held on special  
23 occasions;

24           (iii) the organized function is one for which the  
25 planned attendance is 25 or more persons; and

26           (iv) the facility selling or dispensing the alcoholic

1           liquors has provided dram shop liability insurance in  
2           maximum limits so as to save harmless the facility and the  
3           State from all financial loss, damage or harm.

4           Alcoholic liquors may be delivered to and sold at retail in  
5           the Chicago Civic Center, provided that:

6                   (i) the written consent of the Public Building  
7                   Commission which administers the Chicago Civic Center is  
8                   filed with the Commission;

9                   (ii) the alcoholic liquor is sold or dispensed only in  
10                  connection with organized functions held on special  
11                  occasions;

12                  (iii) the organized function is one for which the  
13                  planned attendance is 25 or more persons;

14                  (iv) the facility selling or dispensing the alcoholic  
15                  liquors has provided dram shop liability insurance in  
16                  maximum limits so as to hold harmless the Civic Center, the  
17                  City of Chicago and the State from all financial loss,  
18                  damage or harm; and

19                  (v) all applicable local ordinances are complied with.

20           Alcoholic liquors may be delivered or sold in any building  
21           belonging to or under the control of any city, village or  
22           incorporated town where more than 75% of the physical  
23           properties of the building is used for commercial or  
24           recreational purposes, and the building is located upon a pier  
25           extending into or over the waters of a navigable lake or stream  
26           or on the shore of a navigable lake or stream. In accordance

1 with a license issued under this Act, alcoholic liquor may be  
2 sold, served, or delivered in buildings and facilities under  
3 the control of the Department of Natural Resources during  
4 events or activities lasting no more than 7 continuous days  
5 upon the written approval of the Director of Natural Resources  
6 acting as the controlling government authority. The Director of  
7 Natural Resources may specify conditions on that approval,  
8 including but not limited to requirements for insurance and  
9 hours of operation. Notwithstanding any other provision of this  
10 Act, alcoholic liquor sold by a United States Army Corps of  
11 Engineers or Department of Natural Resources concessionaire  
12 who was operating on June 1, 1991 for on-premises consumption  
13 only is not subject to the provisions of Articles IV and IX.  
14 Beer and wine may be sold on the premises of the Joliet Park  
15 District Stadium owned by the Joliet Park District when written  
16 consent to the issuance of a license to sell beer and wine in  
17 such premises is filed with the local liquor commissioner by  
18 the Joliet Park District. Beer and wine may be sold in  
19 buildings on the grounds of State veterans' homes when written  
20 consent to the issuance of a license to sell beer and wine in  
21 such buildings is filed with the Commission by the Department  
22 of Veterans' Affairs, and the facility shall provide dram shop  
23 liability in maximum insurance coverage limits so as to save  
24 the facility harmless from all financial loss, damage or harm.  
25 Such liquors may be delivered to and sold at any property owned  
26 or held under lease by a Metropolitan Pier and Exposition

1 Authority or Metropolitan Exposition and Auditorium Authority.

2 Beer and wine may be sold and dispensed at professional  
3 sporting events and at professional concerts and other  
4 entertainment events conducted on premises owned by the Forest  
5 Preserve District of Kane County, subject to the control of the  
6 District Commissioners and applicable local law, provided that  
7 dram shop liability insurance is provided at maximum coverage  
8 limits so as to hold the District harmless from all financial  
9 loss, damage and harm.

10 Nothing in this Section shall preclude the sale or delivery  
11 of beer and wine at a State or county fair or the sale or  
12 delivery of beer or wine at a city fair in any otherwise lawful  
13 manner.

14 Alcoholic liquors may be sold at retail in buildings in  
15 State parks under the control of the Department of Natural  
16 Resources, provided:

17 a. the State park has overnight lodging facilities with  
18 some restaurant facilities or, not having overnight  
19 lodging facilities, has restaurant facilities which serve  
20 complete luncheon and dinner or supper meals,

21 b. consent to the issuance of a license to sell  
22 alcoholic liquors in the buildings has been filed with the  
23 commission by the Department of Natural Resources, and

24 c. the alcoholic liquors are sold by the State park  
25 lodge or restaurant concessionaire only during the hours  
26 from 11 o'clock a.m. until 12 o'clock midnight.

1           Notwithstanding any other provision of this Act, alcoholic  
2           liquor sold by the State park or restaurant concessionaire  
3           is not subject to the provisions of Articles IV and IX.

4           Alcoholic liquors may be sold at retail in buildings on  
5           properties under the control of the Historic Sites and  
6           Preservation Division of the Historic Preservation Agency or  
7           the Abraham Lincoln Presidential Library and Museum provided:

8           a. the property has overnight lodging facilities with  
9           some restaurant facilities or, not having overnight  
10          lodging facilities, has restaurant facilities which serve  
11          complete luncheon and dinner or supper meals,

12          b. consent to the issuance of a license to sell  
13          alcoholic liquors in the buildings has been filed with the  
14          commission by the Historic Sites and Preservation Division  
15          of the Historic Preservation Agency or the Abraham Lincoln  
16          Presidential Library and Museum, and

17          c. the alcoholic liquors are sold by the lodge or  
18          restaurant concessionaire only during the hours from 11  
19          o'clock a.m. until 12 o'clock midnight.

20          The sale of alcoholic liquors pursuant to this Section does  
21          not authorize the establishment and operation of facilities  
22          commonly called taverns, saloons, bars, cocktail lounges, and  
23          the like except as a part of lodge and restaurant facilities in  
24          State parks or golf courses owned by Forest Preserve Districts  
25          with a population of less than 3,000,000 or municipalities or  
26          park districts.

1           Alcoholic liquors may be sold at retail in the Springfield  
2 Administration Building of the Department of Transportation  
3 and the Illinois State Armory in Springfield; provided, that  
4 the controlling government authority may consent to such sales  
5 only if

6           a. the request is from a not-for-profit organization;

7           b. such sales would not impede normal operations of the  
8 departments involved;

9           c. the not-for-profit organization provides dram shop  
10 liability in maximum insurance coverage limits and agrees  
11 to defend, save harmless and indemnify the State of  
12 Illinois from all financial loss, damage or harm;

13           d. no such sale shall be made during normal working  
14 hours of the State of Illinois; and

15           e. the consent is in writing.

16           Alcoholic liquors may be sold at retail in buildings in  
17 recreational areas of river conservancy districts under the  
18 control of, or leased from, the river conservancy districts.  
19 Such sales are subject to reasonable local regulations as  
20 provided in Article IV; however, no such regulations may  
21 prohibit or substantially impair the sale of alcoholic liquors  
22 on Sundays or Holidays.

23           Alcoholic liquors may be provided in long term care  
24 facilities owned or operated by a county under Division 5-21 or  
25 5-22 of the Counties Code, when approved by the facility  
26 operator and not in conflict with the regulations of the



1 Illinois Department of Public Health, to residents of the  
2 facility who have had their consumption of the alcoholic  
3 liquors provided approved in writing by a physician licensed to  
4 practice medicine in all its branches.

5 Alcoholic liquors may be delivered to and dispensed in  
6 State housing assigned to employees of the Department of  
7 Corrections. No person shall furnish or allow to be furnished  
8 any alcoholic liquors to any prisoner confined in any jail,  
9 reformatory, prison or house of correction except upon a  
10 physician's prescription for medicinal purposes.

11 Alcoholic liquors may be sold at retail or dispensed at the  
12 Willard Ice Building in Springfield, at the State Library in  
13 Springfield, and at Illinois State Museum facilities by (1) an  
14 agency of the State, whether legislative, judicial or  
15 executive, provided that such agency first obtains written  
16 permission to sell or dispense alcoholic liquors from the  
17 controlling government authority, or by (2) a not-for-profit  
18 organization, provided that such organization:

19 a. Obtains written consent from the controlling  
20 government authority;

21 b. Sells or dispenses the alcoholic liquors in a manner  
22 that does not impair normal operations of State offices  
23 located in the building;

24 c. Sells or dispenses alcoholic liquors only in  
25 connection with an official activity in the building;

26 d. Provides, or its catering service provides, dram

1 shop liability insurance in maximum coverage limits and in  
2 which the carrier agrees to defend, save harmless and  
3 indemnify the State of Illinois from all financial loss,  
4 damage or harm arising out of the selling or dispensing of  
5 alcoholic liquors.

6 Nothing in this Act shall prevent a not-for-profit  
7 organization or agency of the State from employing the services  
8 of a catering establishment for the selling or dispensing of  
9 alcoholic liquors at authorized functions.

10 The controlling government authority for the Willard Ice  
11 Building in Springfield shall be the Director of the Department  
12 of Revenue. The controlling government authority for Illinois  
13 State Museum facilities shall be the Director of the Illinois  
14 State Museum. The controlling government authority for the  
15 State Library in Springfield shall be the Secretary of State.

16 Alcoholic liquors may be delivered to and sold at retail or  
17 dispensed at any facility, property or building under the  
18 jurisdiction of the Historic Sites and Preservation Division of  
19 the Historic Preservation Agency or the Abraham Lincoln  
20 Presidential Library and Museum where the delivery, sale or  
21 dispensing is by (1) an agency of the State, whether  
22 legislative, judicial or executive, provided that such agency  
23 first obtains written permission to sell or dispense alcoholic  
24 liquors from a controlling government authority, or by (2) an  
25 individual or organization provided that such individual or  
26 organization:

1           a. Obtains written consent from the controlling  
2 government authority;

3           b. Sells or dispenses the alcoholic liquors in a manner  
4 that does not impair normal workings of State offices or  
5 operations located at the facility, property or building;

6           c. Sells or dispenses alcoholic liquors only in  
7 connection with an official activity of the individual or  
8 organization in the facility, property or building;

9           d. Provides, or its catering service provides, dram  
10 shop liability insurance in maximum coverage limits and in  
11 which the carrier agrees to defend, save harmless and  
12 indemnify the State of Illinois from all financial loss,  
13 damage or harm arising out of the selling or dispensing of  
14 alcoholic liquors.

15           The controlling government authority for the Historic  
16 Sites and Preservation Division of the Historic Preservation  
17 Agency shall be the Director of the Historic Sites and  
18 Preservation, and the controlling government authority for the  
19 Abraham Lincoln Presidential Library and Museum shall be the  
20 Director of the Abraham Lincoln Presidential Library and  
21 Museum.

22           Alcoholic liquors may be delivered to and sold at retail or  
23 dispensed for consumption at the Michael Bilandic Building at  
24 160 North LaSalle Street, Chicago IL 60601, after the normal  
25 business hours of any day care or child care facility located  
26 in the building, by (1) a commercial tenant or subtenant

1 conducting business on the premises under a lease made pursuant  
2 to Section 405-315 of the Department of Central Management  
3 Services Law (20 ILCS 405/405-315), provided that such tenant  
4 or subtenant who accepts delivery of, sells, or dispenses  
5 alcoholic liquors shall procure and maintain dram shop  
6 liability insurance in maximum coverage limits and in which the  
7 carrier agrees to defend, indemnify, and save harmless the  
8 State of Illinois from all financial loss, damage, or harm  
9 arising out of the delivery, sale, or dispensing of alcoholic  
10 liquors, or by (2) an agency of the State, whether legislative,  
11 judicial, or executive, provided that such agency first obtains  
12 written permission to accept delivery of and sell or dispense  
13 alcoholic liquors from the Director of Central Management  
14 Services, or by (3) a not-for-profit organization, provided  
15 that such organization:

16 a. obtains written consent from the Department of  
17 Central Management Services;

18 b. accepts delivery of and sells or dispenses the  
19 alcoholic liquors in a manner that does not impair normal  
20 operations of State offices located in the building;

21 c. accepts delivery of and sells or dispenses alcoholic  
22 liquors only in connection with an official activity in the  
23 building; and

24 d. provides, or its catering service provides, dram  
25 shop liability insurance in maximum coverage limits and in  
26 which the carrier agrees to defend, save harmless, and

1 indemnify the State of Illinois from all financial loss,  
2 damage, or harm arising out of the selling or dispensing of  
3 alcoholic liquors.

4 Nothing in this Act shall prevent a not-for-profit  
5 organization or agency of the State from employing the services  
6 of a catering establishment for the selling or dispensing of  
7 alcoholic liquors at functions authorized by the Director of  
8 Central Management Services.

9 Alcoholic liquors may be sold at retail or dispensed at the  
10 James R. Thompson Center in Chicago, subject to the provisions  
11 of Section 7.4 of the State Property Control Act, and 222 South  
12 College Street in Springfield, Illinois by (1) a commercial  
13 tenant or subtenant conducting business on the premises under a  
14 lease or sublease made pursuant to Section 405-315 of the  
15 Department of Central Management Services Law (20 ILCS  
16 405/405-315), provided that such tenant or subtenant who sells  
17 or dispenses alcoholic liquors shall procure and maintain dram  
18 shop liability insurance in maximum coverage limits and in  
19 which the carrier agrees to defend, indemnify and save harmless  
20 the State of Illinois from all financial loss, damage or harm  
21 arising out of the sale or dispensing of alcoholic liquors, or  
22 by (2) an agency of the State, whether legislative, judicial or  
23 executive, provided that such agency first obtains written  
24 permission to sell or dispense alcoholic liquors from the  
25 Director of Central Management Services, or by (3) a  
26 not-for-profit organization, provided that such organization:

1           a. Obtains written consent from the Department of  
2 Central Management Services;

3           b. Sells or dispenses the alcoholic liquors in a manner  
4 that does not impair normal operations of State offices  
5 located in the building;

6           c. Sells or dispenses alcoholic liquors only in  
7 connection with an official activity in the building;

8           d. Provides, or its catering service provides, dram  
9 shop liability insurance in maximum coverage limits and in  
10 which the carrier agrees to defend, save harmless and  
11 indemnify the State of Illinois from all financial loss,  
12 damage or harm arising out of the selling or dispensing of  
13 alcoholic liquors.

14           Nothing in this Act shall prevent a not-for-profit  
15 organization or agency of the State from employing the services  
16 of a catering establishment for the selling or dispensing of  
17 alcoholic liquors at functions authorized by the Director of  
18 Central Management Services.

19           Alcoholic liquors may be sold or delivered at any facility  
20 owned by the Illinois Sports Facilities Authority provided that  
21 dram shop liability insurance has been made available in a  
22 form, with such coverage and in such amounts as the Authority  
23 reasonably determines is necessary.

24           Alcoholic liquors may be sold at retail or dispensed at the  
25 Rockford State Office Building by (1) an agency of the State,  
26 whether legislative, judicial or executive, provided that such

1 agency first obtains written permission to sell or dispense  
2 alcoholic liquors from the Department of Central Management  
3 Services, or by (2) a not-for-profit organization, provided  
4 that such organization:

5 a. Obtains written consent from the Department of  
6 Central Management Services;

7 b. Sells or dispenses the alcoholic liquors in a manner  
8 that does not impair normal operations of State offices  
9 located in the building;

10 c. Sells or dispenses alcoholic liquors only in  
11 connection with an official activity in the building;

12 d. Provides, or its catering service provides, dram  
13 shop liability insurance in maximum coverage limits and in  
14 which the carrier agrees to defend, save harmless and  
15 indemnify the State of Illinois from all financial loss,  
16 damage or harm arising out of the selling or dispensing of  
17 alcoholic liquors.

18 Nothing in this Act shall prevent a not-for-profit  
19 organization or agency of the State from employing the services  
20 of a catering establishment for the selling or dispensing of  
21 alcoholic liquors at functions authorized by the Department of  
22 Central Management Services.

23 Alcoholic liquors may be sold or delivered in a building  
24 that is owned by McLean County, situated on land owned by the  
25 county in the City of Bloomington, and used by the McLean  
26 County Historical Society if the sale or delivery is approved

1 by an ordinance adopted by the county board, and the  
2 municipality in which the building is located may not prohibit  
3 that sale or delivery, notwithstanding any other provision of  
4 this Section. The regulation of the sale and delivery of  
5 alcoholic liquor in a building that is owned by McLean County,  
6 situated on land owned by the county, and used by the McLean  
7 County Historical Society as provided in this paragraph is an  
8 exclusive power and function of the State and is a denial and  
9 limitation under Article VII, Section 6, subsection (h) of the  
10 Illinois Constitution of the power of a home rule municipality  
11 to regulate that sale and delivery.

12 Alcoholic liquors may be sold or delivered in any building  
13 situated on land held in trust for any school district  
14 organized under Article 34 of the School Code, if the building  
15 is not used for school purposes and if the sale or delivery is  
16 approved by the board of education.

17 Alcoholic liquors may be sold or delivered in buildings  
18 owned by the Community Building Complex Committee of Boone  
19 County, Illinois if the person or facility selling or  
20 dispensing the alcoholic liquor has provided dram shop  
21 liability insurance with coverage and in amounts that the  
22 Committee reasonably determines are necessary.

23 Alcoholic liquors may be sold or delivered in the building  
24 located at 1200 Centerville Avenue in Belleville, Illinois and  
25 occupied by either the Belleville Area Special Education  
26 District or the Belleville Area Special Services Cooperative.



1           Alcoholic liquors may be delivered to and sold at the Louis  
2 Joliet Renaissance Center, City Center Campus, located at 214  
3 N. Ottawa Street, Joliet, and the Food Services/Culinary Arts  
4 Department facilities, Main Campus, located at 1215 Houbolt  
5 Road, Joliet, owned by or under the control of Joliet Junior  
6 College, Illinois Community College District No. 525.

7           Alcoholic liquors may be delivered to and sold at Triton  
8 College, Illinois Community College District No. 504.

9           Alcoholic liquors may be delivered to and sold at the  
10 College of DuPage, Illinois Community College District No. 502.

11           Alcoholic liquors may be delivered to and sold at the  
12 building located at 446 East Hickory Avenue in Apple River,  
13 Illinois, owned by the Apple River Fire Protection District,  
14 and occupied by the Apple River Community Association if the  
15 alcoholic liquor is sold or dispensed only in connection with  
16 organized functions approved by the Apple River Community  
17 Association for which the planned attendance is 20 or more  
18 persons and if the person or facility selling or dispensing the  
19 alcoholic liquor has provided dram shop liability insurance in  
20 maximum limits so as to hold harmless the Apple River Fire  
21 Protection District, the Village of Apple River, and the Apple  
22 River Community Association from all financial loss, damage,  
23 and harm.

24           Alcoholic liquors may be delivered to and sold at the Sikia  
25 Restaurant, Kennedy King College Campus, located at 740 West  
26 63rd Street, Chicago, and at the Food Services in the Great

1 Hall/Washburne Culinary Institute Department facility, Kennedy  
2 King College Campus, located at 740 West 63rd Street, Chicago,  
3 owned by or under the control of City Colleges of Chicago,  
4 Illinois Community College District No. 508.
