2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Illinois Optometric Practice Act of 1987 is
amended by changing Sections 3 and 9 as follows:

(a) The practice of optometry is defined as the employment 10 of any and all means for the examination, diagnosis, and 11 12 treatment of the human visual system, the human eye, and its appendages without the use of surgery, including but not 13 14 limited to: the appropriate use of ocular pharmaceutical agents; refraction and other determinants of visual function; 15 16 prescribing corrective lenses or prisms; prescribing, 17 dispensing, or management of contact lenses; vision therapy; visual rehabilitation; or any other procedures taught in 18 19 schools and colleges of optometry approved by the Department, and not specifically restricted in this Act, subject to 20 21 demonstrated competency and training as required by the Board, 22 and pursuant to rule or regulation approved by the Board and adopted by the Department. 23

A person shall be deemed to be practicing optometry within 1 2 the meaning of this Act who: (1) In any way presents himself or herself to be 3 qualified to practice optometry. 4 5 (2)Performs refractions or employs any other determinants of visual function. 6 7 (3) Employs any means for the adaptation of lenses or 8 prisms. 9 (4)Prescribes corrective lenses, prisms, vision 10 therapy, visual rehabilitation, or ocular pharmaceutical 11 agents. 12 (5) Prescribes lenses for or manages contact 13 refractive, cosmetic, or therapeutic purposes. (6) Evaluates the need for, or prescribes, low vision 14 15 aids to partially sighted persons. 16 (7)Diagnoses or treats any ocular abnormality, 17 disease, or visual or muscular anomaly of the human eye or visual system. 18 (8) Practices, or offers or attempts to practice, 19 20 optometry as defined in this Act either on his or her own 21 behalf or as an employee of a person, firm, or corporation, 22 whether under the supervision of his or her employer or 23 not. 24 Nothing in this Section shall be interpreted (i) to prevent 25 a person from functioning as an assistant under the direct 26 supervision of a person licensed by the State of Illinois to SB2218 Engrossed - 3 - LRB098 07840 MGM 37923 b

practice optometry or medicine in all of its branches or (ii) 1 2 to prohibit visual screening programs that are conducted without a fee (other than voluntary donations), by charitable 3 organizations acting in the public welfare under 4 the 5 supervision of a committee composed of persons licensed by the 6 State of Illinois to practice optometry or persons licensed by 7 the State of Illinois to practice medicine in all of its 8 branches.

9 (b) When, in the course of providing optometric services to 10 any person, an optometrist licensed under this Act finds an 11 indication of a disease or condition of the eye which in his or 12 her professional judgment requires professional service 13 outside the scope of practice as defined in this Act, he or she 14 shall refer such person to a physician licensed to practice 15 medicine in all of its branches, or other appropriate health 16 care practitioner. Nothing in this Act shall preclude an 17 optometrist from rendering appropriate nonsurgical emergency 18 care.

(c) Nothing contained in this Section shall prohibit a 19 20 person from manufacturing ophthalmic lenses and prisms or the fabrication of contact lenses according to the specifications 21 22 prescribed by an optometrist or a physician licensed to 23 practice medicine in all of its branches, but shall specifically prohibit (1) the sale or delivery of ophthalmic 24 25 lenses, prisms, and contact lenses without a prescription 26 signed by an optometrist or a physician licensed to practice SB2218 Engrossed - 4 - LRB098 07840 MGM 37923 b

medicine in all of its branches and (2) the dispensing of 1 contact lenses by anyone other than a licensed optometrist, 2 3 licensed pharmacist, or a physician licensed to practice medicine in all of its branches. For the purposes of this Act, 4 5 "contact lenses" include, but are not limited to, contact lenses with prescriptive power and decorative and plano power 6 contact lenses. Nothing in this Section shall prohibit the sale 7 of contact lenses by an optical firm or corporation primarily 8 9 engaged in manufacturing or dealing in eyeglasses or contact 10 lenses with an affiliated optometrist who practices and is 11 licensed or has an ancillary registration for the location 12 where the sale occurs.

13 (d) Nothing in this Act shall restrict the filling of a 14 prescription by a pharmacist licensed under the Pharmacy 15 Practice Act.

16 (e) Nothing in this Act shall be construed to restrict the 17 dispensing and sale by an optometrist of ocular devices, such 18 as contact lenses, that contain and deliver ocular 19 pharmaceutical agents permitted for use or prescription under 20 this Act.

10 (6) "Direct supervision" means supervision of anv 11 person assisting an optometrist, requiring that the 12 optometrist authorize the procedure, remain in the 13 facility while the procedure is performed, approve the work 14 performed by the person assisting before dismissal of the 15 patient, but does not mean that the optometrist must be 16 present with the patient, during the procedure. For the 17 dispensing of contact lenses, "direct supervision" means that the optometrist is responsible for training the person 18 19 assisting the optometrist in the dispensing or sale of 20 contact lenses, but does not mean that the optometrist must 21 be present in the facility where he or she practices under 22 a license or ancillary registration at the time the 23 contacts are dispensed or sold.
