## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1 4 Section 1. The following named amounts, or so much 5 6 thereof as may be necessary, respectively, for the objects 7 and purposes hereinafter named, are appropriated to the Board of the Trustees of the University of Illinois to meet 8 ordinary and contingent expenses for the fiscal year ending 9 10 June 30, 2014: Payable from the Education Assistance Fund: 11 12 For Personal Services, including payment 13 to the university for personal services 14 costs incurred during the fiscal year and salaries accrued but unpaid to academic 15 16 personnel for personal services rendered 17 during the academic year 2013-2014 ...........493,468,200 For State Contributions to Social 18 19 20 21

- Section 5. The sum of \$15,095,300, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for costs and expenses related to or in support of the Prairie Research Institute, in accordance with Public Act 95-0728.
- Section 10. The sum of \$45,000,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for operating costs and expenses related to or in support of the University of Illinois Hospital.
- Section 15. The sum of \$716,200, or so much thereof as may be necessary, is appropriated from the Education Assistance Fund to the Board of Trustees of the University of Illinois for costs associated with the Hispanic Center for Excellence at the Chicago campus.
- 21 Section 20. The sum of \$294,000, or so much thereof as

- 1 may be necessary, is appropriated from the Education
- 2 Assistance Fund to the Board of Trustees of the University of
- 3 Illinois for Dixon Springs Agricultural Center.
- 4 Section 25. The sum of \$1,119,000, or so much thereof as
- 5 may be necessary, is appropriated from the Education
- 6 Assistance Fund to the Board of Trustees of the University of
- 7 Illinois for costs associated with the Public Policy
- 8 Institute at the Chicago campus.
- 9 Section 30. The sum of \$313,000, or so much thereof as
- 10 may be necessary, is appropriated from the Education
- 11 Assistance Fund to the Board of Trustees of the University of
- 12 Illinois for a grant to the College of Dentistry.
- 13 Section 35. The sum of \$3,523,700, or so much thereof as
- 14 may be necessary, is appropriated from the Fire Prevention
- 15 Fund to the Board of Trustees of the University of Illinois
- 16 for the purpose of maintaining the Illinois Fire Service
- 17 Institute, paying the Institute's expenses, and providing the
- 18 facilities and structures incident thereto, including payment
- 19 to the University for personal services and related costs
- 20 incurred.
- 21 Section 40. The sum of \$250,000, or so much thereof as

- 1 may be necessary, is appropriated from the State College and
- 2 University Trust Fund to the Board of Trustees of the
- 3 University of Illinois for scholarship grant awards, in
- 4 accordance with Public Act 91-0083.
- 5 Section 45. The sum of \$200,000, or so much thereof as
- 6 may be necessary, is appropriated from the Emergency Public
- 7 Health Fund to the University of Illinois for costs and
- 8 expenses related to or in support of Emergency Mosquito
- 9 Abatement.
- 10 Section 50. The sum of \$200,000, or so much thereof as
- 11 may be necessary, is appropriated from the Used Tire
- 12 Management Fund to the University of Illinois for costs and
- 13 expenses related to or in support of mosquito research and
- 14 abatement.
- 15 Section 55. The sum of \$500,000, or so much thereof as
- 16 may be necessary, is appropriated from the Hazardous Waste
- 17 Research Fund to the University of Illinois for its ordinary
- 18 and contingent expenses.
- 19 Section 99. Effective date. This Act takes effect July 1,
- 20 2013.
