## "ARTICLE 1

6 Section 5. 16 Section 20. The sum of \$1,000,000, or so much thereof as 17 may be necessary, is appropriated from the General Revenue 18 Fund to the Illinois State Board of Education for the 19 Illinois Coalition Immigrant and Refugee Rights' Parent 20 Mentor Program.

21 Section 25. 9 Section 35. The sum of \$350,000, or so much thereof as 10 may be necessary, is appropriated from the General Revenue 11 Fund to the Illinois State Board of Education for targeted 12 initiatives.

Section 40. The amount of \$550,000, or so much thereof as may be necessary, is appropriated from the Downstate Transit Improvement Fund to the Illinois State Board of Education for grants to Local Education Agencies to conduct Agriculture Education Programs.

Section 99. Effective date. This Act takes effect July 19 1, 2013.".
