

1 AN ACT concerning civil law.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Eminent Domain Act is amended by adding
5 Section 25-5-65 as follows:

6 (735 ILCS 30/25-5-65 new)

7 Sec. 25-5-65. Quick-take; Will County; Weber Road.
8 Quick-take proceedings under Article 20 may be used for a
9 period of no more than one year after the effective date of
10 this amendatory Act of the 99th General Assembly by Will County
11 for the acquisition of the following described property for the
12 purpose of expanding the portion of Weber Road (County Highway
13 88) between Normantown Road and West 135th Street:
