#### SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-643

Amends the Illinois Vehicle Code. Provides that all money in the Mammogram Fund from the sale of Mammogram license plates shall be paid as grants to the Illinois Public Health Association (rather than the Susan G. Komen Foundation) for breast cancer research, education, screening, and treatment. Effective immediately.

A BILL FOR

1 AN ACT concerning transportation.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Illinois Vehicle Code is amended by changing  
5 Section 3-643 as follows:

6 (625 ILCS 5/3-643)

7 Sec. 3-643. Mammogram license plates.

8 (a) The Secretary, upon receipt of an application made in  
9 the form prescribed by the Secretary, may issue special  
10 registration plates designated as Mammogram license plates.  
11 The special plates issued under this Section shall be affixed  
12 only to passenger vehicles of the first division and motor  
13 vehicles of the second division weighing not more than 8,000  
14 pounds. Plates issued under this Section shall expire according  
15 to the multi-year procedure established by Section 3-414.1 of  
16 this Code.

17 (b) The design and color of the plates is wholly within the  
18 discretion of the Secretary, except that the following phrases  
19 shall be on the plates: (i) "Mammograms Save Lives" and (ii)  
20 "The Susan G. Komen Foundation". The Secretary may allow the  
21 plates to be issued as vanity plates or personalized under  
22 Section 3-405.1 of the Code. The Secretary shall prescribe  
23 stickers or decals as provided under Section 3-412 of this

1 Code.

2 (c) An applicant for the special plate shall be charged a  
3 \$25 fee for original issuance in addition to the appropriate  
4 registration fee. Of this fee, \$10 shall be deposited into the  
5 Mammogram Fund and \$15 shall be deposited into the Secretary of  
6 State Special License Plate Fund, to be used by the Secretary  
7 to help defray the administrative processing costs.

8 For each registration renewal period, a \$25 fee, in  
9 addition to the appropriate registration fee, shall be charged.  
10 Of this fee, \$23 shall be deposited into the Mammogram Fund and  
11 \$2 shall be deposited into the Secretary of State Special  
12 License Plate Fund.

13 (d) The Mammogram Fund is created as a special fund in the  
14 State treasury. All money in the Mammogram Fund shall be paid,  
15 subject to appropriation by the General Assembly and  
16 distribution by the Secretary, as grants to the Illinois Public  
17 Health Association ~~Susan G. Komen Foundation~~ for breast cancer  
18 research, education, screening, and treatment.
