SYNOPSIS AS INTRODUCED:

735 ILCS 30/25-65 new

Amends the Eminent Domain Act. Provides that quick-take proceedings may be used for a period of no more than one year after the effective date by the Cicero Public School District 99 in Cook County for the acquisition of certain described property for the purpose of early childhood schools. Effective immediately.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Eminent Domain Act is amended by adding
5 Section 25-65 as follows:

6 (735 ILCS 30/25-65 new)

7 Sec. 25-65. Quick-take; Cicero Public School District 99.
8 Quick-take proceedings under Article 20 may be used for a
9 period of no more than one year after the effective date of
10 this amendatory Act of the 99th General Assembly by the Cicero
11 Public School District 99 in Cook County for the acquisition of
12 the following described property for the purpose of early
13 childhood schools:
