A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The sum of \$0, or so much thereof as may be
6 necessary, is appropriated to the Illinois Student Assistance
7 Commission from the General Revenue Fund for costs associated
8 with marketing for the College Illinois! Prepaid Tuition
9 Program.

10 Section 10. The following named amount, or so much
11 thereof as may be necessary, is appropriated from the General
12 Revenue Fund to the Illinois Student Assistance Commission
13 for the following purpose:

14 To support outreach, research, and
15 training activities3,200,000

16 Section 15. In addition to any other sums appropriated,
17 the sum of \$1,000,000, or so much thereof as may be
18 necessary, is appropriated from the General Revenue Fund to
19 the Illinois Student Assistance Commission for operational

1 expenses during the fiscal year ending June 30, 2017.

2 Section 20. The sum of \$364,856,300, or so much thereof
3 as may be necessary, is appropriated to the Illinois Student
4 Assistance Commission from the General Revenue Fund for grant
5 awards to students eligible for the Monetary Award Program,
6 as provided by law, and for agency administrative and
7 operational costs not to exceed 2 percent of the total
8 appropriation in this Section.

9 Section 25. The sum of \$25,000, or so much thereof as
10 may be necessary, is appropriated from the Education
11 Assistance Fund to the Illinois Student Assistance Commission
12 for costs associated with the Veterans' Home Nurses' Loan
13 Repayment Program pursuant to Public Act 95-0576.

14 Section 30. The sum of \$293,300, or so much thereof as
15 may be necessary, is appropriated from the Education
16 Assistance Fund to the Illinois Student Assistance Commission
17 for grants to eligible nurse educators to use for payment of
18 their educational loan pursuant to Public Act 94-1020.

19 Section 35. The following named sums, or so much thereof
20 as may be necessary, respectively, are appropriated from the
21 Education Assistance Fund to the Illinois Student Assistance

1 Commission for the following purposes:

2 Grants and Scholarships

3 For the payment of scholarships to students
 4 who are children of policemen or firemen
 5 killed in the line of duty, or who are
 6 dependents of correctional officers killed
 7 or permanently disabled in the line of
 8 duty, as provided by law1,105,200

9 For payment of Minority Teacher Scholarships1,900,000

10 Total \$3,005,200

11 Section 40. The sum of \$3,323,800, or so much thereof as
 12 may be necessary, is appropriated from the Education
 13 Assistance Fund to the Illinois Student Assistance Commission
 14 to the Golden Apple Scholars of Illinois program, as provided
 15 by law.

16 Section 45. The sum of \$496,400, or so much thereof as
 17 may be necessary, is appropriated from the Education
 18 Assistance Fund to the Illinois Student Assistance Commission
 19 for the Loan Repayment for Teachers Program.

20 Section 50. The sum of \$300,000, or so much thereof as
 21 may be necessary, is appropriated from the ISAC Accounts
 22 Receivable Fund to the Illinois Student Assistance Commission

1 for costs associated with the collection of delinquent
2 scholarship awards pursuant to the Illinois State Collection
3 Act of 1986.

4 Section 55. The sum of \$110,000, or so much thereof as
5 may be necessary, is appropriated to the Illinois Student
6 Assistance Commission from the University Grant Fund for
7 payment of grants for the Higher Education License Plate
8 Program, as provided by law.

9 Section 60. The following named sum, or so much thereof
10 as may be necessary, is appropriated from the Illinois
11 Student Assistance Commission Contracts and Grants Fund to
12 the Illinois Student Assistance Commission for the following
13 purpose:

14 To support outreach, research, and
15 training activities10,000,000

16 Section 65. The following named sum, or so much thereof
17 as may be necessary, is appropriated from the Optometric
18 Licensing and Disciplinary Board Fund to the Illinois Student
19 Assistance Commission for the following purpose:

20 Grants and Scholarships
21 For payment of scholarships for the
22 Optometric Education Scholarship

1 Program, as provided by law50,000

2 Section 70. The following named sum, or so much thereof
3 as may be necessary, is appropriated from the National Guard
4 and Naval Militia Grant Fund to the Illinois Student
5 Assistance Commission for the following purpose:

6 Grants and Scholarships

7 For payment of Illinois National Guard and
8 Naval Militia Scholarships
9 at State-controlled universities
10 and public community colleges in
11 Illinois to students eligible to
12 receive such awards, as provided by law20,000

13 Section 75. The sum of \$225,000, or so much thereof as
14 may be necessary, is appropriated from the Golden Apple
15 Scholars of Illinois Fund to the Illinois Student Assistance
16 Commission for the Golden Apple Scholars of Illinois Program,
17 as provided by law.

18 Section 80. The following named sums, or so much thereof
19 as may be necessary, respectively, are appropriated to the
20 Illinois Student Assistance Commission from the Student Loan
21 Operating Fund for its ordinary and contingent expenses:

16 Section 85. The sum of \$2,500,000, or so much thereof as
17 may be necessary, is appropriated to the Illinois Student
18 Assistance Commission from the Student Loan Operating Fund
19 for costs associated with Federal Loan System Development and
20 Maintenance.

21 Section 90. The sum of \$1,000,000 or so much thereof as
22 may be necessary, is appropriated to the Illinois Student
23 Assistance Commission from the Student Loan Operating Fund

1 for costs associated with the Illinois Designated Account
2 Purchase Program.

3 Section 95. The sum of \$15,000,000, or so much thereof
4 as may be necessary, is appropriated to the Illinois Student
5 Assistance Commission from the Student Loan Operating Fund
6 for distribution as necessary for the following: for payment
7 of collection agency fees associated with collection
8 activities for Federal Family Education Loans, for Default
9 Aversion Fee reversals, and for distributions as necessary
10 and provided for under the Federal Higher Education Act.

11 Section 100. The following named sum, or so much thereof
12 as may be necessary, is appropriated from the Federal
13 Congressional Teacher Scholarship Program Fund to the
14 Illinois Student Assistance Commission for the following
15 purpose:

16 For transferring repayment funds collected
17 under the Paul Douglas Teacher Scholarship
18 Program to the U.S. Treasury400,000

19 Section 105. The sum of \$260,000,000, or so much thereof
20 as may be necessary, is appropriated from the Federal Student
21 Loan Fund to the Illinois Student Assistance Commission for
22 distribution when necessary as a result of the following: for

1 guarantees of loans that are uncollectible, for collection
2 payments to the Student Loan Operating Fund as required under
3 agreements with the United States Secretary of Education, for
4 payment to the Student Loan Operating Fund for Default
5 Aversion Fees, for transfers to the U.S. Treasury, or for
6 other distributions as necessary and provided for under the
7 Federal Higher Education Act.

8 Section 110. The sum of \$15,000,000, or so much thereof
9 as may be necessary, is appropriated from the Federal Student
10 Incentive Trust Fund to the Illinois Student Assistance
11 Commission for allowable uses of federal grant funds related
12 to college access, outreach, and training, including but not
13 limited to funds received under the federal College Access
14 Challenge Grant Program.

15 Section 115. The sum of \$500,000, or so much thereof as
16 may be necessary, is appropriated from the Federal Student
17 Incentive Trust Fund to the Illinois Student Assistance
18 Commission for the John R. Justice Student Loan Repayment
19 Program.

20 Section 999. Effective date. This Act takes effect July 1,
21 2016, if and only if Senate Bill 2789 of the 99th General
22 Assembly (the Unbalanced Budget Response Act), as introduced

1 in the Illinois Senate, becomes law.
