- 20 (2) Has (i) served on active duty in the armed forces
- 21 for one year for purposes of eligibility for domiciliary care
- 22 only or (ii) served in the National Guard or Reserve Forces

- 1 of the United States and completed 20 years of satisfactory
- 2 <u>service</u>, is otherwise eligible to receive reserve or active
- 3 <u>duty retirement benefits, and has been an Illinois resident</u>
- 4 for at least one year before applying for admission for

- 6 (b) Has service accredited to the State of Illinois or
