AN ACT concerning taxation.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

Section 5. The Property Tax Code is amended by changing
Section 18-101.35 as follows:

6 (35 ILCS 200/18-101.35)

(Section scheduled to be repealed on January 1, 2003) 7 8 Sec. 18-101.35. Time and form of notice. The notice shall appear not more than 14 days nor less than 7 days 9 before the date of the public hearing. The notice shall be no 10 less than one-eighth page in size, and the smallest type used 11 shall be 12 point and shall be enclosed in a black border no 12 13 less than one-quarter inch wide. The notice shall not be placed in that portion of the newspaper where legal notices 14 15 and classified advertisements appear. The notice shall be 16 published in the following form:

Notice of Proposed Property Tax Levy for ... (commonlyknown name of taxing district).
