1 AN ACT concerning criminal law.

2 Be it enacted by the People of the State of Illinois,
3 represented in the General Assembly:

4 Section 5. The Code of Criminal Procedure of 1963 is
5 amended by changing Section 110-10 as follows:

6 (725 ILCS 5/110-10) (from Ch. 38, par. 110-10)

7 Sec. 110-10. Conditions of bail bond.

8 (a) If a person is released prior to conviction, either 9 upon payment of bail security or on his or her own 10 recognizance, the conditions of the bail bond shall be that 11 he or she will:

12 (1) Appear to answer the charge in the court having 13 jurisdiction on a day certain and thereafter as ordered 14 by the court until discharged or final order of the 15 court;

16 (2) Submit himself or herself to the orders and17 process of the court;

18 (3) Not depart this State without leave of the19 court;

20 (4) Not violate any criminal statute of any 21 jurisdiction;

22 (5) At a time and place designated by the court, surrender all firearms in his or her possession to a law 23 enforcement officer designated by the court to take 24 custody of and impound the firearms when the offense the 25 person has been charged with is a forcible felony, 26 27 stalking, aggravated stalking, domestic battery, any violation of either the Illinois Controlled Substances 28 Act or the Cannabis Control Act that is classified as a 29 Class 2 or greater felony, or any felony violation of 30 Article 24 of the Criminal Code of 1961; the court may, 31

1 however, forgo the imposition of this condition when the 2 circumstances of the case clearly do not warrant it or when its imposition would be impractical; all legally 3 4 possessed firearms shall be returned to the person upon that person completing a sentence for a conviction on a 5 misdemeanor domestic battery, upon the charges being 6 7 dismissed, or if the person is found not guilty, unless the finding of not guilty is by reason of insanity; and 8

9 (6) At a time and place designated by the court, submit to a psychological evaluation when the person has 10 11 been charged with a violation of item (4) of subsection (a) of Section 24-1 of the Criminal Code of 1961 and that 12 13 violation occurred in a school or in any conveyance owned, leased, or contracted by a school to transport 14 15 students to or from school or a school-related activity, 16 or on any public way within 1,000 feet of real property 17 comprising any school.

Psychological evaluations ordered pursuant 18 to this Section shall be completed promptly and made available to the 19 State, the defendant, and the court. As a further condition 20 21 of bail under these circumstances, the court shall order the 22 defendant to refrain from entering upon the property of the 23 school, including any conveyance owned, leased, or contracted by a school to transport students to or from school or a 24 25 school-related activity, or on any public way within 1,000 feet of real property comprising any school. Upon receipt of 26 psychological evaluation, either the State or the 27 the defendant may request a change in the conditions of bail, 28 pursuant to Section 110-6 of this Code. The court may change 29 30 the conditions of bail to include a requirement that the defendant follow the recommendations of the psychological 31 evaluation, including undergoing psychiatric treatment. 32 The 33 conclusions of the psychological evaluation and any 34 statements elicited from the defendant during its

administration are not admissible as evidence of guilt during
 the course of any trial on the charged offense, unless the
 defendant places his or her mental competency in issue.

4 (b) The court may impose other conditions, such as the 5 following, if the court finds that such conditions are 6 reasonably necessary to assure the defendant's appearance in 7 court, protect the public from the defendant, or prevent the 8 defendant's unlawful interference with the orderly 9 administration of justice:

(1) Report to or appear in person before such person or agency as the court may direct;

12 (2) Refrain from possessing a firearm or other13 dangerous weapon;

14 (3) Refrain from approaching or communicating with
15 particular persons or classes of persons;

16 (4) Refrain from going to certain described 17 geographical areas or premises;

18 (5) Refrain from engaging in certain activities or
 19 indulging in intoxicating liquors or in certain drugs;

20 (6) Undergo treatment for drug addiction or 21 alcoholism;

(7) Undergo medical or psychiatric treatment;

23 (8) Work or pursue a course of study or vocational
24 training;

25 (9) Attend or reside in a facility designated by 26 the court;

27

(10) Support his or her dependents;

(11) If a minor resides with his or her parents or
in a foster home, attend school, attend a non-residential
program for youths, and contribute to his or her own
support at home or in a foster home;

32 (12) Observe any curfew ordered by the court;
33 (13) Remain in the custody of such designated
34 person or organization agreeing to supervise his release.

1 Such third party custodian shall be responsible for 2 notifying the court if the defendant fails to observe the 3 conditions of release which the custodian has agreed to 4 monitor, and shall be subject to contempt of court for 5 failure so to notify the court;

6 (14) Be placed under direct supervision of the 7 Pretrial Services Agency, Probation Department or Court 8 Services Department in a pretrial bond home supervision 9 capacity with or without the use of an approved 10 electronic monitoring device subject to Article 8A of 11 Chapter V of the Unified Code of Corrections;

(14.1) The court shall impose upon a defendant who 12 is charged with any alcohol, cannabis or controlled 13 substance violation and is placed under direct 14 15 supervision of the Pretrial Services Agency, Probation 16 Department or Court Services Department in a pretrial bond home supervision capacity with the use of an 17 approved monitoring device, as a condition of such bail 18 19 bond, a fee that represents costs incidental to the electronic monitoring for each day of 20 such bail the court, unless after 21 supervision ordered by determining the inability of the defendant to pay the 22 23 fee, the court assesses a lesser fee or no fee as the case may be. The fee shall be collected by the clerk of 24 25 the circuit court. The clerk of the circuit court shall pay all monies collected from this fee to the county 26 treasurer for deposit in the substance abuse services 27 fund under Section 5-1086.1 of the Counties Code; 28

(14.2) The court shall impose upon all defendants,
including those defendants subject to paragraph (14.1)
above, placed under direct supervision of the Pretrial
Services Agency, Probation Department or Court Services
Department in a pretrial bond home supervision capacity
with the use of an approved monitoring device, as a

1 condition of such bail bond, a fee which shall represent 2 costs incidental to such electronic monitoring for each day of such bail supervision ordered by the court, unless 3 4 after determining the inability of the defendant to pay the fee, the court assesses a lesser fee or no fee as the 5 case may be. The fee shall be collected by the clerk of 6 the circuit court. The clerk of the circuit court shall 7 pay all monies collected from this fee to the county 8 9 treasurer who shall use the monies collected to defray the costs of corrections. The county treasurer shall 10 11 deposit the fee collected in the county working cash fund under Section 6-27001 or Section 6-29002 of the Counties 12 13 Code, as the case may be;

(14.3) Refrain from operating a motor vehicle not 14 15 equipped with an ignition interlock device, as defined in 16 Section 1-129.1 of the Illinois Vehicle Code, pursuant to 17 the rules promulgated by the Secretary of State for the installation of ignition interlock devices. Under this 18 condition the court may allow a defendant who is not 19 self-employed to operate a vehicle owned by the 20 defendant's employer that is not equipped with an 21 22 ignition interlock device in the course and scope of the 23 defendant's employment;

(15) Comply with the terms and conditions of an
order of protection issued by the court under the
Illinois Domestic Violence Act of 1986 or an order of
protection issued by the court of another state, tribe,
or United States territory;

1 "Criminal Code of 1961", involving a victim who is a minor 2 under 18 years of age living in the same household with the defendant at the time of the offense, in granting bail or 3 4 releasing the defendant on his own recognizance, the judge shall impose conditions to restrict the defendant's access to 5 6 the victim which may include, but are not limited to 7 conditions that he will:

1. Vacate the Household.

9 2. Make payment of temporary support to his dependents. 10

11

3. Refrain from contact or communication with the child victim, except as ordered by the court. 12

When a person is charged with a criminal offense and 13 (d) the victim is a family or household member as defined in 14 15 Article 112A, conditions shall be imposed at the time of the 16 defendant's release on bond that restrict the defendant's access to the victim. Unless provided otherwise by the court, 17 the restrictions shall include requirements that the 18 19 defendant do the following:

(1) refrain from contact or communication with the 20 victim for a minimum period of 72 hours following the 21 22 defendant's release; and

23 (2) refrain from entering or remaining at the victim's residence for a minimum period of 72 hours 24 25 following the defendant's release.

26 (e) Local law enforcement agencies shall develop standardized bond forms for use in cases involving family or 27 household members as defined in Article 112A, including 28 specific conditions of bond as provided in subsection (d). 29 30 Failure of any law enforcement department to develop or use those forms shall in no way limit the applicability and 31 enforcement of subsections (d) and (f). 32
