Be it enacted by the People of the State of Illinois,represented in the General Assembly:

## ARTICLE 1

5 Section 1. Section 3. The sum of \$1,050,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Arts Council for the purpose of funding administrative and grant expenses associated with humanities programs and related activities.

Section 4. The amount of \$384,500, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Arts Council for grants to certain public radio and television stations for operating costs.

23 Section 5. The amount of \$5,181,800, or so much thereof 24 as may be necessary is appropriated from the General Revenue 25 Fund to the Illinois Arts Council for grants to certain 26 public radio and television stations and related 27 administrative expenses, pursuant to the Public Radio and 28 Television Grant Act.

29 Section 99. Effective date. This Act takes effect on 30 July 1, 2002.
