- 4 Section 5. The Southwestern Illinois Development
- 5 Authority Act is amended by changing Section 11.1 as follows:

- 7 Sec. 11.1. (a) No member of the Authority or officer,
- 8 agent, or employee of the Authority shall, in his or her own
