

1 AMENDMENT TO SENATE BILL 991

2 AMENDMENT NO. _____. Amend Senate Bill 991 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. Upon the payment of any sum required by the
5 Cook County Forest Preserve District, and subject to the
6 conditions set forth in Section 10 of this Act, the Cook
7 County Forest Preserve is authorized to convey by quitclaim
8 deed all of its right, title, and interest in and to the
9 following described lands in Cook County, Illinois:

10 PARCEL A

11 Lot 46, 47, and 48 in block 6 in Indian Highlands, a
12 subdivision of all that part of the west 225 acres of the
13 north 32/80ths of the north Section of Robinson's Reserve
14 in Township 40 North, Range 12 East of the Third
15 Principal Meridian, lying east of a line as follows:
16 Beginning at a point on the North line of the North
17 Section 40.05 chains east of the Northwest corner of the
18 North Section running thence South 22 1/4 degrees East
19 4.40 chains; thence South 63 1/2 degrees West 11.73
20 chains; thence North 55 1/2 degrees West 4.80 chains;
21 thence South 35 1/2 degrees West 3.57 chains; thence
22 North 79 degrees West 5.30 chains; thence South 2 degrees
23 East 24.15 chains to the South line of said North

1 32/80ths of North Section, Cook County, Illinois.

3 PARCEL B

4 That portion lying northwest of the northwesterly right
5 of way line of the Chicago, Rock Island and Pacific Railway
6 of the property described as follows:

7 The West half (W. 1/2)(except therefrom the right of way
8 of the Chicago Rock Island and Pacific Railroad) of Lot 2
9 in Assessor's Division of the Northeast quarter (N.E.
10 1/4) of Section Twenty nine (29), Township Thirty-six
11 (36) North, Range Thirteen (13) East of the Third
12 Principal Meridian, in Cook County, Illinois.

14 PARCEL C

15 That part of Lot Four (4) of partition between the
16 children of Hans Johann Schrum (also known as John
17 Schrum, deceased) of lands left by him in Fractional
18 Section 20 and 29, Township 36 North, Range 15 East of
19 the Third Principal Meridian, lying west of Wentworth
20 Avenue and South of a line 50 feet South of and parallel
21 to the following described line: Commencing at a cross
22 notch in the center line of the pavement of Wentworth
23 Avenue, which is 204.5 feet South of the North line of
24 the South 1/2 of the Northeast Fractional Quarter of Said
25 Section 20; running thence westerly on a curve having a
26 radius of 1766.84 feet and being convex to the south and
27 being tangent to a line forming an angle of 90 degrees
28 and 9 minutes to the northeast with the center line of
29 said Wentworth Avenue, in Cook County, Illinois.

30 Also, that portion lying south of the south right of way
31 line of River Oaks Drive of the property described as
32 follows:

33 That part of Section 20, Township 36 North, Range 15 East
34 of the Third Principal Meridian Described as follows:

1 Commencing at a point 12.303 chains East of the Northwest
 2 corner of the East 1/2 of the Northwest 1/4 of Section 20
 3 aforesaid; thence running east 8.994 chains; thence south
 4 20 chains; thence west 2.50 chains; running thence south
 5 363.4 feet, more or less, to the center line of Prairie
 6 or Ridge Road (Schrum Road); running thence Northwesterly
 7 in the center of said Road to a point due south of the
 8 place of beginning, running thence north 1458.7 feet,
 9 more or less, to the point of beginning, in Cook County,
 10 Illinois.

13 PARCEL E

14 That portion of the East 1/2 of the Southeast 1/4 of
 15 Section 35, Township 40 North, Range 12 East of the Third
 16 Principal Meridian lying northeasterly of the
 17 northeasterly right of way line of Thatcher Avenue in
 18 Cook County, Illinois.

19 Permanent Index Number: Part of 12-3 5-400-003

20 PARCEL F

21 That portion of the East 1/2 of the West 1/2 of
 22 Fractional Section 1 of Township 41 North, Range 9 East
 23 of the Third Principal Meridian lying north of the 240
 24 foot wide right of way of Higgins Road (Route 72), except
 25 that part thereof conveyed to the Illinois State Toll
 26 Highway Commission by deed recorded April 25, 1957 as
 27 document number 16887105, and also except that part
 28 conveyed to The Northern Illinois Gas Company by deed
 29 recorded December 3, 1958 as document number 17393730 in
 30 Cook County, Illinois.

32 Section 10. The Cook County Forest Preserve District
 33 shall obtain a certified copy of the portions of this Act

1 containing the title, the enacting clause, the effective
2 date, Section 5, and this Section within 60 days after its
3 effective date and upon receipt of the required payment, if
4 payment is required, shall record the certified document in
5 the Recorder's Office in Cook County.

6 Section 99. Effective date. This Act takes effect upon
7 becoming law.".
