- Be it enacted by the People of the State of Illinois, 2
- 3 represented in the General Assembly:
- The Illinois Vehicle Code is amended by 4 Section 5.
- changing Section 4-107 as follows: 5
- б (625 ILCS 5/4-107) (from Ch. 95 1/2, par. 4-107)
- Sec. 4-107. Stolen, converted, recovered and unclaimed 7
- 8 vehicles.
- (a) Every Sheriff, Superintendent of police, Chief of 9
- police or other police officer in command of any Police 10
- department in any City, Village or Town of the State, shall, 11
- by the fastest means of communications available to his 12
- 13 enforcement agency, immediately report to the State Police,
- in Springfield, Illinois, the theft or recovery of any stolen 14
- 15 or converted vehicle within his district or jurisdiction.
- 16 The report shall give the date of theft, description of the
- vehicle including color, year of manufacture, manufacturer's 17
- 18 trade name, manufacturer's series name, body style, vehicle
- 19 identification number and license registration number,
- year of issuance, together with the name, residence address,

including the state in which the license was issued and the

- business address, and telephone number of the owner.
- report shall be routed by the originating law enforcement
- agency through the State Police District in which such agency

- (b) A registered owner or a lienholder may report the 26
- 27 theft by conversion of a vehicle, to the State Police, or any
- other police department or Sheriff's office. Such report 28
- 29 will be accepted as a report of theft and processed only if a
- formal complaint is on file and a warrant issued. 30
- (c) An operator of a place of business for garaging, 31

- repairing, parking or storing vehicles for the public, 1
- 2 which a vehicle remains unclaimed, after being left for the
- purpose of garaging, repairing, parking or storage, for a 3
- 4 period of 15 days, shall, within 5 days after the expiration
- of that period, report the vehicle as unclaimed to the 5
- 6 municipal police when the vehicle is within the corporate

- Failure to comply with this Section will result in 17 the
- 18 forfeiture of storage fees for that vehicle involved.
- 19 The State Police shall keep a complete record of all
- reports filed under this Section of the Act. Upon receipt of 20
- 2.1 such report, a careful search shall be made of the records
- of the office of the State Police, and where it is found that 22
- 23 a vehicle reported recovered was stolen in a County, City,

Village or Town other than the County, City, Village or Town

office or Police department of the County, City, Village or

Notification of the recovery of a vehicle previously reported as a theft or a conversion 3 4 will be furnished to the Secretary of State by the State 5 Police. The Secretary of State shall remove the proper 6 information from the license registration and title 7 registration files that has previously indicated the theft or 8 conversion of a vehicle. The Secretary of State shall 9 suspend the registration of a vehicle upon receipt of a report from the State Police that such vehicle was stolen or 10 converted. 11
- (f) When the Secretary of State receives an application 12 for a certificate of title or an application for registration 13 of a vehicle and it is determined from the records of 14 office of the Secretary of State that such vehicle has been 15 16 reported stolen or converted, the Secretary of State shall immediately notify the State Police and shall give the State 17 18 Police the name and address of the person or firm titling or 19 registering the vehicle, together with all other information contained in the application submitted by such person or 20 21 firm.
 - (g) During the usual course of business the manufacturer of any vehicle shall place an original manufacturer's vehicle identification number on all such vehicles manufactured and on any part of such vehicles requiring an identification number.

If a manufacturer's vehicle identification number is 27 (h) missing or has been removed, changed or mutilated on any 28 29 vehicle, or any part of such vehicle requiring identification number, the State Police shall restore, 30 restamp or reaffix the vehicle identification number plate, 31 32 or affix a new plate bearing the original manufacturer's vehicle identification number on each such vehicle and on all 33 necessary parts of the vehicles. A vehicle identification 34

- 1 number so affixed, restored, restamped, reaffixed or replaced
- 2 is not falsified, altered or forged within the meaning of
- 3 this Act.
- 4 (i) If a vehicle or part of any vehicle is found to have
- 5 the manufacturer's identification number removed, altered,
- 6 defaced or destroyed, the vehicle or part shall be seized by
- 7 any law enforcement agency having jurisdiction and held for
- 8 the purpose of identification. In the event that the
- 9 manufacturer's identification number of a vehicle or part
- 10 cannot be identified, the vehicle or part shall be considered
- 11 contraband, and no right of property shall exist in any
- 12 person owning, leasing or possessing such property, unless
- the person owning, leasing or possessing the vehicle or part
- 14 acquired such without knowledge that the manufacturer's
- 15 vehicle identification number has been removed, altered,
- 16 defaced, falsified or destroyed.
- 17 Either the seizing law enforcement agency or the State's
- 18 Attorney of the county where the seizure occurred may make an
- 19 application for an order of forfeiture to the circuit court
- 20 in the county of seizure. The application for forfeiture
- 21 shall be independent from any prosecution arising out of the
- 22 seizure and is not subject to any final determination of such
- 23 prosecution. The circuit court shall issue an order
- 25 if the court finds that the property did not at the time of

forfeiting the property to the seizing law enforcement agency

- 26 seizure possess a valid manufacturer's identification number

- 6 (j) The State Police shall notify the Secretary of State
- 7 each time a manufacturer's vehicle identification number is
- 8 affixed, reaffixed, restored or restamped on any vehicle.
- 9 The Secretary of State shall make the necessary changes or
- 10 corrections in his records, after the proper applications and
- 11 fees have been submitted, if applicable.
- 12 (k) Any vessel, vehicle or aircraft used with knowledge
- and consent of the owner in the commission of, or in the
- 14 attempt to commit as defined in Section 8-4 of the Criminal

- 29 The law enforcement agency shall not retain, sell or
- 30 dispose of a vehicle under paragraphs (2) or (3) of this
- 31 subsection (k) except upon an order of forfeiture issued by
- 32 the circuit court. The circuit court may issue such order of
- 33 forfeiture upon application of the law enforcement agency or
- 34 State's Attorney of the county where the law enforcement

- 1 agency has jurisdiction, or in the case of the Department of
- 2 State Police or the Secretary of State, upon application of
- 3 the Attorney General.
- 4 The court shall issue the order if the owner of the
- 5 vehicle has been convicted of transporting stolen vehicles or

- 7 owner's vehicle has been used in the commission of such
- 8 offense.
- 9 The provisions of subsection (k) of this Section shall
- 10 not apply to any vessel, vehicle or aircraft, which has been
- 11 leased, rented or loaned by its owner, if the owner did not
- 12 have knowledge of and consent to the use of the vessel,
- vehicle or aircraft in the commission of, or in an attempt to
- 14 commit, an offense prohibited by Section 4-103 of this
- 15 Chapter.
