was circulated, or (3) certifying that none of the signatures on the sheet were signed more than 90 days preceding the last day for the filing of the petition, --er--mere--than--45--days preceding-the-last-day-for-filing-of-the-petition-in-the-case of--political--party-and-independent-candidates-for-single-or multi-county-regional-superintendents-of-schools-in-the--1994 general--primary-election; -and-certifying-that-the-signatures on-the-sheet-are-genuine, and certifying that to the best of his or her knowledge and belief the persons so signing were at the time of signing the petitions qualified voters of the political party for which a nomination is sought. No petition sheet shall be circulated more than 90 days preceding the last day provided in Section 7-12 for the filing of such petition, -er-mere-than-45-days--preceding--the last--day-fer-filing-ef-the-petitien-in-the-case-ef-pelitical party-and-independent-candidates-fer-single--er--multi-county regional--superintendents--ef--schools--in--the--1994-general primary-election.

The person circulating the petition, or the candidate on whose behalf the petition is circulated, may strike any signature from the petition, provided that: $\dot{\tau}$ 

- (1) the person striking the signature shall initial the petition at the place where the signature is struck; and
- (2) the person striking the signature shall sign a certification listing the page number and line number of each signature struck from the petition. Such certification shall be filed as a part of the petition.

Such sheets before being filed shall be neatly fastened together in book form, by placing the sheets in a pile and fastening them together at one edge in a secure and suitable manner, and the sheets shall then be numbered consecutively.

1 The sheets shall not be fastened by pasting them together end 2 to end, so as to form a continuous strip or roll. petition sheets which are filed with the proper local 3 4 election officials, election authorities or the State Board 5 of Elections shall be the original sheets which have been 6 signed by the voters and by the circulator thereof, and not 7 photocopies or duplicates of such sheets. Each petition must include as a part thereof, a statement of candidacy for each 8 of the candidates filing, or in whose behalf the petition is 9 filed. Such petitions for nominations shall be signed:

- (a) If for a State office, or for delegate or alternate delegate to be elected from the State at large to a National nominating convention by not less than 5,000 nor more than 10,000 primary electors of his party.
- (b) If for a congressional officer or for delegate or alternate delegate to be elected from a congressional district to a national nominating convention by at least .5% of the qualified primary electors of his party in his congressional district, except that for the first primary following a redistricting of congressional districts such petitions shall be signed by at least 600 qualified primary electors of the candidate's party in his congressional district.
- for a county office (including county board (c) If member and chairman of the county board where elected from the county at large), by at least .5% of the qualified electors of his party cast at the last preceding general election in his county. However, if for the nomination for county commissioner of Cook County, then by at least .5% of the qualified primary electors of his or her party in his or her county in the district or division in which such person is a candidate for nomination; and if for county board member from a county board district, then by at least .5% of the qualified primary electors of his party in the county board district. In the case of an election for county board member to be elected from a district, for the first primary following a redistricting of county board districts or the initial establishment of county board districts, then by at least .5% of the qualified electors of his party in the entire county at the last preceding general election, divided by the number of county board districts, but in any event not less than 25 qualified

primary electors of his party in the district.

- (d) If for a municipal or township office by at least .5% of the qualified primary electors of his party in the municipality or township; if for alderman, by at least .5% of the voters of his party of his ward. In the case of an election for alderman or trustee of a municipality to be elected from a ward or district, for first primary following a redistricting or initial establishment of wards or districts, then by of the total number of votes cast for the candidate of such political party who received the highest number of votes in the entire municipality at the last regular election at which an officer was regularly scheduled to be elected from the entire municipality, divided by the number of wards or districts, but in any event not less than 25 qualified primary electors of his party in the ward or district.
- (e) If for State central committeeman, by at least 100 of the primary electors of his or her party of his or her congressional district.
- (f) If for a candidate for trustee of a sanitary district in which trustees are not elected from wards, by at least .5% of the primary electors of his party, from such sanitary district.
- (g) If for a candidate for trustee of a sanitary district in which the trustees are elected from wards, by at least .5% of the primary electors of his party in his ward of such sanitary district, except that for the first primary following a reapportionment of the district such petitions shall be signed by at least 150 qualified primary electors of the candidate's ward of such sanitary district.
- (h) <u>If</u> The--number--of--signatures--required for a candidate for judicial office in a district, circuit, or

subcircuit, by a number of primary electors at least equal to shall-be 0.25% of the number of votes cast for the judicial candidate of his or her political party who received the highest number of votes at the last regular general election at which a judicial officer from the same district, circuit, or subcircuit was regularly scheduled to be elected, but in no event fewer shall-be less than 500 signatures.

- (i) If for a candidate for precinct committeeman, by at least 10 primary electors of his or her party of his or her precinct; if for a candidate for ward committeeman, by not less than 10% nor more than 16% (or 50 more than the minimum, whichever is greater) of the primary electors of his party of his ward; if for a candidate for township committeeman, by not less than 5% nor more than 8% (or 50 more than the minimum, whichever is greater) of the primary electors of his party in his township or part of a township as the case may be.
- (j) If for a candidate for State's Attorney or Regional Superintendent of Schools to serve 2 or more counties, by at least .5% of the primary electors of his party in the territory comprising such counties.
- (k) If for any other office by at least .5% of the total number of registered voters of the political subdivision, district or division for which the nomination is made or a minimum of 25, whichever is greater.

For the purposes of this Section the number of primary electors shall be determined by taking the total vote cast, in the applicable district, for the candidate for such political party who received the highest number of votes, state-wide, at the last general election in the State at which electors for President of the United States were elected. For political subdivisions, the number of primary

- 1 electors shall be determined by taking the total vote cast
- 2 for the candidate for such political party who received the
- 3 highest number of votes in such political subdivision at the
- 4 last regular election at which an officer was regularly

Whoever forges any name signer upon any petition shall be deemed guilty of a forgery, 5 6 and on conviction thereof, shall be punished accordingly. 7 The word "petition" or "petition for nomination", as used 8 shall mean what is sometimes known as nomination 9 papers, in distinction to what is known as a certificate of nomination. The words "political division for which the 10 candidate is nominated", or its equivalent, shall mean the 11 largest political division in which all qualified voters may 12 vote upon such candidate or candidates, as the state in 13 case of state officers; the township in the case of township 14 officers et cetera. Provided, further, that no person shall 15 16 circulate or certify petitions for candidates of more than one political party, or for an independent candidate or 17 candidates in addition to one political party, to be voted 18 19 upon at the next primary or general election, or for such 20 candidates and parties with respect to the same political 21 subdivision at the next consolidated election.

Sec. 28-3. Form of petition for public question. Petitions for the submission of public questions shall consist of sheets of uniform size and each sheet shall contain, above the space for signature, an appropriate heading, giving the information as to the question of public policy to be submitted, and specifying the state at large or the political subdivision or district or precinct or combination of precincts or other territory in which it is to be submitted and, where by law the public question must be submitted at a particular election, the election at which it

1 is to be submitted. In the case of a petition for the 2 submission of a public question described in subsection (b) Section 28-6, the heading shall also specify the regular 3 4 election at which the question is to be submitted and include 5 the precincts included in the territory concerning which the 6 public question is to be submitted, as well as a common 7 description of such territory in plain and nonlegal language, 8 such description to describe the territory by reference to 9 streets, natural or artificial landmarks, addresses or any other method which would enable a voter signing the petition 10 11 to be informed of the territory concerning which the question is to be submitted. The heading of each sheet shall be the 12 same. Such petition shall be signed by the registered voters 13 of the political subdivision or district or precinct or 14 15 combination of precincts in which the question of public 16 policy is to be submitted in their own proper persons only, and opposite the signature of each signer his residence 17 18 address shall be written or printed, which residence address shall include the street address or rural route number of the 19 20 signer, as the case may be, as well as the signer's county, 2.1 and city, village or town, and state; provided that the 22 county or city, village or town, and state of residence of 23 such electors may be printed on the petition forms where all of the such electors signing the petition reside in the same 24 25 county or city, village or town, and state. abbreviations may be used in writing the residence address, 26 27 including street number, if any. No signature shall be valid or be counted in considering the validity or sufficiency of 28 29 such petition unless the requirements of this Section are 30 complied with. At the bottom of each sheet of such petition shall be 31 32 added a <u>circulator's</u> statement, signed by a <u>person 18 years</u> 33 of age or older who is a citizen of the United States

Such statement shall be sworn to before some 14 15 officer authorized to administer oaths in this State.

Such sheets, before being filed with the proper officer or board shall be bound securely and numbered consecutively. The sheets shall not be fastened by pasting them together end to end, so as to form a continuous strip or roll. All petition sheets which are filed with the proper local election officials, election authorities or the State Board of Elections shall be the original sheets which have been by the voters and by the circulator, and not signed photocopies or duplicates of such sheets. A petition, presented or filed, shall not be withdrawn, altered, or added to, and no signature shall be revoked except by revocation in writing presented or filed with the board or officer with whom the petition is required to be presented or filed, before the presentment or filing of such petition, except as may otherwise be provided in another statute which authorize the public question. Whoever forges any name of a signer upon any petition shall be deemed guilty of a forgery, and on conviction thereof, shall be punished accordingly.

In addition to the foregoing requirements, a petition

- 1 proposing an amendment to Article IV of the Constitution
- 2 pursuant to Section 3 of Article XIV of the Constitution or a
- 3 petition proposing a question of public policy to be
- 4 submitted to the voters of the entire State shall be in
- 5 conformity with the requirements of Section 28-9 of this
- 6 Article.
- 7 If multiple sets of petitions for submission of the same
- 8 public questions are filed, the State Board of Elections,
- 9 appropriate election authority or local election official
- where the petitions are filed shall within 2 business days
- 11 notify the proponent of his or her multiple petition filings
- 12 and that proponent has 3 business days after receipt of the
- 13 notice to notify the State Board of Elections, appropriate
- 14 election authority or local election official that he or she
- 15 may cancel prior sets of petitions. If the proponent
- 16 notifies the State Board of Elections, appropriate election
- 17 authority or local election official, the last set of
- 18 petitions filed shall be the only petitions to be considered
- valid by the State Board of Elections, appropriate election
- 20 authority or local election official. If the proponent fails
- 21 to notify the State Board of Elections, appropriate election
- 22 authority or local election official then only the first set
- 23 of petitions filed shall be valid and all subsequent
- 24 petitions shall be void.
