Agency Mobile Audio/Video Report

Reporting Period:

01/01/2020 to 12/31/2020

The Department:

The Murphysboro Police Department is comprised of sixteen (16) full time police officers, twelve (14) assigned to the Patrol Division, one (1) assigned to the Investigations Division, and one (1) assigned to the Administrative Division.

Grant Devices:

The department received fifteen (15) audio/video mobile recording devices. The devices were installed in thirteen (13) patrol vehicles and two (2) administrative vehicles, in early October 2018. The department has had one camera system fail and purchased an additional device to replace it.

The Review Process:

Murphysboro Police Department audio/video records, by policy, may be reviewed in the following situations:

By a supervisor investigating a specific act of officer conduct, by a department detective after approval of a supervisor who is participating in an official investigation, such as a personnel complaint, administrative inquiry or a criminal investigation, by department personnel who request to review their own recordings, by court personnel through proper process or with permission of the Chief of Police or his/her designee, by media personnel with permission of the Chief of Police or his/her designee, recordings may be shown for the purposes of training value with approval of the Chief of Police, or his designee, or for Officer safety or training concerns.

Currently, Patrol Sergeants, Lieutenant of Police, and the Chief of Police have access to data lockers and/or long term storage servers. The Lieutenant of Police acts as the Mobile Audio Video program supervisor. The program supervisor is the only officer authorized




