Christian County is a county located in central Illinois. There are approx. 716 square miles with a population of just over 32,000 people. The Christian County Sheriff's Office is made up of 14 fulltime deputies along with The Sheriff and Chief Deputy. We also have 5 part-time deputies. The Sheriff's Office houses the 55 bed Christian County Jail. The 12 road Deputies along with part time deputies wear and utilize the body cameras while on duty. We have had several issues with the mounts purchased with the body cameras. The mounts were replaced in the beginning but then the company was bought out by another and we are no longer able to get them.
