(50 ILCS 707/15)

Sec. 15. Rules; in-car video camera grants.

(b) Each law enforcement agency receiving a grant for in-car video cameras under Section 10 of this Act must provide an annual report to the Board, the Governor, and the General Assembly on or before May 1 of the year following the receipt of the grant and by each May 1 thereafter during the period of the grant. The report shall include the following:

- (1) the number of cameras received by the law enforcement agency; 9
- (2) the number of cameras actually installed in law enforcement agency vehicles; 9
- (3) a brief description of the review process used by supervisors within the law enforcement agency; **Supervisors, including Sergeants, Lieutenants and Chiefs, will review In-Car Camera Recordings at Rando, to ensure proper execution of Policies and Procedures. We will also review any and all incidents in which Use of Force and/or Complaints were made.**

(4) a list of any criminal, traffic, ordinance, and civil cases in which in-car video recordings were used, including party names, case numbers, offenses charged, and disposition of the matter. Proceedings to which this paragraph (4) applies include, but are not limited to, court proceedings, coroner's inquests, grand jury proceedings, and plea bargains; **ATTACHED** and

(5) any other information relevant to the administration of the program.

We have been working with our Records Software Supplier in order to simplify this Report in the future.
