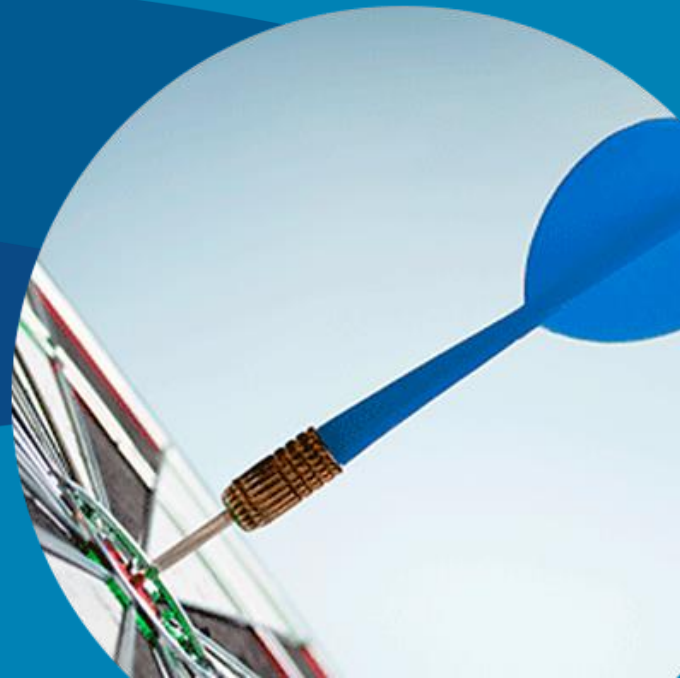

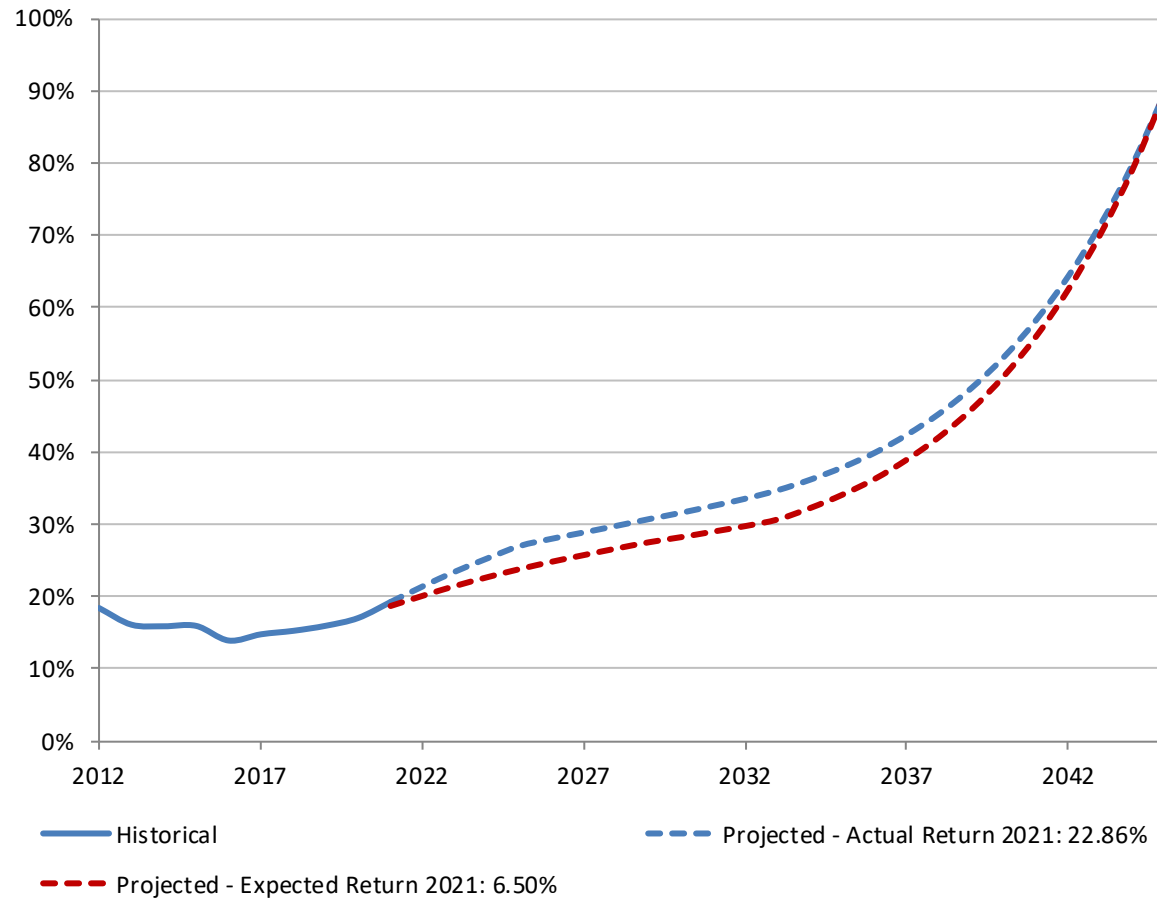

- In fiscal years 2023 through 2041, benefits are projected to exceed State and employee contributions.
- From 2024 to 2032, the percentage of investment income needed to pay ongoing benefits is projected to increase from approximately 31 percent to 89 percent.
 - This implies that a lower level of investment income is projected to be available for potential asset growth.

- The Actuarially Determined Contribution (ADC), is equal to the Normal Cost plus a 20-year level percent of capped payroll closed-period amortization of the Unfunded Actuarial Accrued Liability. As of June 30, 2021, the remaining amortization period is 14 years.



Experience Study

- Pursuant to Public Act 99-0232, GARS is required to conduct an actuarial experience review once every three years. Under this schedule, an experience review for the period from July 1, 2018 through June 30, 2021, will be performed after completion of the June 30, 2021, actuarial valuation with expected implementation of the recommended assumptions beginning with the June 30, 2022, actuarial valuation.

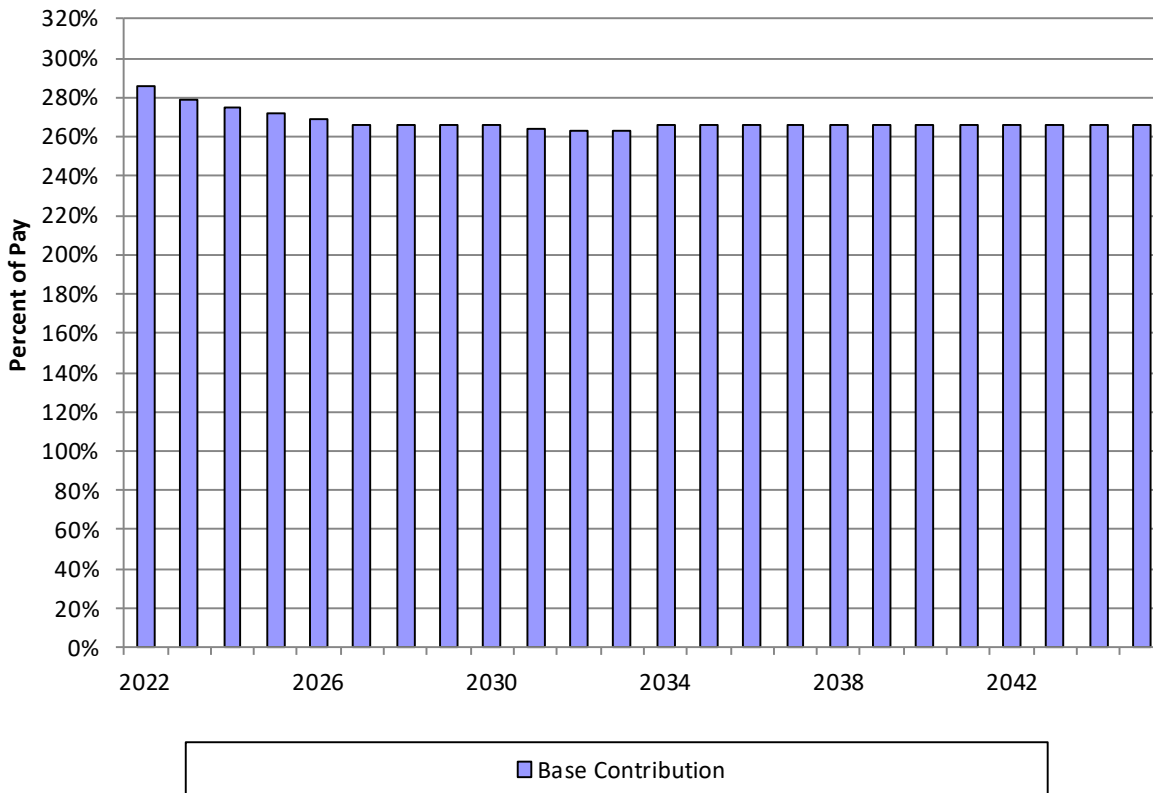
Summary

- Investment gains decreased the State's contribution requirement.
- Funded ratio is projected to increase slowly from 19.3% in 2021 to 35% in 2033, and then increase rapidly to 90% by 2045.

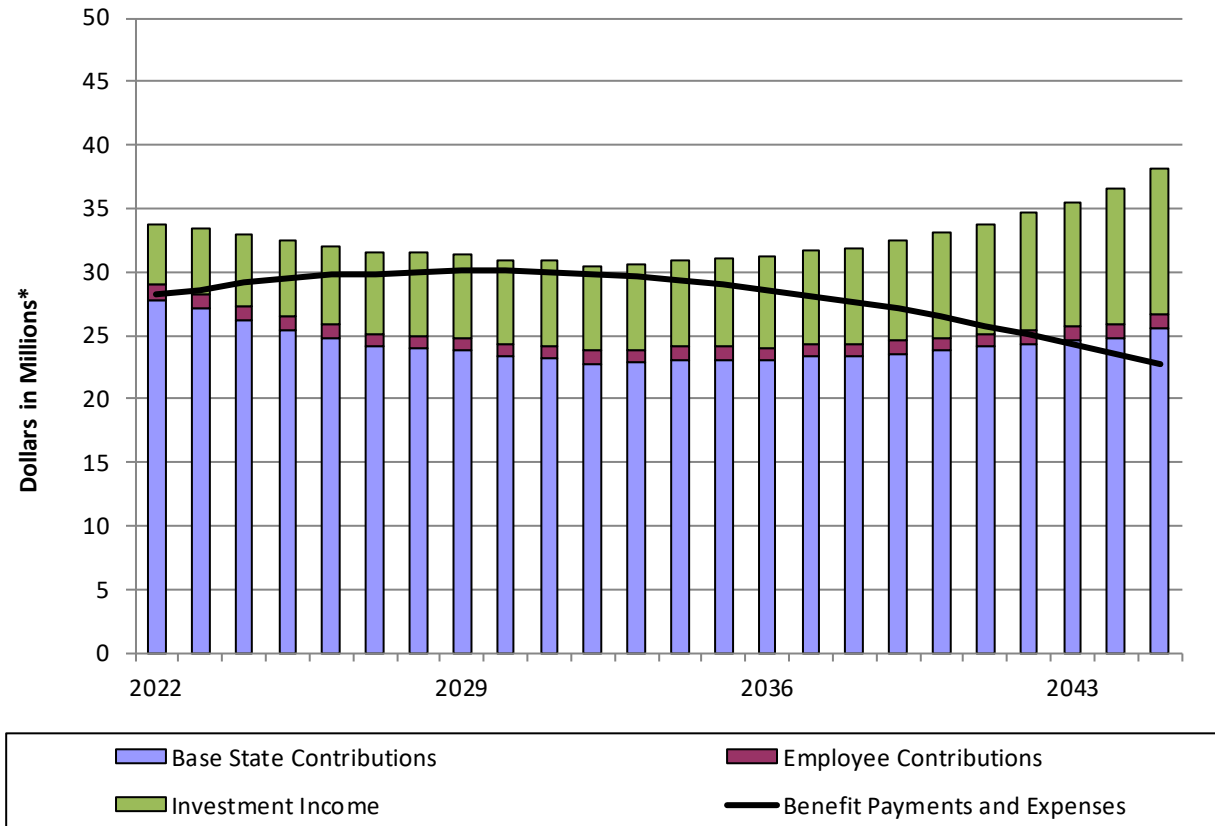

Base Contribution Rates

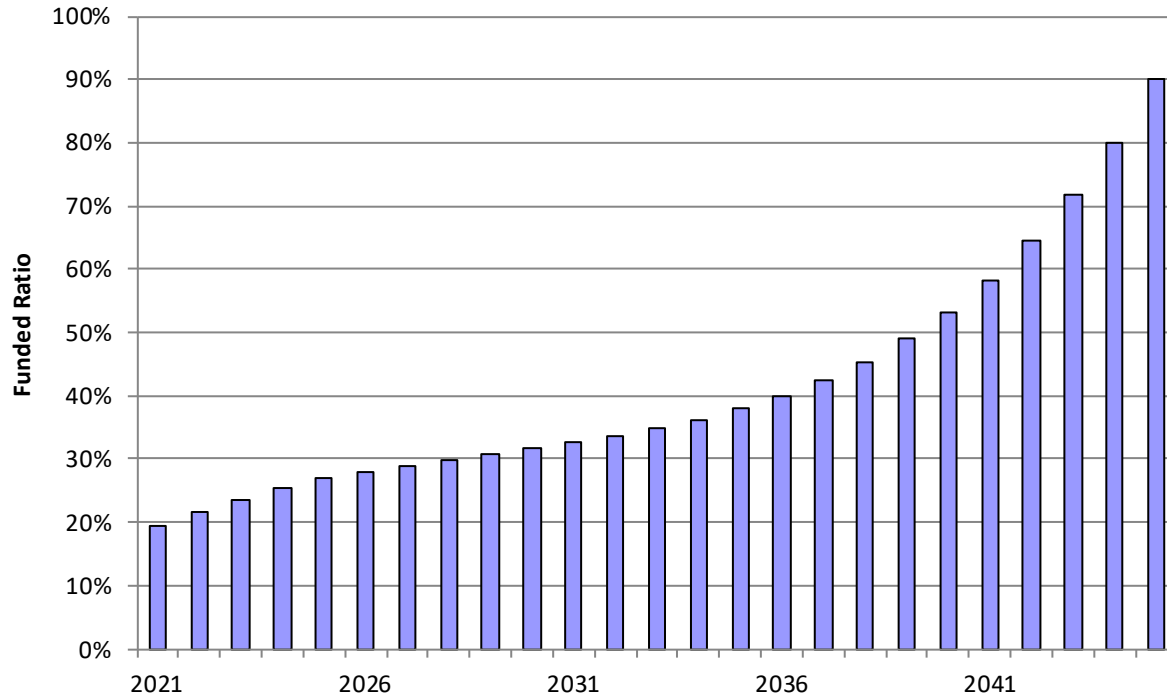

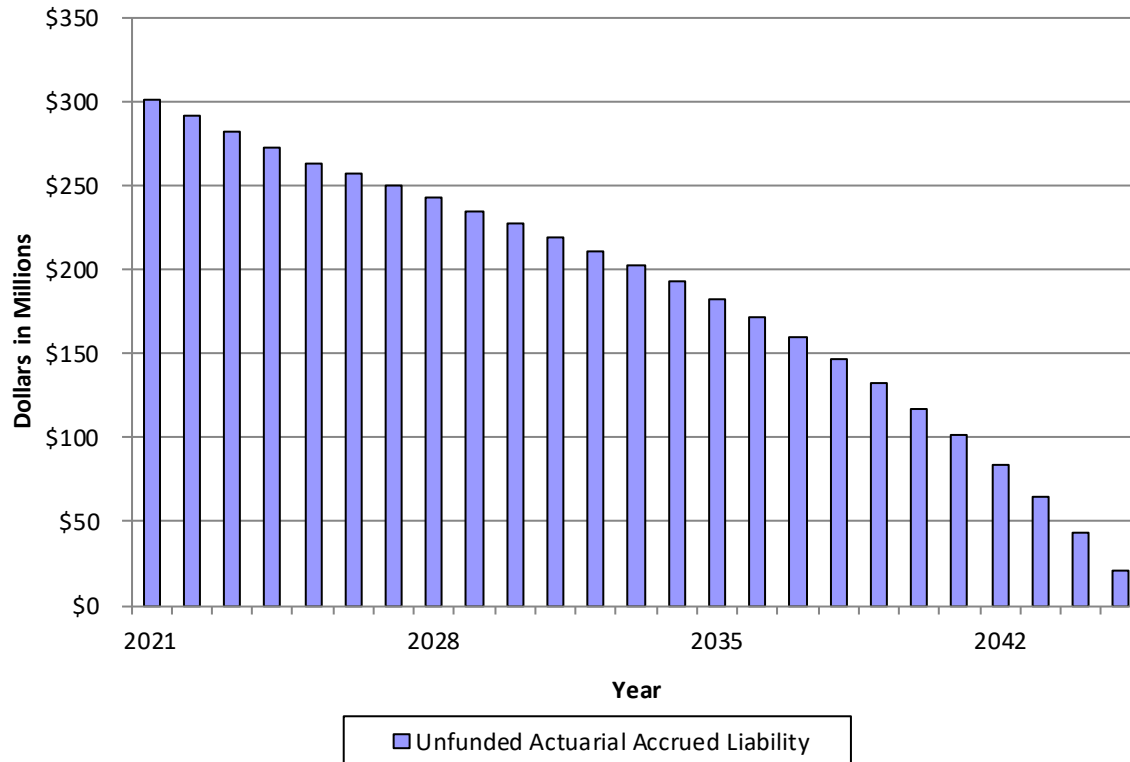
