Memorandum of Agreement for A Grant
To A State Veterans Home under 38 CFR Part 59

This Memorandum of Agreement is hereby made by and between
The Department of Veterans Affairs (VA)
810 Vermont Avenue, NW, Washington, DC 20420, and
Illinois Department of Veterans' Affairs, 833 S. Spring St., Springfield, IL 62694

Illinois Department of Veterans' Affairs has submitted to VA an application for a grant to **renovate; Emergency Campus Reconstruction and Replacement of 210 Skilled Care Beds and 80 Domiciliary Beds** for veterans in the **Quincy Veterans Home in Quincy, Illinois, (FAI 17-051)**. The parties agree that this application meets the requirements of Federal law for this grant. The estimated total cost in which VA will participate, is **\$299,635,000**. The VA grant will total **\$194,762,750** but will not exceed sixty-five (65) percent of the actual cost of the **renovations; Emergency Campus Reconstruction** as determined by the final audit. In consideration of the foregoing, the parties hereto mutually agree as follows:


- (1) **Illinois Department of Veterans' Affairs** certifies that the plans and specifications included in the application meet all applicable Federal requirements.
- (2) **Illinois Department of Veterans' Affairs** agrees that it will **renovate; Emergency Campus** Reconstruction and Bed Replacement in accordance with the documentation submitted by the state.
- (3) **Illinois Department of Veterans' Affairs** agrees to comply strictly with the assurances contained in the documentation submitted.
- (4) **Illinois Department of Veterans' Affairs** agrees to enter into a contract to **renovate; Emergency Campus Reconstruction** within 90 days of the date on which both parties have signed this agreement.

- (5) **Illinois Department of Veterans' Affairs** agrees to periodically inspect the project and certify to the Chief Consultant, Office of Geriatrics and Extended Care, 810 Vermont Avenue, NW, Washington, DC 20420, for payment of such sums which it deems are payable by VA.
- (6) **Illinois Department of Veterans' Affairs** agrees to furnish any additional State funds needed to complete the project and, if **Illinois Department of Veterans' Affairs** expends \$750,000 or more in a year in Federal awards, conduct and submit the results of an audit on the **renovations; Emergency Campus Reconstruction** in accordance with the provisions of 2 CFR Part 200.
- (7) **Illinois Department of Veterans' Affairs** agrees that, upon completion of the project, it will provide adequate financial support to maintain and operate the facility.
- (8) **Illinois Department of Veterans' Affairs** agrees that no beds will be closed as a result of the work being performed.
- (9) **Illinois Department of Veterans' Affairs** agrees that it will use the **393-bed nursing home** facility principally to furnish veterans **nursing home care**, and that not more than 25 percent of the bed occupancy at any one time will consist of residents who are not receiving such level of care as veterans. **Illinois Department of Veterans' Affairs** further agrees that all non-veteran residents must be spouses of veterans or parents of children who died while serving in the Armed Forces.
- (10) **Illinois Department of Veterans' Affairs** agrees that it will operate and maintain the facility in conformance with State standards and with all applicable State and local laws, codes, regulations, and ordinances, and in conformance with the standards prescribed by VA.
- (11) **Illinois Department of Veterans' Affairs** agrees that it will make such reports in such form and containing such information as the Under Secretary for Health may from time to time reasonably require, and give the Under Secretary for Health, upon demand, access to the records upon which such information is based.

The Under Secretary for Health of the Department of Veterans Affairs hereby approves the application. After **Illinois Department of Veterans' Affairs** certifies its **renovation; Emergency Campus Reconstruction** costs as set forth in paragraph (5) above, the Under Secretary for Health agrees that the grant shall be paid by way of reimbursement, and in such installments consistent with the progress of the project. VA will make these reimbursements by making partial payments to cover the costs certified. VA reimbursements will be limited to the unpaid balance of the grant for actual incurred costs for this project.


This grant is subject to the recapture provisions as stated in 38 CFR 59.110.

Memorandum of Agreement for A Grant

Act (CARES Act)

This Memorandum of Agreement is hereby made by and between
The Department of Veterans Affairs (VA)
810 Vermont Avenue, NW, Washington, DC 20420, and
Illinois Department of Veterans' Affairs, 833 S. Spring St., Springfield, IL 62794

Illinois Department of Veterans' Affairs has submitted to VA an application for a grant to make modifications with **Mechanical, Electrical, Fire Alarm System Upgrades and mitigation strategies to the Illinois Veterans' Home at LaSalle, the Illinois veterans' Home at Manteno and the Illinois Veterans' Home at Quincy, for veterans in the State of Illinois, FAI 17-053**. The parties agree that this application meets the requirements of Federal law for this grant. The VA grant will total **\$5,500,000**. In consideration of the foregoing, the parties hereto mutually agree as follows:

- (1) **Illinois Department of Veterans' Affairs** certifies that the plans and specifications included in the application meet all applicable Federal requirements.
- (2) **Illinois Department of Veterans' Affairs** agrees that it will **make modifications with Mechanical, Electrical, Fire Alarm System Upgrades and mitigation strategies to the Illinois Veterans' Homes at LaSalle, Manteno and Quincy** in accordance with the documentation submitted by the state as of the date such application was approved.
- (3) **Illinois Department of Veterans' Affairs** agrees to comply strictly with the assurances contained in the documentation submitted, as well as all applicable requirements of all Federal laws, executive orders, regulations, and policies with regard to this grant, to include those contained in 38 CFR Part 59 and 2 CFR Part 200.
- (4) **Illinois Department of Veterans' Affairs** agrees to periodically inspect the project and certify to the Executive Director, Office of Geriatrics and Extended Care, 810 Vermont Avenue, NW, Washington, DC 20420, for payment of such sums which it deems are payable by VA.
- (5) **Illinois Department of Veterans' Affairs** agrees to furnish any additional State funds needed to complete the project and, if **Illinois Department of Veterans' Affairs** expends \$750,000 or more in a fiscal year in Federal awards, conduct and submit the results of an audit on the **modifications with Mechanical, Electrical, Fire Alarm System Upgrades and mitigation strategies to the Illinois Veterans' Homes at LaSalle, Manteno and Quincy** in accordance with the provisions of 2 CFR Part 200.

- (6) **Illinois Department of Veterans' Affairs** agrees that, upon completion of the project, it will provide adequate financial support to maintain and operate the facility.
- (7) **Illinois Department of Veterans' Affairs** agrees that all non-veteran residents must be spouses of veterans or parents of children who died while serving in the Armed Forces.
- (8) **Illinois Department of Veterans' Affairs** agrees that it will operate and maintain the facility in conformance with State standards and with all applicable State and local laws, codes, regulations and ordinances, and in conformance with the standards prescribed by VA.
- (9) **Illinois Department of Veterans' Affairs** agrees that it will make such reports in such form and containing such information as the Executive Director, Office of Geriatrics and Extended Care, may from time to time reasonably require, and give the Executive Director, Office of Geriatrics and Extended Care, upon demand, access to the records upon which such information is based.

After **Illinois Department of Veterans' Affairs** certifies its **modifications with Mechanical, Electrical, Fire Alarm System Upgrades and mitigation strategies to the Illinois Veterans' Homes at LaSalle, Manteno and Quincy** costs as set forth in paragraph (4) above, the Under Secretary for Health agrees that the grant shall be paid by way of reimbursement, and in such installments consistent with the progress of the project. VA will make these reimbursements by making partial payments to cover the costs certified. VA reimbursements will be limited to the unpaid balance of the grant for actual incurred costs for this project.

This grant is subject to the recapture provisions as stated in 38 USC 8136.
