Re: Illinois Department of Human Services' Data Governance and Organization to Support Equity and Racial Justice Act Section 20-15(a) Report

This report is issued pursuant to the provisions of Section 20-15(a) of the Data Governance and Organization to Support Equity and Racial Justice Act ("the Act") (20 ILCS 65/20-1). The Act requires the Illinois Department of Human Services (IDHS) to report statistical data on the racial, ethnic, age, sex, disability status, sexual orientation, gender identity, and primary or preferred language demographics of program participants for each major program that IDHS administers.

Introduction

In the first Annual March Data Governance and Organization to Support Equity and Racial Justice Act Report, IDHS identified the following "major programs" and corresponding participant populations for analysis:

- 1. Temporary Assistance for Needy Families (TANF)
- 2. Supplemental Nutrition Assistance Program (SNAP)
- 3. Commodity Supplemental Food Program (CSFP)
- 4. Domestic Violence Prevention Intervention
- 5. Emergency and Transitional Housing (ETH)
- 6. Medical
- 7. Supplemental Nutrition Program for Women, Infants, and Children (WIC)
- 8. Teen REACH
- 9. Title XX Donated Funds Initiative (DFI) Senior Services
- 10. Substance Use Disorder Treatment and Intervention
- 11. Child Care Assistance Program
- 12. FIRST.IL
- 13. Vocational Rehabilitation

For each major program identified in the IDHS March 2022 report, this report will provide statistical data, where available, for each of the demographic dispositions enumerated in the Act: race, age, sex, disability status, sexual orientation, gender identity, and primary or preferred language.

Section 20-15(e) of the Act states "if the Board or Department is unable to begin reporting the data required by subsection (a) by July 1, 2022, the Board or the Department shall state the reasons for the delay under the reporting requirements." As of the date of this report, IDHS was unable to begin reporting various subsets of the data required in the statute because IDHS does not currently collect that data. This information is reflected in both the "Methodology" and "Statistics" sections of this report. Additionally, federal reporting requirements do not require this reporting for multiple programs.

IDHS is in the very early stages of identifying what data is currently not being collected. There are over 100 programs that serve customers across Illinois, with multiple, different data collection systems and/or processes. We will continue gathering information from program staff on their various data collection efforts and challenges, and we will use that information to inform an overarching data collection plan.

There will be a number of significant challenges in aligning data collection across all IDHS programs, including updating over 100 program applications, updating program information on over 100 programs, accessing shared data from other State agencies (i.e., data for IDHS programs that is collected and maintained by other State agencies), and ensuring external partner capacity and compliance. IDHS is confident that given appropriate time and resources, these challenges will be met.

Methodology

The information contained in this report is based solely on the data provided by program participants and collected by programming personnel for the various major programs. The data provided by program participants has not been audited for completeness and quality, therefore, no baseline for comparison has been established.

For the purpose of this report, program participants are defined as any individual who receives program services or interventions directly from State agency staff, contractors, or grantees. The program participants count is the number of distinct individuals that have been identified as program participants regardless of demographic category.

Temporary Assistance for Needy Families (TANF), Supplemental Nutrition Assistance Program (SNAP), and Medical

Date pulled: May 6, 2022

In each category (Race, Ethnicity, Sex, Disability, Age, Primary Language) the IDHS Division of Family and Community Services uses Business Objects, which is a software application that pulls information from the IDHS Integrated Eligibility System (IES). IES is used by the field to enter data provided by the customers applying for benefits to assist in determining eligibility for the SNAP, TANF, and Medicaid programs.

To determine a count for each program, a filter is added to the Business Object Report and then the program calculates the number based on what has been entered into IES by the field. Along with the filters, other analysis tools are used to get a breakdown of the required data elements such as the age groupings, disability status, gender, etc.

Gender identity and sexual orientation are not currently collected for these programs. The addition of these data fields will be addressed through our change management efforts.

Commodity Supplemental Food Program (CSFP)

Date pulled: March 31, 2022

The information collected for the number of households served is entered in by each grant manager using the Illinois Emergency Food Portal. That information is then gathered by The Emergency Food Assistance Program (TEFAP) team and entered in as a total number in the Illinois SharePoint portal on the Program Data Performance Report.

No demographic data is collected for the CSFP program because it is not currently a program requirement.

Domestic Violence Prevention Intervention (DVPI)

Date pulled: April 1, 2022

DVPI consists of two programs, Victim Services and Partner Abuse Intervention Programs (PAIP).

The Victim Services information is entered by the Illinois Criminal Justice Information Authority into InfoNet, a web-based data collection and reporting system used by victim service providers in Illinois. The system is nationally recognized for facilitating standardized data collection and reporting at the statewide level. There are minor differences in the Race and Ethnicity categories, with the DVPI program collecting the following for Race: American Indian/Alaskan Native; Asian/Asian American; African American/Black; Native Hawaiian and Other Pacific Islander; Middle Eastern/North African; White/European American; and the following for Ethnicity: Latina/Latino/Latinx. This information is gathered quarterly, and IDHS requests reports.

The PAIP client demographics are submitted annually and include all IDHS approved PAIP providers (funded and unfunded programs). This information is submitted using Excel spreadsheets.

Emergency and Transitional Housing (ETH)

Date pulled: May 20, 2022

The document used to gather data is called a Service Report. Providers complete and return this report quarterly.

Supplemental Nutrition Program for Women, Infants, and Children (WIC)

Date pulled: May 12, 2022

Data is collected and reported using IWIC, a web-based system used by contracted local health departments and not for profits to enroll clients into the USDA-funded WIC Program. It captures demographic, socio-economic, health, and nutritional information to determine eligibility for WIC, and helps calculate what nutritional benefits should be issued to the client to alleviate their nutritional or health deficiencies. IWIC data is kept in a Microsoft SQL database. IWIC has some built-in reports, such as Race/Ethnic composition, and staff have the ability to query and report the data using Microsoft SQL Server Tools.

Per current USDA guidance, IWIC records the Race and Ethnicity of the client using the ERJA choices, except for Middle Eastern / North African. Sex is identified in the system as Gender and is a choice between Man and Woman with no Gender Identity. Sexual Orientation and Disability Status are not recorded. Age is calculated via their Date of Birth and Language is also recorded.

Gender identity and sexual orientation are not currently being collected.

Teen REACH (Responsibility, Education, Achievement, Caring, and Hope)

Date pulled: May 12, 2022

In each demographic category (Race, Ethnicity, Sex, Disability, Age, Primary Language), the program uses Business Objects, a software application that pulls information from the IDHS eCornerstone System (ECS). ECS is used to enter data of teens enrolled in the program.

To determine the count for each, a query is run against the database tables which contain the data which has been entered into the ECS. Separate queries are used to get a breakdown of the required data elements (age groupings, disability status, gender, etc.).

Gender identity and sexual orientation are not currently being collected.

Title XX Donated Funds Initiative (DFI) - Senior Services

Date pulled: June 6, 2022

An Excel database is used to collect quarterly data on Race. Sex, Gender Identity, Sexual Orientation, Disability, Age, and Primary Language are not currently being collected.

Substance Use Disorder Treatment and Intervention

Date pulled: May 12, 2022

For each of the demographic categories reported, the Department's Automated Reporting and Tracking System (DARTS) data was used to calculate counts. DARTS is the demographic and claims reporting system used by IDHS and all contracted substance use disorder providers to report service data reimbursed through the Substance Abuse and Mental Health Services Administration (SAMHSA) federal block grant or Medicaid Fee-For-Service. DARTS data is processed on the mainframe and transferred to a SQL Server. The program area uses Tableau to connect to the DARTS data on the SQL Server and perform analysis, including the ERJA counts reported here.

Gender, Sexual Orientation, and Disability Status are not uniquely collected in DARTS.

Child Care Assistance Program (CCAP)

Date pulled: May 23, 2022

The CCAP data is captured from a paper application process that is submitted to the IDHS Child Care Resource and Referral agencies. The data is then entered into the Child Care Management System. Data is stored on an IBM SQL Mainframe system. Data entered and stored includes demographic information to capture a comprehensive view of a child and family, and includes, but is not limited to: age, income and employment information, city and county of residence.

Sex, Disability Status, Sexual Orientation, Gender, Primary Language, and Age are not currently being collected.

FIRST.IL

Date pulled: May 20, 2022

For each of the demographic areas reported, data experts pulled information using Crystal Reports. software. Crystal Reports is a Windows-based report writer solution that allows for the creation of reports and dashboards from a variety of data sources.

Vocational Rehabilitation

Date pulled: May 6, 2022

The data collected for the Vocational Rehabilitation program aligns data collection designations with the Federal Department of Education Rehabilitation Services Administration. All data was pulled from the Human Services Database.

Race and Ethnicity

The Act provides that IDHS "shall use the same racial and ethnic classifications for each program." 20 ILCS 65/20-15(a).

The enumerated classifications are:

- (1) American Indian and Alaska Native alone.
- (2) Asian alone.
- (3) Black or African American alone.
- (4) Hispanic or Latino of any race.
- (5) Native Hawaiian and Other Pacific Islander alone.
- (6) White alone.
- (7) Some other race alone.
- (8) Two or more races.

Id. The Act allows for IDHS to "further define the racial and ethnic categories[.]" Id.

The Act further states that if

a program administered by the Board or the Department is subject to federal reporting requirements that include the collection and public reporting of statistical data on the racial and ethnic demographics of program participants, the Department may maintain the same racial and ethnic classifications used under the federal requirements if such classifications differ from the classifications listed in subsection (a).

Statistical Data

The key below corresponds to the data/information contained in each chart below:

- An "X" indicates when a demographic disposition has 10 or fewer people
- A blank indicates that data for a demographic disposition is not collected
- A "0" indicates that data for a demographic disposition is collected, but no program participants have selected that category as of when the report was pulled
