# 2022 Annual Report on State Employee Child Care Centers

#### **Overview of the Act**

Pursuant to 30 ILCS 590, known as the State Agency Employees Child Care Services Act, the Department of Central Management Services (CMS) may authorize state agencies to contract for the provision of childcare services for their employees. To that end, the State of Illinois presently operates two on-site childcare centers, one located in Chicago and one in Springfield, as evidence of its commitment to provide a valuable service and benefit to state employees.

## I. State of Illinois Child Development Center

The State of Illinois Child Development Center, located in the Michael A. Bilandic Building, 160 N. LaSalle Street, Chicago, Illinois, celebrated its 30th successful year in September 2022.

Early Child Care Services, Inc. Director, Stacy Olszewski, has managed the Center since 1997. The center has been accredited for over 20 years and received the Gold Circle of Quality by the National Association for the Education of Young Children (NAEYC). Ms. Olszewski holds a bachelor's degree and is credentialed as a director, preschool and infant/toddler instructor.



The Center is licensed to care for children from ages two through 12 years. The hours of operation are 7:30 a.m. to 6:00 p.m. Monday through Friday to align with most operational hours of State offices. There are five preschool classrooms all year and one school-aged summer camp group.

This fall of 2022, there are more openings than usual as many of the parents are working from home and no longer coming into the downtown area. As the openings/vacancies are changing; we are hopeful to attract new State employees and have some of the families return to the center once parents are back in the downtown area for work. The Center has added new children every week throughout the fall. The Center continues to maintain a few openings to ensure that any State of Illinois employee will have a spot.

Priority enrollment is given to children of state employees. The Center provides care on a day-to-day basis for children who are not enrolled full-time in the center and who work for the State of Illinois. The Center currently has vacancies and is actively reaching out to clients to market the Center. The rates (as of December 1, 2022) for full-time and the summer camp program are listed below:

The Center prides itself with low turnover of teachers with the average length of employment of 8 years. All lead teachers have their Bachelor's Degree in Early Childhood Education while 2 of those teachers have attained their Master's Degree in Early Childhood Education.

The Center offers spacious classrooms, a separate Discovery Room designed by Kohl Museum, and a large outdoor playground located on the deck of the 21<sup>st</sup> floor of the Bilandic Building which was recently replaced in October of 2012. The Center is staffed by dedicated and highly qualified early childhood teachers who provide a developmentally appropriate curriculum in a safe and nurturing environment. The innovative curriculum, based on the belief that children learn through play, includes whole language, math their way, science, social studies, art, music, movement, and computers. The children grow and develop socially, emotionally, cognitively, and physically during their time in the Center.

In 2008, the Center became part of the Chicago Public Schools in the Community Partnership Program which has enabled the Center to:

- 1. Increase the employees' salaries based on their educational qualifications.
- 2. Financially assist Center employees to earn bachelor's degrees.
- 3. Increase training opportunities for the staff.

By taking advantage of the program's opportunities to better educate, train, and compensate the Center's employees, the Center's children and parents are afforded higher quality childcare and education.

The current contract (18-416-CMS-BOSS4-P-1380) for childcare services with Early Child Care Services, Inc. expires on May 15, 2026, with an additional 2-year extension option. This contract was awarded through CMS' procurement process on May 16, 2018.

## II. Capital City Learning Center, Department of Revenue



Capital City learning Center has been open for 6 years. The center is a sister company to Kountry Kids Learning Center in New Berlin and Rushville, Il. Owned by Kris and Stephanie Neuman, the Center provides professional quality care to the Springfield area with the emphasis on learning. The Neuman's bring years of experience in the field of early childhood learning, as well as

business administration to the city of Springfield.

The Center cares for children from ages six weeks through five years old. The hours of operation are 7:00 a.m. to 5:30 p.m. Monday through Friday to align with most operational hours of State offices. The average full-time enrollment is 75 children, with a capacity of 43.

There is a waiting list for enrollment comprised of approximately 75 children. The rates (as of November 1, 2021) for full-time are listed below:

The Center's Director is Lori Rice. Ms. Rice holds an associate degree and over 19 years of early childhood education experience. Ms. Rice is currently pursuing a bachelor's degree. The current staff consists of eleven teachers, all of whom have associate degrees or pursing associate degrees with completion in the Fall 2023.

The educational program is based on Creative Curriculum and Teaching Strategies Gold Standards. Capital City Learning Center has received the Gold Circle of Quality and Accreditation through the National Accreditation Commission. We have worked so hard to achieve this goal and continue to strive each day to keep improving our quality of care to our families.

Capital City Learning Center strives to meet the needs of children and their families each day while at the same time building solid, positive relationships. One way it achieves that goal is hosting a variety of fun, community and family-friendly activities. Some of the activities include hosting an annual Halloween Parade, and going on field trips to the Apple Barn, Pumpkin Creek Farm, Ergadoozy, Children's Museum and the Scoville Zoo. Some of these events were cancelled due to the COVID-19 pandemic

The current contract (REV17Z4000) childcare services with Capital City Learning Center expires on June 30, 2024. This contract was awarded through the Illinois Department of Revenue procurement process.

## **Dependent Care Assistance Program**

Both Centers accommodate State of Illinois employees by accepting payments through the flexible spending program. The flexible spending program allows for employees to set aside up to \$5,000 tax-free, per year through payroll deduction in order to pay for dependent care expenses.

The Illinois Department of Central Management Services reports strong employee participation since the program's inception in 1987. In calendar year 2022, an average of 2,009 employees statewide participated in the flex-spending program with contributions totaling \$5,784,355.00.
