This report is compiled to satisfy the requirements of the Unified Code of Corrections; 730 ILCS 5/3-7-2(i) (2) (Public Act 102-1082) effective June 10, 2022.

The Illinois Department of Corrections Constituent Services Office serves as a bridge between the Department and the community at large. The Family Liaison is a member of the Constituent Services Office and serves as a point of contact person for family members, friends and visitors with loved ones in the custody of the Illinois Department of Corrections to address questions or concerns. The Family Liaison works with staff within the Department to address the question or concern.

For the time period represented in this report, December 1, 2021, thru November 30, 2022, there were nearly 14,000 communications between the Illinois Department of Corrections Constituent Services Office/Family Liaison and constituents tracked by use of a spreadsheet all of which are in a closed status. In the absence of an electronic tracking system, a spreadsheet was the available tracking method.

The report shall include a summary of activities undertaken and completed as a result of submissions to the point of contact person. The Department of Corrections shall collect and report the following aggregated and disaggregated data for each institution and facility and describe:

- A. The work of the point of contact person.
- B. The general nature of suggestions, complaints, and other requests submitted to the point of contact person.
- C. The volume of emails, calls, letters, and other correspondence received by the point of contact person.
- D. The resolutions reached, or recommendations made as a result of the point of contact person's review.
- E. Whether, if an investigation is recommended, a report of the complaint was forwarded to the Chief Inspector of the Department or other Department employee, and the resolution of the complaint, and if the investigation has not concluded, a detailed status report on the complaint.
- F. Any recommendations that the point of contact person has relating to systemic issues in the Department of Corrections, and any other matters for consideration by the General Assembly and the Governor.

There were 26 investigations recommended during this reporting period. Of the 26 investigations, 6 are pending investigations, 14 investigations were not substantiated, 6 investigations were substantiated.

<u>Recommendations:</u> There are no recommendations for this reporting cycle.

Note: Stakeholders were able to utilize multiple communication channels to address both questions and concerns they may have had regarding family, friends, conditions, and other topics of concern. The data does not account for circumstances where multiple communication channels were utilized by the same constituent, at the same time, to address the same question or concern.

Note: Data may be skewed as there was no way to represent repetitive contacts, robocalls, or other forms of solicited repeat communications.

Note: On June 10, 2022, per Public Act 102-1082, the Department was required to report variables that had not historically been collected. The implementation and collection of this data is evolving and data reported is subject to change.
