Subsequently, the Illinois Team, consisting of Illinois Department of Veterans' Affairs Grants Manager, Connie Watson, Illinois Capital Development Board Project Manager, Chris MacGibbon, and A/E Project Manager, Ramu Ramachandran, and received your approval of the DRAFT SF 271. However, prior to having the opportunity to submit the signed request for reimbursement, MAX.GOV link for submitting documents to the project was removed from the "Grant Application Status ILLINOIS 17-000" page.
