Introduction

The Illinois Angel Investment Tax Credit Program is designed to encourage interested firms or individuals to make investments in Illinois' innovative businesses. The investments encourage job growth and expand capital investment in Illinois. The Program can offer tax credits to qualified investors in an amount equal to 25% of their investment made directly in a Qualified New Business Venture (QNBV). The maximum amount of tax credits to be issued under the Act is \$10,000,000 per calendar year. While the Program was initially to be administered for the taxable years beginning after December 31,2010 and ending on or before December 31, 2021, the Program was extended in 2021 to end on or before December 31, 2026.

The Program has two components of participation: (i) a business component and (ii) an investor component. Interested Illinois businesses must apply to DCEO each taxable year for which the business desires registration. If deemed eligible, the business can direct investors to apply for tax credits. Investors for eligible businesses must submit an application to DCEO in order to be considered for a tax credit. To receive a credit, investors must (i) invest in the eligible business after the business has been deemed eligible and within the same calendar year, (ii) submit an executed application (which conforms to the Program's requirements) and (iii) certify to keep their investment in the qualified new business venture for no less than 3 years.

Overview

In 2022, total of \$6,983,738 in tax credits were utilized which allowed the Department to leverage \$31,258,706 in private investments for innovative, early-stage businesses across the State of Illinois.

Although the Program Manager position was vacant for the first half of 2022, the Program remained operational. In July, the Department welcomed a new Program Manager, Jason Anderson.

Operational efficiencies implemented in 2020 such as digital applications, automated submission confirmations and publicly shared schedules implemented by the Office of Entrepreneurship, Innovation & Technology at Illinois Department of Commerce & Economic Opportunity have continued to improve upon the customer experience for both businesses and investors.

The Department continues to make concerted efforts, such as outreach to various organizations and businesses about the program and providing webinars to highlight businesses, to reduce the equity gap. Outreach partners include, but are





These outreach efforts have resulted in an increasing number of applications received from businesses which could be considered eligible for set-asides.¹


This outreach has also resulted in an increased amount of tax credits being issued for investments into businesses eligible for set-asides (minority-, women-, persons with a disability-owned businesses and businesses located in counties with populations of less than 250,000).

In order to create more visibility into the equity of the program, the Department also continues to analyze average investment sizes for each of the set-asides relative to average investment sizes for businesses which are not eligible for set-asides as shown below.

Effectiveness of the Program

Since 2011, the Angel Investment Tax Credit Program has aided in the placement of over **\$396,802,917** in investments into early-stage, innovative businesses throughout Illinois which provided **\$98,293,737** in tax credits for **2,614** investments. The breakdown for each year can be found below.


Assistance for Minority-Owned Businesses

In 2022, the Department received 43 applications from minority-owned businesses. Of these applications, 19 (44%) were approved through the Program. Reasons for denials included:


- 75% Principally engaged in a disqualifying area as defined by statute
- 50% Not principally engaged in a qualifying area as defined by statute
- 17% Not in good standing with Illinois Secretary of State
- 4% Principal place of business is not in Illinois
- 4% Less than 51% of employees in Illinois
- 4% Did not agree to maintain the minimum employment threshold

Of the 19 minority-owned businesses registered through the Program, 11 (58%) received investments from investors.

Average Investment Size for Minority-Owned Businesses




In total, the Program incentivized 24 investments into minority-owned businesses which placed a **record-breaking \$12,208,483** (in aggregate) into 11 businesses. The average investment size was a **record-breaking \$508,687**.


Assistance for Asian American-Owned Businesses

In 2022, the Department received 17 applications from Asian American-owned businesses. Of these applications, 11 (65%) were approved through the Program. Reasons for denials included:

- 67% Principally engaged in a disqualifying area as defined by statute
- 33% Not principally engaged in a qualifying area as defined by statute
- 33% Not in good standing with Illinois Secretary of State
- 17% Principal place of business is not in Illinois
- 17% Did not agree to maintain the minimum employment threshold

Aggregate Investments for Asian American-Owned Businesses





Of the 11 Asian American-owned businesses registered through the Program, 8 (73%) received investments from investors.

In total, the Program incentivized 17 investments into Asian American-owned businesses which placed a **record-breaking \$9,365,990** (in aggregate) into a **recordbreaking 8 businesses**. The average investment size was a **record-breaking \$550,941**.

Average Investment Size for Asian American-Owned Businesses




Assistance for Black/African American-Owned Businesses

In 2022, the Department received 21 applications from Black/African American-owned businesses. Of these applications, 6 (29%) were approved through the Program. Reasons for denials included:


- 80% Principally engaged in a disqualifying area as defined by statute
- 60% Not principally engaged in a qualifying area as defined by statute
- 13% Not in good standing with Illinois Secretary of State
- 7% Less than 51% of employees in Illinois

Of the 6 Black/African American-owned businesses registered through the Program, 2 (33%) received investments from investors.

In total, the Program incentivized a **recordbreaking 6 investments** into Black/African American-owned businesses which placed a **record-breaking \$2,432,493** (in aggregate) into 2 businesses. The average investment size was \$405,416.

Assistance for LatinX/Hispanic-Owned Businesses


In 2022, the Department received 6 applications from LatinX/Hispanic-owned businesses. Of these applications, 3 (50%) were approved through the Program. Reasons for denials included:

- 67% Principally engaged in a disqualifying area as defined by statute
- 33% Not principally engaged in a qualifying area as defined by statute

Of the 3 LatinX/Hispanic-owned businesses registered through the Program, 2 (**67% - a new record**) received investments from investors.

% of Approved LatinX/Hispanic-Owned Businesses Receiving Investments





Assistance for Women-Owned Businesses


In 2022, the Department received 29 applications from women-owned businesses. Of these applications, 15 (52%) were approved through the Program. Reasons for denials included:

- 71% Principally engaged in a disqualifying area as defined by statute
- 64% Not principally engaged in a qualifying area as defined by statute
- 7% Did not agree to maintain the minimum employment threshold

Women-Owned Businesses Received Investments




Aggregate Investments for Women-Owned Businesses



Of the 15 women-owned businesses registered through the Program, **11** (73%) **received investments** from investors – **a new record for the program**.

In total, the Program incentivized 25 investments into women-owned businesses which placed a **record-breaking \$5,729,491** (in aggregate) into 11 businesses. The average investment size was a **record-breaking \$229,180**.




Average Investment Size for Women-Owned Businesses

Assistance for Businesses in Counties with Populations of Less Than 250,000

In 2022, the Department received 10 applications from businesses located in counties with populations of less than 250,000. Of these applications, 4 (40%) were approved through the Program. Reasons for denials included:

- 67% Principally engaged in a disqualifying area as defined by statute
- 33% Not principally engaged in a qualifying area as defined by statute
- 17% Not in good standing with Illinois Secretary of State
- 17% Less than 51% of employees in Illinois

Of the 4 businesses registered through the Program, 3 (**75% - a new record**) received investments from investors.

In total, the Program incentivized 5 investments into businesses located in counties with populations of less than 250,000 which placed \$450,000 (in aggregate) into 4 businesses. The average investment size was \$90,000.

Intersectionality

Assistance for Minority Women-Owned Businesses


In 2022, the Program incentivized investments in minority women-owned businesses for the first time since its inception in 2011.

The Department received 17 applications from minority women-owned businesses. Of these applications, **6** (35%) **were approved** through the Program – **a new record**. Reasons for denials included:

- 73% Not principally engaged in a qualifying area as defined by statute
- 64% Principally engaged in a disqualifying area as defined by statute
- 9% Principal place of business is not in Illinois
- 9% Did not agree to maintain the minimum employment threshold

Of the 6 minority women-owned businesses registered through the Program, 4 (67%) received investments from investors.

In total, the Program incentivized 8 investments into minority women-owned businesses which placed **\$3,092,493** (in aggregate) **into 4 businesses**. The average investment size was \$386,562.


Assistance for Asian American Women-Owned Businesses

In 2022, the Program **incentivized investments in Asian American women-owned businesses for the first time since its inception in 2011**.

The Department received 6 applications from Asian American women-owned businesses. Of these applications, **3** (50%) **were approved** through the Program – **a new record**. Reasons for denials included:

- 67% Not principally engaged in a qualifying area as defined by statute
- 33% Principally engaged in a disqualifying area as defined by statute
- 33% Principal place of business is not in Illinois
- 33% Did not agree to maintain the minimum employment threshold





Of the 3 Asian American women-owned businesses registered through the Program, 2 (67%) received investments from investors.

In total, the Program incentivized 2 investments into Asian American women-owned businesses which placed **\$660,000** (in aggregate) **into 2 businesses**. The average investment size was \$330,000.


Assistance for Black/African American Women-Owned Businesses

In 2022, the Program incentivized investments in Black/African American women-owned businesses for the <u>first time since its inception in 2011</u>.

The Department received 11 applications from Black/African American women-owned businesses. Of these applications, **3** (27%) **were approved** through the Program – **a new record**. Reasons for denials included:

- 75% Not principally engaged in a qualifying area as defined by statute
- 75% Principally engaged in a disqualifying area as defined by statute

Of the 3 Black/African American women-owned businesses registered through the Program, 2 (67%) received investments from investors.

In total, the Program incentivized 6 investments into Black/African American women-owned businesses which placed **\$2,432,493** (in aggregate) **into 2 businesses**. The average investment size was \$405,416.


Assistance for LatinX/Hispanic Women-Owned Businesses

In 2022, the Program incentivized investments in LatinX/Hispanic women-owned businesses for the first time since its inception in 2011.

The Department received 1 application from LatinX/Hispanic women-owned businesses. This business was approved through the program and received investments.

In total, the Program incentivized 3 investments into LatinX/Hispanic women-owned businesses which placed **\$40,000** (in aggregate) **into 1 business**. The average investment size was \$13,333.
