Dear Governor Pritzker:

On behalf of the Illinois Firefighters' Pension Investment Fund ("FPIF"), I am providing this report to you and the General Assembly disclosing FPIF's economic opportunity investments as of June 30, 2023.

Under Public Act 96-0753, Illinois encourages its pension funds to promote the economy of Illinois through the use of economic opportunity investments to the greatest extent feasible within the bounds of financial fiduciary prudence.

This report lists the investments made by FPIF's investment managers into Illinois-based businesses. To compile the public equity and fixed income portion of the report, FPIF Staff identified Illinois businesses that are public companies using the Bloomberg Illinois Index. The index consisted of 120 companies, as of June 30, 2023, headquartered in Illinois. FPIF's economic opportunity investments, consisting of real estate, public equity, and fixed income investments, total \$191,766,775 or 2.4% of the total fund. FPIF recently consolidated approximately 300 Article 4 firefighter pension funds into a new entity and established relationships with five investment managers. While those investment managers are not based in Illinois, FPIF strives to identify Illinois-based investment managers to engage in the future.

It is the goal of FPIF, subject to its fiduciary responsibility, to continue to increase its participation in economic opportunity investments in order to improve the economic condition of the state and its municipalities.
