The following report fulfills the statutory directive that the Department of Commerce and Economic Opportunity (DCEO) provide the Governor and Members of the General Assembly with an annual report on the activities of the Office of Business Permits and Regulatory Assistance, more commonly known as the First Stop Business Information Center. The Business Assistance and Regulatory Reform Act (20 ILCS 608) authorizes the Department of Commerce & Economic Opportunity (Department) to create the Office which shall consolidate information about existing programs throughout State government, provide assistance to businesses with fewer than 500 employees in meeting requirements, and perform other functions specified in the Act in order to improve the State's business climate by making it easier for small and mid-sized businesses to navigate State requirements. This goal is achieved by providing timely and accurate information regarding business requirements.



The First Stop Business Information Center (First Stop) was created under the Business Assistance and Regulatory Reform Act (20 ILCS 608) as the Office of Business Permits and Regulatory Assistance over 30 years ago. First Stop provides small businesses and business startups with comprehensive information regarding business licenses, permits, and government regulations. Business specialists provide professional guidance to businesses and entrepreneurs by helping them identify and navigate regulatory requirements for their business and connecting them to state and local resources.




## **Department Activity**

In 2023, First Stop provided information and technical support - via phone, email, and mail – for new and existing businesses with inquiries pertaining to starting a business in Illinois, COVID-19 pandemic recovery, regulations, programs, resources, incentives, and more.

The Office provided entrepreneurs and small business owners free business startup kits, online access to its searchable knowledgebase system for license and regulatory information, as well as easy to understand guides on various business topics.

First Stop also continued to build upon its partnership with the Illinois Department of Corrections' Women and Family Services Division to provide "Starting Your Business in Illinois" handbooks for use by its re-entry counselors as they prepare individuals for their return to their communities.

### **Business Specialists**

The First Stop Business Information Center employees have over 80 years of combined experience assisting new and established business owners with Illinois regulatory processes and connecting them with resources from the federal, state, and local governments to support the launch and expansion of their enterprises. First Stop experts assist in facilitating communication between the business client and State agencies if a firm needs assistance with the state regulatory process to help alleviate any confusion or irritation.

## Online KnowledgeBase of Business Resources & Requirements

First Stop uses Oracle Service Cloud to host its KnowledgeBase System, a comprehensive database of over 500 business-related questions and answers, to better serve clients. Over 61,000 visits were made to the knowledge base in 2023. This technology is available on the First Stop website and enables entrepreneurs and small businesses to have access to the same business permit, license, certification, and business resource information as our professional staff. Self-serve information can be found on the <u>First Stop website</u>.

### **Business Start-up Assistance**

The program's business startup package revolves around the "Starting Your Business in Illinois" handbook. It is available in English and Spanish and links can be found on the <u>First Stop website</u>. It includes responses to frequently asked questions and issues that new businesses often face. It also contains lists of important government agencies, a business plan outline, a business feasibility checklist, and other helpful data.
