#### Introduction


The Illinois Angel Investment Tax Credit Program is designed to encourage interested firms or individuals to make investments in Illinois' innovative businesses. The investments encourage job growth and expand capital investment in Illinois. The Program can offer tax credits to qualified investors in an amount equal to 25% of their investment made directly in a Qualified New Business Venture (QNBV). The maximum amount of tax credits to be issued under the Act is \$10,000,000 per calendar year. While the Program was initially to be administered for the taxable years beginning after December 31, 2010, and ending on or before December 31, 2021, the Program was extended in 2021 to end on or before December 31, 2026.

The Program has two components of participation: (i) a business component and (ii) an investor component. Interested Illinois businesses must apply to DCEO each taxable year for which the business desires registration. If deemed eligible, the business can direct investors to apply for tax credits. Investors for eligible businesses must submit an application to DCEO in order to be considered for a tax credit. To receive a credit, investors must (i) invest in the eligible business after the business has been deemed eligible and within the same calendar year, (ii) submit an executed application (which conforms to the Program's requirements) and (iii) certify to keep their investment in the qualified new business venture for no less than 3 years.

#### Overview

In 2023, a total of \$2,727,675.36 in tax credits were utilized which allowed the Department to leverage \$10,910,701.42 in private investments for innovative, early-stage businesses across the State of Illinois.

The Department welcomed an intern, Rodney Ovbiye, in March 2023 and an additional full-time tax incentive manager, Nicole Barton, in January 2024.




Operational efficiencies implemented in 2020 such as digital applications, automated submission confirmations and publicly shared schedules implemented by the Office of Entrepreneurship, Innovation & Technology at Illinois Department of Commerce & Economic Opportunity have continued to improve upon the customer experience for both businesses and investors.

Over the course of Governor Pritzker's term in office, the program incentivized \$166,883,437 in private investments for businesses – a record for the program.

The Department continues to make concerted efforts, such as outreach to various organizations and businesses about the program and providing webinars to highlight businesses, to reduce the equity gap. Outreach partners include, but are not limited to:



These outreach efforts have resulted in an increasing number of applications received from businesses that meet the eligibility criteria for set-asides (minority-, women-, persons with a disability-owned businesses and businesses located in counties with populations of less than 250,000).


Our outreach efforts have also resulted in an increased amount of tax credits being issued for investments into businesses eligible for set-asides.

To create more visibility into the equity of the program, the Department also continues to analyze average investment sizes for each of the set-asides relative to average investment sizes for businesses which are not eligible for set-asides as shown below.

#### Effectiveness of the Program

Since 2011, the Angel Investment Tax Credit Program has aided in the placement of over \$407,720,001 in investments into early-stage, innovative businesses throughout Illinois which provided \$101,023,008 in tax credits for 2,721 investments. The breakdown for each year can be found below.

#### Assistance for Minority-Owned Businesses

In 2023, the Department received 33 applications from minority-owned businesses. Of these applications, 18 (55%) were approved through the Program. Reasons for denials included:

- 47% Principally engaged in a disqualifying area as defined by statute
- 33% Not principally engaged in a qualifying area as defined by statute
- 33% Capitalization table discrepancy
- 13% Less than 51% of employees in Illinois
- 6% Not in good standing with Illinois Secretary of State
- 6% Business operated in Illinois longer than ten years

Of the 18 minority-owned businesses registered through the Program, 9 (50%) received investments from investors.

In total, the Program incentivized 16 investments into minority-owned businesses which placed **\$2,596,297** (in aggregate) into 9 businesses. The average investment size was **\$162,269**.

#### Assistance for Asian American-Owned Businesses

In 2023, the Department received 11 applications from Asian American-owned businesses. Of these applications, 7 (64%) were approved through the Program. Reasons for denials included:

- 50% Principally engaged in a disqualifying area as defined by statute
- 25% Capitalization table discrepancy
- 25% Less than 51% of employees in Illinois
- Of the 7 Asian American-owned businesses registered through the Program, 6 (86%) received investments from investors.

In total, the Program incentivized 10 investments into Asian American-owned businesses which placed \$2,213,798 (in aggregate) into 6 businesses. The average investment size was \$221,379.

## Assistance for Black/African American-Owned Businesses

In 2023, the Department received 15 applications from Black/African American-owned businesses. Of these applications, 8 (53%) were approved through the Program. Reasons for denials included:

- 57% Principally engaged in a disqualifying area as defined by statute
- 43% Capitalization table discrepancy
- 13% Not principally engaged in a qualifying area as defined by statute
- 13% Not in good standing with Illinois Secretary of State
- 13% Less than 51% of employees in Illinois

Of the 8 Black/African American-owned businesses registered through the Program, 2 (33%) received investments from investors.

In total, the Program incentivized **4 investments** into Black/African American-owned businesses which placed **\$82,500** (in aggregate) into 2 businesses. The average investment size was \$20,625.

### Assistance for LatinX/Hispanic-Owned Businesses

In 2023, the Department received 8 applications from LatinX/Hispanic-owned businesses. Of these applications, 4 (50%) were approved through the Program. Reasons for denials included:

- 75% Principally engaged in a disqualifying area as defined by statute
- 75% Not principally engaged in a qualifying area as defined by statute
- 50% Capitalization table discrepancy
- 25% Less than 51% of employees in Illinois
- 25% Business operated in Illinois longer than ten years

Of the 4 LatinX/Hispanic-owned businesses registered through the Program, 2 received investments from investors.

In total, the Program incentivized 5 investments into LatinX/Hispanic-owned businesses which placed \$372,500 (in aggregate) into 2 businesses. The average investment size was \$74,500.

#### Assistance for Women-Owned Businesses

In 2023, the Department received 33 applications from women-owned businesses. Of these applications, 14 (42%) were approved through the Program. Reasons for denials included:

- 63% Capitalization table discrepancy
- 42% Principally engaged in a disqualifying area as defined by statute
- 32% Not principally engaged in a qualifying area as defined by statute
- 11% Not in good standing with Illinois Secretary of State
- 5% Less than 51% of employees in Illinois
- 5% Business operated in Illinois longer than ten years

Of the 14 women-owned businesses registered through the Program, 6 (43%) received investments from investors.

In total, the Program incentivized 31 investments into women-owned businesses which placed \$2,379,498 (in aggregate) into 6 businesses. The average investment size was \$76,758.

# Assistance for Businesses in Counties with Populations of Less Than 250,000

In 2023, the Department received 9 applications from businesses located in counties with populations of less than 250,000. Of these applications, 6 (67%) were approved through the Program. Reasons for denials included:

- 67% Principally engaged in a disqualifying area as defined by statute
- 67% Capitalization table discrepancy
- 33% Not in good standing with Illinois Secretary of State

Of the 6 businesses registered through the Program, 2 received investments from investors.

In total, the Program incentivized 2 investments into businesses located in counties with populations of less than 250,000 which placed \$60,000 (in aggregate) into 2 businesses. The average investment size was \$30,000.

#### Intersectionality

#### Assistance for Minority Women-Owned Businesses

In 2023, the Program, for the second consecutive year, **incentivized investments in minority women-owned businesses**.

The Department received 13 applications from minority women-owned businesses. Of these applications, 5 (38%) were approved through the Program. Reasons for denials included:

- 63% Not principally engaged in a qualifying area as defined by statute
- 50% Capitalization table discrepancy
- 25% Principally engaged in a disqualifying area as defined by statute
- 13% Not in good standing with Illinois Secretary of State
- 13% Business operated in Illinois longer than ten years

Of the 5 minority women-owned businesses registered through the Program, 2 (40%) received investments from investors.

In total, the Program incentivized 4 investments into minority women-owned businesses which placed \$82,500 (in aggregate) into 2 businesses. The average investment size was \$41,250.

#### Assistance for Asian American Women-Owned Businesses

In 2023, the Program, for the second consecutive year, **incentivized investments in Asian American** women-owned businesses.

The Department received 3 applications from Asian American women-owned businesses. Of these applications, 1 (33%) was approved through the Program. Reasons for denials included:

• 100% - Principally engaged in a disqualifying area as defined by statute

Of the 1 Asian American women-owned business registered through the Program, 0 (0%) received investments from investors.

In total, the Program incentivized 0 investments into Asian American women-owned businesses which placed \$0 (in aggregate) into 1 business. The average investment size was \$0.

#### Assistance for Black/African American Women-Owned Businesses

In 2023, the Program, for the second consecutive year, **incentivized investments in Black/African American women-owned businesses**.

The Department received 8 applications from Black/African American women-owned businesses. Of these applications, **4** (50%) **were approved** through the Program – **a new record**. Reasons for denials included:

- 50% Not principally engaged in a qualifying area as defined by statute
- 50% Capitalization table discrepancy
- 25% Not in good standing with Illinois Secretary of State

Of the 4 Black/African American women-owned businesses registered through the Program, 2 (50%) received investments from investors.

In total, the Program incentivized 4 investments into Black/African American women-owned businesses which placed **\$82,500** (in aggregate) **into 2 businesses**. The average investment size was \$41,250.

#### Assistance for LatinX/Hispanic Women-Owned Businesses

In 2023, the Program, for the second consecutive year, **incentivized investments in LatinX/Hispanic women-owned businesses**.

The Department received **3** applications from LatinX/Hispanic women-owned businesses, **a new record**. One business was approved through the program and received investments.

Reasons for denials included:

- 100% Not principally engaged in a qualifying area as defined by statute
- 50% Capitalization table discrepancy
- 50% Business operated in Illinois longer than ten years
- 50% Principally engaged in a disqualifying area as defined by statute

In total, the Program incentivized 3 investments into LatinX/Hispanic women-owned businesses which placed **\$72,500** (in aggregate) **into 1 business**. The average investment size was \$24,167.
