Dear Governor Pritzker:

On behalf of the Illinois Firefighters' Pension Investment Fund ("FPIF"), I am providing this report to you and the General Assembly disclosing FPIF's economic opportunity investments as of June 30, 2024.

Under Public Act 96-0753, Illinois encourages its pension funds to promote the economy of Illinois through the use of economic opportunity investments to the greatest extent feasible within the bounds of financial fiduciary prudence.

This report lists the investments made by FPIF's investment managers into Illinois-based businesses. As of June 30, 2024, FPIF's economic opportunity investments, consisting of real estate, public equity, and fixed income investments, total \$168,979,381.17 or 1.88% of the total Fund. FPIF recently consolidated approximately 300 Article 4 Firefighters' pension funds into a new entity and established relationships with eight investment managers. In 2024, FPIF procured two Illinois-based investment managers, William Blair and Adams Street Partners, and FPIF's investment to these managers as of June 30, 2024, was equal to \$127,099,050 or 1.41% of the total Fund.

It is the goal of FPIF, subject to its fiduciary responsibility, to continue to increase its participation in economic opportunity investments in order to improve the economic condition of the state and its municipalities.
