Background

The <u>Illinois Environmental Justice Act (415 ILCS 155/)</u> established the Illinois Commission on Environmental Justice (EJ Commission). The principle of EJ requires that no segment of the population, regardless of race, national origin, age, or income, should bear disproportionately high or adverse effects of environmental pollution.

Section 10(d) of the Environmental Justice Act establishes the Commission's duties. Those duties are:

- 1. Advise State entities on environmental justice and related community issues.
- 2. Review and analyze the impact of current State laws and policies on the issue of environmental justice and sustainable communities.
- 3. Assess the adequacy of State and local laws to address the issue of environmental justice and sustainable communities.
- 4. Develop criteria to assess whether communities in the State may be experiencing environmental justice issues.
- Recommend options to the Governor for addressing issues, concerns, or problems related to environmental justice
 that surface after reviewing State laws and policies, including prioritizing areas of the State that need immediate
 attention.

The Illinois Environmental Protection Agency provides administrative support to the EJ Commission.

The EJ Commission is subject to the Open Meetings Act (OMA), which establishes requirements for conducting meetings, including the requirement to have a quorum to take official action. The EJ Commission is currently at quorum, with more than 13 out of the 24 voting members active. As of October 2024, the EJ Commission has a total of 6 vacancies, outlined above. EJ Commission members have been actively seeking additional members and encouraging interested parties to submit applications through the Boards and Commissions webpage.

2024 Quarterly Meetings & Significant Issues

EJ Commission meetings are open to the public and anyone interested may participate. The level of public participation throughout the meetings typically have not exceeded more than five people. Overall input from the public has enhanced the Commission's work through steering agenda topics and keeping the mission of advancing environmental justice efforts at the State a top priority. The EJ Commission meets quarterly (see Appendix A for copies of 2024 agendas). Links to past and upcoming meeting agendas, notices, recordings, and minutes can be found on the Illinois EPA Commission on Environmental Justice meetings webpage.

Key topics discussed throughout 2024 meetings included the historic federal funding, grant, and technical assistance opportunities available to EJ communities. The EJ Commission heard a presentation from Blacks in Green (BIG), a Chicago-based organization that is one of the 16 Thriving Communities Technical Assistance Centers (TCTACs) across the nation. To provide context, in 2024, the U.S. Environmental Protection Agency (U.S. EPA) selected 16 TCTACs to remove barriers and improve accessibility for communities with EJ concerns, provide training and other assistance to build capacity for navigating federal grant application systems, provide guidance on community engagement, meeting facilitation, and translation and interpretation services for limited English-speaking participants, thus removing barriers and improving accessibility for communities with EJ concerns. BIG shared their experience and expertise on providing assistance to communities and their efforts in driving federal funding to the State of Illinois to advance EJ. Commissioners emphasized the importance of needing to share TCTAC resources with EJ communities, partners, and stakeholders across Illinois. To that end, Illinois EPA developed a webpage and distributed a press release intended to alert eligible entities to these funding opportunities and thereby increase federal investments in Illinois that will benefit EJ communities across the State.

Additionally, Illinois EPA this year provided numerous updates to the Commission on developments including the Informal Resolution Agreement (IRA) that Illinois EPA entered into with the U.S. Environmental Protection Agency (U.S. EPA). On February 14, 2024, Illinois EPA voluntarily entered into an IRA with U.S. EPA to resolve a civil rights complaint filed pursuant to Title VI of the Civil Rights Act of 1964 concerning the Illinois EPA's issuance of an air construction permit for a metal shredder to be located on the Southeast Side of Chicago. Under the IRA, Illinois EPA committed to revising several of its plans and polices, including its 2018 Enhanced Public Participation Plan and its Language Access Plan to ensure that civil rights procedural safeguards are in place. Illinois EPA is working with Commission members to support their review of the draft Enhanced Public Participation Plan in preparation for their submission of comments on behalf of their organizations.

Lastly, the EJ Commission this year revisited and revised the EJ questionnaire (see Appendix B) that was sent in 2018 to state agencies on the Commission. The purpose of the questionnaire is for Commissioners to learn more about the degree to which state agencies have integrated EJ into their programs and activities, identify any gaps, and provide recommendations for improvements. Commissioners are hoping to vote on the final set of questions by the end of this year and discuss a path forward for collecting and analyzing the responses.
