WHEREAS, Genetic counselors empower patients and their families with vital healthcare information, guidance, and emotional support to help them understand their family history, evaluate genetic testing options, and make informed choices based on test results; and

WHEREAS, There are over 150 certified genetic counselors in Illinois working in prenatal, fertility, pediatrics, metabolic, cardiovascular, neurology, and cancer care; and

WHEREAS, Many people benefit from increased genetic sequencing research and genetic counseling, including anyone with a condition linked to a specific gene or anyone who has a family history of an inherited disease; and

WHEREAS, The 5,000 genetic counselors across the country streamline the healthcare industry by ensuring the right tests are being ordered, avoiding costly and unnecessary costs and tests, by helping patients and providers understand complex test results and how to best use this information, by helping consult with potential parents on the intimidating potential of passing on inherited diseases, by sharing information with family members, and by providing recommendations for community support services; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare November 14, 2019 as "Genetic Counselor Awareness Day" in the State of Illinois.

WHEREAS, Over 300,000 patrons visit the Auditorium Theatre each year, representing diverse backgrounds and a wide array of cultural perspectives; and

WHEREAS, Throughout the 2019-2020 season, the Auditorium Theatre is demonstrating its commitment to diversity and inclusion by presenting an eclectic array of exceptional programming so that all people from surrounding communities will have the opportunity to find inspiration, entertainment, and enjoyment through these varied artistic experiences; and

WHEREAS, The Auditorium Theatre was recently awarded the League of Historic American Theatres' Outstanding Historic Theatre Award in recognition of its substantial contributions to arts and culture and its profound historic significance; and

WHEREAS, It is important to celebrate the Auditorium Theatre's unparalleled history and incomparable tradition; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that in recognition of the Auditorium Theatre's initial unveiling, we declare December 9, 2019 "Auditorium Theatre Day" in the State of Illinois, and we acknowledge this historic landmark's commitment to artistic excellence and community inclusion while celebrating the artists, performers, world leaders, authors, musicians, and cultural icons who have graced the auditorium's stage and enthralled tens of millions of patrons over the years; and be it further

"Section 5. The Time Standardization Act is amended by changing Section 1 as follows:

(5 ILCS 440/1) (from Ch. 1, par. 3201)

Sec. 1. Notwithstanding how time is advanced pursuant to the federal Uniform Time Act of 1966, 15 U.S.C. 260a, at At two o'clock ante meridian of the second Sunday in March of 2020 each year, the standard time in this State shall be advanced one hour; and thereafter, daylight saving time shall be the year-round standard time of the entire State , and at two o'clock ante meridian of the first Sunday in November of each year the standard time in this State shall, by the retarding of one hour, be made to coincide with the mean astronomical time of the ninety degrees of longitude West from Greenwich, the standard official time of which is described as United States standard central time, so that between the second Sunday of March at two o'clock ante meridian in each year and the first Sunday in November at two o'clock ante meridian in each year the standard time in this State shall be one hour in advance of the United States standard central time: Provided, however, that nothing in this Act shall be so construed as to be in contravention of any federal law or authorized order of the Interstate Commerce Commission with respect to the time zones of the United States. And in all laws, statutes, orders, judgments, rules and regulations relating to the time of performance of any act of any officer or department of this State, or of any county, township, city or town, municipal corporation, agency or instrumentality of the State, or school district or school authority or relating to the time in which any rights shall accrue or determine, or within which any act shall or shall not be performed by any person subject to the jurisdiction of the State, and in all the public schools and in all institutions of the State, or of any county, township, city or town, municipal corporation, agency or instrumentality of the State or school district or school authority, and in all contracts or choses in action made or to be performed in the State, it shall be understood and intended that the time shall be the time prescribed in this Section.

If the date on which time is to be advanced one hour, the date on which time is to be retarded one hour, or both, as set forth under Section 260a of the federal Uniform Time Act of 1966 (15 U.S.C. 260a), as now or hereafter amended, renumbered, or succeeded, differs from either or both of those dates as set forth under this Section, then the dates set forth under the federal law shall control and shall apply in Illinois, notwithstanding the dates set forth in this Section.

"Section 5. The Department of Transportation Law of the Civil Administrative Code of Illinois is amended by changing Section 2705-210 as follows: (20 ILCS 2705/2705-210) (was 20 ILCS 2705/49.15)

Sec. 2705-210. Traffic control and prevention of accidents. The Department has the power to develop, consolidate, and coordinate effective programs and activities for the advancement of driver education, for the facilitation of the movement of motor vehicle traffic, and for the protection and conservation of life and property on the streets and highways of this State and to advise, recommend, and consult with the several departments, divisions, boards, commissions, and other agencies of this State in regard to those programs and activities. The Department has the power to aid and assist the counties, cities, towns, and other political subdivisions of this State in the control of traffic and the prevention of traffic accidents. That aid and assistance to counties, cities, towns, and other political subdivisions of this State shall include assistance with regard to planning, traffic flow, light synchronizing, preferential lanes for carpools, and carpool parking allocations.

To further the prevention of accidents, the Department shall conduct a traffic study following the occurrence of any accident involving a pedestrian fatality that occurs at an intersection of a State highway. The study shall include, but not be limited to, consideration of alternative geometric design improvements, traffic control devices, and any other improvements that the Department deems necessary. The Department shall make the results of the study available to the public on its website. (Source: P.A. 91-239, eff. 1-1-00.)

Section 99. Effective date. This Act takes effect upon becoming law.".
