SENATE RESOLUTION NO. 967

WHEREAS, Power generation companies have invested billions of dollars in Illinois to make the state the fifth largest generation state in the country; and

WHEREAS, Unlike California and other States in the Union, Illinois is a net exporter of electricity in the Midwest region; and

WHEREAS, The power industry supports more than 285,000 jobs in Illinois; 103,000 of those jobs are direct high paying jobs that run the power plants 24 hours a day; many if not most of the jobs are union jobs that pay twice the national median salary; and

WHEREAS, The electric power industry accounts for five percent of the Illinois economy, with the industry and its workers accounting for at least \$3.7 billion in taxes in every community in the State; these taxes keep property taxes low in the counties that contain power generation assets; and

WHEREAS, The electric power industry runs plants that keep Illinois electric power reliable and effective; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we strongly support the electric industry in Illinois and stand behind the men and women that operate the electric plants every day that keep the lights on for Illinois citizens; and be it further

RESOLVED, We support keeping Illinois an exporter of power in the Midwest, therefore not relying on other state legislatures for our power; and be it further

RESOLVED, That we support public policy for reliable and moderately priced electric power that will keep large electric power plants operating well into the foreseeable future; and be it further

RESOLVED, That suitable copies of this resolution be sent to the Governor and to the Speaker of the House.

Senator Martinez offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 57

WHEREAS, The current national immigration policy provides cruel and unusual punishment to immigrants with criminal convictions; and

WHEREAS, Convicted immigrants, even those found guilty of minor offenses, are being deported after they have paid their debt to society; and

WHEREAS, These individuals are being deprived of their families, their communities, and their country, often based on cases with inadequate evidence and an improper defense; and

WHEREAS, This is apparent in the case of Miguel Perez, who was a legal permanent resident and joined the Army after 9/11; he served two tours in Afghanistan with distinction and left the military with Posttraumatic Stress Disorder (PTSD) and brain injury trauma; and

WHEREAS, Miguel Perez was caught in a drug sting and was convicted without proper representation; he was sentenced to a long term in a state penitentiary and was then taken by Immigration and Customs Enforcement (ICE) for deportation; he was held by ICE for one year pending his appeals and was then deported to Mexico; and

WHEREAS, Miguel Perez was eligible for Veterans Affairs (VA) health care but found there was no VA facility in Mexico; and

WHEREAS, Miguel Perez was only allowed to reenter the United States after he received a full pardon from Governor Pritzker; he has now achieved full U.S. citizenship; and

WHEREAS, The governors of New York and California have issued pardons on an expedited basis in approximately 30 cases in 2017; and

WHEREAS, ICE's aggressive actions can often be offset by pardons, but this requires expedited action to avoid deportation; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we urge Governor Pritzker to immediately establish a commission for expedited pardons associated with immigration-related action.
